# 1. Environment Minister Releases India's National Redd+ Strategy Related Information REDD

- REDD means "Reducing Emissions from Deforestation and forest Degradation".
- First negotiated under the United Nations Framework Convention on Climate Change (UNFCCC) in 2005.
- It is the collaborative programme of the Food and Agriculture Organization (FAO), United Nations Development Programme (UNDP) and United Nations Environment Programme (UNEP).
- Its main objective is to reduce greenhouse gases.

#### REDD+

- REDD+ means "Reducing Emissions from Deforestation and forest Degradation", conservation of forest carbon stocks, sustainable management of forests, and enhancement of forest carbon stocks in developing countries.
- REDD+ aims to achieve climate change mitigation by incentivizing forest conservation.

#### National REDD+ Strategy

- It has been prepared by Indian Council of Forestry Research & Education (ICFRE), Dehradun.
- It will further supplement India's commitment of the 2015 Paris agreement.
- Under it, Green Skill Development programme will be launched.
- The National REDD+ Strategy will soon be communicated to the UNFCCC.

2. HRD Ministry introduces Atal ranking for institutions to promote innovation. Related information

Atal Ranking of Institutions on Innovation Achievements (ARRIA).

- Named after former PM Atal Bihari Vajpayee.
- It will be launched on 15<sup>th</sup> October, on the occasion of the birth anniversary of former President APJ Abdul Kalam.
- To promote a culture of innovation and research in higher education.
- ARIIA will rank educational institutions for innovation output based on all major indicators and parameters used globally.

### 3. INS Sahyadri reaches Australia for Exercise KAKADU 2018

**Related Information** 

- Exercise KAKADU, which started in 1993.
- It is a premier multilateral regional maritime engagement.
- Hosted by the Royal Australian Navy (RAN) and supported by the Royal Australian Air Force (RAAF).
- It is held biennially in Darwin and the Northern Australian Exercise Areas (NAXA).
- KAKADU 2018, the fourteenth edition of the exercise.
- It would see participation from 23 warships, one submarine, 45 aircraft, 250 marines and approximately 52 foreign staff from over 25 different countries.

#### **NOTE-**

 Exercise KAKADU derives its name from Kakadu National Park, which is a protected area in the northern territory of Australia, 171 km southeast of Darwin.

The International Energy Agency (IEA)

• IEA is a Paris-based autonomous intergovernmental organization.



- Established in the framework of the Organisation for Economic Cooperation and Development (OECD) in 1974 in the wake of the 1973 oil crisis.
- India is not a member of IEA.

#### **NOTE-**

- Only the OECD member states can become members of the IEA.
- Except for Chile, Iceland, Israel, and Slovenia, all OECD member states are members of the IEA.
- In 2014, Estonia joined the IEA and became its 29th member.
- Brazil, China, India, Indonesia, Morocco, Singapore and Thailand are the associate members of IEA.
- It publishes the World Energy Outlook.

## 5. Law Commission's report on the wrongful prosecution

#### **Key Highlights of the report:**

- The Commission has recommended the enactment of a specific legal provision for redressal of cases of wrongful prosecution.
- To provide relief to the victims of wrongful prosecution in terms of monetary and non-monetary compensation (such as counselling, mental health services, vocational / employment skills development etc.) within a statutory framework.
- The report enumerates the core principles of the recommended framework- defining 'wrongful prosecution' i.e., cases in which claim for compensation can be filed, designation of a Special Court to decide these claims of compensation, nature of proceedings.
- Timeline for deciding the claim, etc., financial and other factors to be considered while determining the compensation, provisions for interim compensation in certain cases, removal of disqualification on account of wrongful prosecution/conviction etc.

## Related Information Wrongful Prosecution

- The wrongful prosecution is identified as 'miscarriage of justice' that takes place after a person has been wrongfully convicted but is later found to be factually innocent basis a new fact/proof coming to light.
- It would include both the cases where the person spent time in prison as well as where he did not.

#### NOTE-

 The International Covenant on Civil and Political Rights ('ICCPR', ratified by India) also creates an obligation on the State parties to enact a law to compensate the victims of such miscarriage of justice.

## Members of Parliament Local Area Development Scheme (MPLADS)

- Members of Parliament Local Area Development Scheme (MPLADS) is a scheme formulated on 23<sup>rd</sup> December 1993.
- It provides that each member of parliament of India has the choice to suggest to the Head of the District works to the tune of ₹5 crore per year, to be taken up in his/her constituency.
- Initially, this scheme was administered by the Ministry of Rural Development.
- Later, in October 1994, Ministry of Statistics and Programme Implementation (MOSPI) has been looking into its working.
- Elected Members of Rajya Sabha representing the whole of the State as they do, may select works for implementation in one or more district(s) as they may choose.
- Nominated Members of the Lok Sabha and Rajya Sabha may also select works for implementation in one or more districts, anywhere in the country.



 It also allows MPs to spend up to ₹10 lakh in any other constituency in India.

- Swadhar –A Scheme for Women in Difficult Circumstances.
- It was launched by the Department of Women and Child Development.
- In 2015.
- The Scheme envisages providing shelter, food, clothing and health as well as economic and social security for these women
- It targets those women victims of difficult circumstances who are in need of institutional support for rehabilitation so that they could lead their life with dignity.
- Swadhar Greh is a DBT compliant scheme.

# 8. Law panel says uniform civil code not desirable now, reform family laws first. Key Highlights:

- The Law Commission has taken a stand in favour of "equality 'within communities' between men and women" (personal law reform), "rather than 'equality between' communities" (UCC).
- It said that the Uniform Civil Code is "neither necessary nor desirable at this stage.
- It cited Sati, the devadasi, triple talaq and child marriage as examples of 'social evils' under the garb of religious customs.
- The Commission has held that a Parsi woman should be allowed to retain her identity even if she marries outside the community and that their children should be allowed to inherit if they choose Zoroastrianism, and not their father's religion.

- It has recommended for a 'Muslim Code of Inheritance and Succession', applicable to both Sunnis and the Shias, so that succession and inheritance be based on 'proximity to the deceased rather than preference to male agnates heirs'.
- The Commission includes compulsory marriage registration, rectifying the inequality in the age of consent for marriage (18 for girls 21 for boys) as it 'simply contributes to the stereotype that wives must be younger than their husbands.
- Allowing transgender persons to adopt.
- Introduction of a new grounds for 'no-fault' divorce, taking 'best interest of the child' as the basis for matters of custody and defining the rights of persons with disabilities within marriage.

• It was announced in the 4<sup>th</sup> BIMSTEC summit.

#### **Key Points:**

- Strong commitment to combat terrorism
- Prevent the financing of terrorists and terrorist actions from territories under their control.
- Blocking recruitment and crossborder movement of terrorists.
- Countering radicalization.
- Countering misuse of the internet for purposes of terrorism and dismantling terrorist safe havens.
- Underlined the importance of multidimensional connectivity.

### The Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC)

- BIMSTEC is a regional organization.
- The countries lying in the littoral and adjacent areas of the Bay of Bengal are its members.
- Came into being on 6<sup>th</sup> June 1997.



- Through the Bangkok Declaration.
- It constitutes seven Member States:
  - 1. Bangladesh
  - 2. Bhutan
  - 3. India
  - 4. Nepal
  - 5. Sri Lanka
  - 6. Myanmar
  - 7. Thailand

## 2. India and Pakistan have agreed to undertake the Indus Waters Treaty mandated tours.

 Both sides to resolve issues on the various hydroelectric projects, including the Pakal Dul and Lower Kalnai in Jammu and Kashmir.

## Related Information Indus Water Treaty

- India and Pakistan signed the Indus Waters Treaty in 1960.
- After nine years of negotiations, with the World Bank being a signatory.
- Under the provisions of the Indus Water Treaty 1960:
  - (a) Waters of the eastern rivers-Sutlej, Beas and Ravi- had been allocated to India
  - (b) Western rivers- the Indus, Jhelum and Chenab- to Pakistan, except for certain non-consumptive uses for India.

#### The Pakal Dul Dam

- The Pakal Dul Dam is a proposed concrete-face rock-fill dam on the Marusadar River, a tributary of the Chenab River, in Jammu and Kashmir.
- It is 1000 MW hydroelectric power generation project.
- It will divert water to the south into power station on the reservoir of the Dul Hasti Dam, on the Chenab.
- Pakistan, who relies on the Chenab downstream, views the dam as a violation of the Indus Water Treaty, whereas India states it is as per Treaty Provisions.

#### **Lower Kalnai**

- On Lower Kalnai Nalla, a tributary of river Chenab, in Jammu and Kashmir.
- It is 43 MW hydroelectric power generation project.

#### 3. 4<sup>th</sup> International Ayurveda Congress

- International Ayurveda Congress is a joint effort of three organizations:

   (a) The International Maharishi Ayurveda Foundation, from The Netherlands
  - (b) The All India Ayurvedic Congress, New Delhi.
  - (c) The International Academy of Ayurveda, Pune.
- These International Congresses are held regularly, at least once in two years.
- It aims to establish Ayurveda as the most ancient, scientific and holistic health care system, which is capable of leading the world towards an increasingly disease-free society.
- Previous Congress:
  - (a) 2010 -Klagenfurt, Austria.
  - (b) 2015- Roermond, the Netherlands.
  - (c) 2017- London, United Kingdom.
  - (d) 2018- The Netherlands.

## 4. Astronomers capture the clearest image yet of 'monster galaxy' 12 billion light years from Earth.

- The 'monster galaxy' is around 12 billion light years from Earth.
- It gives birth to new stars around 1,000 times faster than our own galaxy, the Milky Way.
- It has been christened 'COSMOS-AzTEC-1'.
- The scientists used the ALMA Observatory in Chile to capture observations the galaxy with a resolution 10 times greater than any previous effort.

#### **NOTE**

- The Milky Way has a single, thick core with spiral arms stretching outwards.
- But COSMOS-AzTEC-1 has three cores – or two smaller cores that exist with their own discs many light years away from the centre one.
- In a normal galaxy, the gravity pushing inwards and pressure pushing outwards are balanced.



 But this one is experiencing a massive gravitational collapse that is probably what's causing its fast-paced star formation.

#### **Related information**

#### The Atacama Large Millimeter/ submillimeter Array (ALMA)Observatory

- ALMA is an astronomical interferometer of radio telescopes in the Atacama Desert of northern Chile.
- The array has been constructed on the Chajnantor plateau at an elevation of 5,000m.
- It consists of 66 radio telescopes.
- ALMA is an international partnership among Europe, the United States, Canada, Japan, South Korea, Taiwan, and Chile.
- It is the most expensive ground-based telescope in operation.
- ALMA is expected to provide insight on star birth during the early universe and detailed imaging of local star and planet formation.

#### 5. Govt comes out with draft rules for epharmacies to regulate online sale of medicines.

#### **Key Highlights:**

- For regulating the online sale of medicines across the country.
- It aims at providing patients access to genuine drugs from authentic online portals.
- It states that no person will distribute or sell, stock, exhibit or offer for sale of drugs through the e-pharmacy portal unless registered.
- Any person who intends to conduct the business of e-pharmacy shall apply for the grant of registration to the Central Licensing Authority through the online portal of the Central Government.
- However, the sale of tranquillisers, psychotropic drugs, narcotics and habit-forming drugs have been prohibited through these portals.

## <u>6. For the first time, Census 2021 to collect data on OBCs</u>

- It comes after implementation of 27% reservation for OBCs on the basis of Mandal Commission's recommendations.
- The data was collected in the 1931 census.
- The decennial exercise will involve 25 lakh trained enumerators and the use of "maps/georeferencing at the time of house listing.

#### NOTE-

 The Census Organization was set up on an ad-hoc basis for each Census till the 1951 Census when the Census Act was enacted in 1948 to provide for the scheme of conducting population census with duties and responsibilities of census officers.

#### 7. China-Maldives Friendship Bridge

- It is the first cross-sea bridge to be built in the Maldives.
- The bridge is an iconic project of the Maldives and China in co-building the 21st Century Maritime Silk Road.
- The 2-km bridge connects capital Male and neighbouring Hulhule island where the Maldives' main international airport is located.
- The bridge has made it possible for locals and tourists to transit between the two islands on land within five minutes.

# 8. Union Home Minister chairs first review meeting of Department of Official Language.

 The Department of Official Language was set up in June 1975 as an independent Department of the Ministry of Home Affairs.

#### **NOTE-**

 The department has developed a computer software called "Kanthasth" for translating the all kinds of official files from English to Hindi and vice versa to make the translation work simpler and quicker.



 An E-learning platform called the "Pravah" also being developed by the department for use in 16 Indian languages including English. Anybody can learn Hindi through his mother tongue with the help of this E-learning platform.

## 9. Justice Ranjan Gogoi to be next Chief Justice of India

- Justice Ranjan Gogoi is set to take over as the new Chief Justice of India (CJI).
- He will replace incumbent CJI Justice Dipak Misra (will retire on 1<sup>st</sup> October 2018).
- Justice Gogoi will be sworn in as CJI (46th) on October 3, 2018, and will hold the post till 17<sup>th</sup> November 2019.

#### Note:

- The Chief Justice of India (CJI) is the head of the judiciary of India and the Supreme Court of India.
- As head of the supreme court, the chief justice is responsible for the allocation of cases and appointment of constitutional benches which deal with important matters of law.
- Article 124 of the Constitution of India provides for the manner of appointing judges to the Supreme Court.

# 1. Cyprus reaffirms its support to India for its NSG membership; its claim for being inducted as the permanent member of UNSC

 India and Cyprus have expressed concern over the threat of terrorism and called for the early adoption of the Comprehensive Convention on International Terrorism at the United Nations.

## Related information Nuclear Suppliers Group (NSG)

 NSG is a multilateral export control regime and a group of nuclear supplier countries.

- It seeks to prevent nuclear proliferation by controlling the export of materials, equipment and technology that can be used to manufacture nuclear weapons.
- The NSG was founded in response to the Indian nuclear test in May 1974 and first met in November 1975.
- It has also been referred to as the London Group, or the London Suppliers Group.
- The NSG Chair for 2018-2019 is Latvia.
- NSG has 48 participating governments.
- Both India and Pakistan are not its member.

## Treaty on the Non-Proliferation of Nuclear Weapons

- Commonly known as the Non-Proliferation Treaty or NPT.
- It is an international treaty.
- The objective is to prevent the spread of nuclear weapons and weapons technology, to promote cooperation in the peaceful uses of nuclear energy, and to further the goal of achieving nuclear disarmament and general and complete disarmament.
- It has three pillars:
  - 1. Non-proliferation.
  - 2. Disarmament.
  - 3. The right to peacefully use nuclear technology.
- It was signed in 1<sup>st</sup> July 1968 and became effective from 5<sup>th</sup> March 1970.
- Located in Moscow, Russia; London, UK; Washington DC, United States.
- It has 190 members.

#### **NOTE-**

- Four UN member states have never accepted the NPT, three of which are thought to possess nuclear weapons: India, Israel, and Pakistan.
- In addition, South Sudan, founded in 2011, has not joined.

#### **United Nations Security Council (UNSC)**

- The United Nations Security Council (UNSC) is one of the six principal organs of the United Nations.
- Charged with the maintenance of international peace and security.
- Founded in 1945.



- The Security Council consists of fifteen members.
- The 5 permanent members are:
  - 1. The Russian Federation
  - 2. The United Kingdom
  - 3. France
  - 4. China
  - 5. The United States
- These permanent members can veto any substantive Security Council resolution, including those on the admission of new member states or candidates for Secretary-General.
- The Security Council also has 10 nonpermanent members, elected on a regional basis to serve two-year terms.
- The body's presidency rotates monthly among its member.

## Comprehensive Convention on International Terrorism

- The Comprehensive Convention on International Terrorism is a proposed treaty which intends to criminalize all of international terrorism and deny terrorists, their financiers and supporters access to funds, arms, and safe havens
- Currently, the negotiations of the Comprehensive Terrorism Convention are deadlocked because of differences over the definition of terrorism.
- India proposed this convention in 1996 and has since demanded consistently, especially in the wake of the 2008 Mumbai attacks.
- India further pressed for the adoption of CCIT following the July 2016 Dhaka attack.

# 2. India along with 23 other nations to participate in tsunami mock drill Related Information IOWaye18

 IOWave18 exercise is being organised by the Intergovernmental Oceanographic Commission (IOC) of UNESCO, which coordinated the setting up of the Indian Ocean Tsunami Warning and Mitigation System (IOTWMS) in the aftermath of December 2004 tsunami.

- The primary objective is to enhance tsunami preparedness at the community level.
- The purpose of the exercise is to increase tsunami preparedness, evaluate response capabilities in each state and improve coordination throughout the region.

## Indian Tsunami Early Warning Centre (ITEWC)

- ITEWC, based out of the Indian National Centre for Ocean Information Services (INCOIS), Hyderabad.
- It is an autonomous institution.
- Under the Union Ministry of Earth Sciences.
- It has been operational since October 2007.

## The Intergovernmental Oceanographic Commission of UNESCO (IOC-UNESCO),

- IOC-UNESCO established in 1960 as a body with functional autonomy within UNESCO.
- It is the only competent organization for marine science within the UN system.
- The purpose of the commission is to promote international cooperation and to coordinate programmes in research, services and capacitybuilding.

- EAS is an initiative of ASEAN and is based on the premise of the centrality of ASEAN.

- It controls the monetary policy of the Indian rupee.
- It commenced its operations on 1<sup>st</sup> April, 1935 in accordance with the Reserve Bank of India Act, 1934.
- The RBI plays an important part in the Development Strategy of the Government of India.
- It is a member bank of the Asian Clearing Union.
- Headquarters in Mumbai,

- The Nutrition Month will also focus on adolescent girls, pregnant women and lactating mothers to eliminate the deficiencies prevailing in the Health sector.
- The decision to celebrate September as the National Nutrition Month every year was taken during the second meeting of National Council on India's Nutrition Challenges under the Poshan Abhiyaan.

## Related Information POSHAN Abhiyaan

- POSHAN Abhiyaan- the National Nutrition Mission was launched by Prime Minister Narendra Modi on 8<sup>th</sup> March, 2018 in Jhunjhunu, Rajasthan.
- With the aim to bring down the stunting of children in the age group of 0-6 years from 38 per cent to 25 per cent by 2022.
- It aims to reduce the level of undernutrition and other related problems on nutrition-related issues.
- It also aims to reduce stunting, undernutrition, anaemia (among young children, women and adolescent girls) and low birth rate.
- It is being supported by World Bank assisted Integrated Child Development Services (ICDS) Systems Strengthening and Nutrition Improvement Project (ISSNIP) for reaching out to all districts in the country by 2022

• The Rapid Trident exercises is held each year since 1996.



• It is designed to test and build Ukraine's interoperability with NATO allies and partners.

- An interim climate intersession is scheduled to be held in Bangkok from September 4-9, 2018 before the Conference of the Parties to the United Nations Framework Convention on Climate Change (COP24) at Katowice in Poland this December.
- In Katowice, Parties have the mandate to finalise and adopt the "rule book" for implementation of the Paris Agreement.

#### Related information United Nations Framework Convention

on Climate Change (UNFCCC)

- The UNFCCC is an international environmental treaty.
- Adopted on 9<sup>th</sup> May 1992 and opened for signature at the Earth Summit in Rio de Janeiro from 3 to 14 June 1992.
- It then entered into force on 21 March 1994.
- The UNFCCC objective is to "stabilize greenhouse gas concentrations in the atmosphere at a level that would prevent dangerous anthropogenic interference with the climate system".
- It is non- binding treaty.
- Headquartered in New York City, New York, U.S.

# 9. Several experimental drugs being tested in Congo to halt Ebola Related Information

#### Ebola

- The disease was first identified in 1976.
- Near the Ebola River from which the disease takes its name.
- The outbreaks occur intermittently in tropical regions of sub-Saharan Africa.
- Ebola virus disease, in humans, is caused by four of five viruses of the genus Ebolavirus:
  - 1. Bundibugyo virus (BDBV)

- 2. Sudan virus (SUDV)
- 3. Taï Forest virus (TAFV)
- 4. Ebola virus (formerly Zaire Ebola virus)
- 5. Reston virus (RESTV)(is not thought to cause disease in humans, but has caused disease in other primates)
- Zaire ebolavirus is the most dangerous of the known EVD-causing viruses and is responsible for the largest number of outbreaks.
- Ebola disease spreads only by direct contact with the blood or other body fluids of a person who has developed symptoms of the disease.

#### NOTE

- Liberia first country to be declared Ebola-free.
- Sierra Leone was declared free of Ebola transmission and Guinea in 2015.

#### 3. New Ganga clean-up law Key Highlights

- The Bill calls for a National Ganga Council and a National Ganga Rejuvenation Authority to enforce the law and protect the river which flows over 2500 km.
- An armed Ganga Protection Corps (GPC); treating a slew of actions from obstructing the flow to commercial fishing — as cognizable offences that may attract a prison term of up to three years and a fine of up to Rs 5 lakh.
- Cognizable offences marked in the draft Bill include:

- 1. Construction activities causing obstruction in the river- 2-year imprisonment or fine up to Rs 50 lakh or both.
- 2. Withdrawal of groundwater for industrial or commercial consumption from the land fronting the river and its tributaries.
- 3. Commercial fishing or aquaculture in the river and its tributaries- 2 years prison term or a fine of Rs 2 lakh or both.
- 4. Discharging untreated or treated sewage into the river- 5-year prison term or a fine of Rs 50,000 per day or both.
- Ganga Protection Corps, an armed force "constituted and maintained" by the Central government.
- GPC personnel will have powers to arrest those who pollute the river.
- No person or municipal authority will establish or take any steps to set up any industrial or residential or commercial premises or structure which may result in the discharge of any sewage or trade effluent into the Ganga.

#### **NOTE**

 In 2016, a committee was constituted under a retired judge of the Allahabad High Court Justice Girdhar Malviya who had submitted a draft Bill last year named The National River Ganga (Rejuvenation, Protection and Management) Bill, 2017.

- In terms of recommendations of the Damodaran Committee on banking ombudsman scheme, the Internal Ombudsman (IO) system was introduced.

## Related Information Banking Ombudsman

- Banking Ombudsman is a quasijudicial authority.
- Under India's Banking Ombudsman Scheme 2006.
- The authority was created for resolving complaints of customers of banks relating to certain services rendered by the banks.
- It does not charge any fee in terms of filing complaints.

#### **NOTE**

- This year, the RBI had extended the scheme to Non-Banking Finance Companies (NBFC) taking deposit.
- Appellate Authority, is headed by a Deputy Governor of the RBI, where people can take their complaints against the Banking Ombudsman.



#### Who is a Banking Ombudsman?

- The Banking Ombudsman is a senior official appointed by the Reserve Bank of India to redress customer complaints against deficiency in certain banking services covered under the grounds of complaint.
- As on date, twenty Banking Ombudsmen have been appointed

#### Internal Ombudsman (IO)

- IO is for strengthening the grievance redressal mechanism in banks.
- It helps to reduce the complaints being escalated to Banking Ombudsman.
- An IO can be removed only with prior approval of RBI.
- This scheme advices banks to give IO, a fixed term of 3 to 5 years, which cannot be renewed.

# 1. NASA-funded Rocket to View Sun with X-Ray Vision Related information

FOXSI (Focusing Optics X-ray Solar Imager) mission

- FOXSI is a sounding rocket mission.
- FOXSI is a collaboration between NASA and the Japan Aerospace Exploration Agency,
- The sounding rockets make brief 15minute journeys above Earth's atmosphere for a peek at space before falling back to the ground.
- Smaller, cheaper and faster to develop than large-scale satellite missions.
- FOXSI will travel 190 miles up, above the shield of Earth's atmosphere, to stare directly at the Sun and search for nanoflares using its X-ray vision.
- FOXSI is the first instrument built specially to image high-energy X-rays from the Sun by directly focusing them.
- FOXSI is so far the only instrument to optimize especially for the Sun.

#### **NOTE-**

- This will be FOXSI's third flight.
- Its first flight was in 2012, during which it successfully viewed a small solar flare in progress.
- Its second flight was in 2014 when it detected the best evidence at the time of X-ray emission from nanoflares.
- The third mission follows up on this discovery, but this time it includes a new telescope designed for imaging lower-energy, so-called soft X-rays as well.

## 1. Pluto should be reclassified as a planet

- In 2006, the International Astronomical Union, a global group of astronomy experts, established a definition of a planet.
- The definition agreed upon requires that an object meet three conditions to qualify as a planet:
  - 1. It must orbit the sun.
  - 2. It must be massive enough that its gravity pulls it more or less into a spherical shape.
  - 3. It must clear the neighborhood around its orbit.

## Why was Pluto not classified as a planet?

 Since Neptune's gravity influences its neighboring planet Pluto, and Pluto shares its orbit with frozen gases and objects in the Kuiper belt, that meant Pluto was out of planet status.

#### **New Expert Study**

 It argued that the third piece of that definition does not match historical usage by scientists and should be revoked.



- Moons such as Saturn's Titan and Jupiter's Europa have been routinely called planets by planetary scientists since the time of Galileo.
- It recommends classifying a planet based on if it is large enough that its gravity allows it to become spherical in shape.

## 4. INMAS develops India's first indigenous anti-nuclear medical kit

- Scientists at a central research institute claim to have developed India's first indigenous medical kit that may ensure protection from serious injuries and faster healing of wounds resulting from nuclear warfare or radioactive leakage.
- Developed in India for the first time, it's a potent alternative to similar kits that were till now being procured from strategically advanced nations such as the US & Russia at much higher prices.
- The contents include an advanced form of Prussian blue tablets, highly effective in incorporating Radio-Cesium (Cs-137) and Radio Thallium, among the most feared radioisotopes in nuclear bombs that destroy human body cells.
- The tablet provides 100 percent absorption from the gut and other portals of entry to the human body.
- The kit has been developed for the armed, paramilitary and police forces only as they are the first ones likely to get exposed to radiation -- be it during nuclear, chemical and biomedical (NCB) warfare or a rescue operation after a nuclear accident.
- The kit also has an Ethylenediaminetetraacetic acid (EDTA) injection that traps uranium in the guts and blood of victims during a nuclear accident or warfare.
- The kit also has Ca-EDTA Respiratory Fluid, which is the inhalation formula for chelation, or grabbing, of heavy metals and radioactive elements deposited in lungs through inhalation at nuclear accident sites.

- The Chiller Star Labelling Program has been formulated by Bureau of Energy Efficiency (BEE).
- The program envisages providing star rating in terms of its energy performance.
- Initially, the program is launched on the voluntary basis and will be valid upto 31st December 2020.
- Chillers are used extensively for space conditioning of buildings and for industrial process cooling applications.
- Chillers, being energy intensive system, contribute more than 40 percent of the total energy consumption in commercial buildings.
- Then 500 million units of electricity would be saved in 2019 along with Green House Gases (GHG) reduction of 0.5 million-ton equivalent of CO2. The HIV Estimations 2017 is the 14th round in the series of HIV Estimations under National AIDS Control Programme (NACP).

#### **Key Highlights:**

- Overall, the impact of the programme has been significant with more than 80% decline in estimated new infection from the peak of the epidemic in 1995.
- As per UNAIDS 2018 report, the global average for the decline in new infections and AIDS-related deaths from peak has been 47% and 51% respectively.
- As per the report, in 2017, India had around 21.40 lakh people living with HIV (PLHIV) with the adult prevalence of 0.22%.
- Around 87.58 thousand new HIV infections and 69.11 thousand AIDS-related deaths happened in 2017 while around 22,675 mothers needed Antiretroviral Therapy (ART) for prevention of mother to child transmission of HIV.

### 4. Government moves to stabilize the rupee

#### Key measures to be taken into consideration:

- FPIs' investment in a single corporate entity cannot exceed 20% of its corporate bond portfolio will be reviewed.
- The condition that FPIs cannot invest more than 50% of an issue of corporate bonds.
- The government has exempted all masala bonds issues until March 31, 2019, from withholding tax.
- It has also said it will remove restrictions on Indian banks on market-making for such bonds and on underwriting them.

- Both the satellites together weighed about 889 kg, and the commercial launch was carried out under an arrangement Surrey Satellite Technologies Limited (SSTL) and ISRO's commercial arm Antrix Corporation Limited.
- NovaSAR is an S-Band Synthetic Aperture Radar (SAR) satellite intended for forest mapping, land use and ice cover monitoring and disaster monitoring while S-14 is a highresolution Optical Earth Observation Satellite, used for surveying resources, environment monitoring, urban management and for the disaster monitoring.

- The PSLV-C42 was only the third launch of PSLV after the rare failure it encountered in August last year due to problems in the heat shield.

### 2. <u>Child death below 5 declined faster in</u> India: UN.

- The reports have been released by the United Nations Inter-agency Group for Child Mortality Estimation (UNIGME).
- UNIGME is a combination of Unicef, the World Health Organization (WHO), the UN Population Division and the World Bank Group.
- It says that the death of children below the age of five continues to steadily reduce in India, declining from nearly 22 percent in 2012 to 18 percent in 2017, which is now for the first time below the one million marks.

#### **Key Highlights:**

- The under-five mortality rate of India at 39 per 1000 now equals that of the world, highlighting the much faster decline by India in the last five years as compared to the global decline.
- According to the report, the gender gap in child survival has reduced almost four-fold in the last five years, with under-five mortality of girl child now being 2.5 percent higher, compared to nearly 10 percent in 2012.
- An estimated 6.3 million children under 15 years of age died in 2017 and the vast majority of these deaths, 5.4 million occurred in the first five years of life.
- Globally in 2017, half of all deaths under five years of age took place in sub-Saharan Africa and another 30 percent in Southern Asia.
- In sub-Saharan Africa, one in 13 children died before their fifth birthday.



- In high-income countries, that number was one in 185.
- In 2017, 2.5 million newborns died in their first month. A baby born in sub-Saharan Africa or in Southern Asia was nine times more likely to die in the first month than a baby born in a high-income country.
- The most children under five die due to preventable or treatable causes such as complications during birth, pneumonia, diarrhea, neonatal sepsis and malaria.
- Under-five mortality rates among children in rural areas are, on average, 50 percent higher than among children in urban areas.

### 6. <u>One manual scavenging death every</u> <u>five days: Official data</u>

- One person has died every five days, on an average, while cleaning sewers and septic tanks across the country, according to numbers collated by the National Commission for Safai Karamcharis (NCSK).
- The data, which is based mostly on newspaper reports and numbers supplied by a few state governments.



 It is the first such official attempt to account for the deaths of sewer and septic tank cleaners.

#### **Key Highlights:**

- According to NCSK, 123 people employed in hazardous forms of manual scavenging lost their lives while at work since January 2017.
- The last one week alone has seen a total of six deaths in the National Capital Region.
- There are no numbers available on those employed in sewer and septic tank cleaning.
- All previous and ongoing exercises at compiling data have been restricted to accounting for those removing human excreta from dry latrines, open drains, and single pit toilets in villages.
- In the reported instances are high in:
  - Haryana
  - Uttar Pradesh
  - Delhi
  - Gujarat
- The NCSK data shows Maharashtra as having had just two deaths in this period.
- As per NCSK data, the Rs 10 lakh compensation that is mandated under the law in case of manual scavenging deaths, has been paid in only 70 of the 123 cases.

- Union Cabinet approved the ordinance to make triple talaq a punishable offense.
- The Bill makes instant triple talaq, delivered in any form, a criminal offense.
- It proposes a three-year jail term for a Muslim man who divorces his wife by uttering the word 'talaq' thrice.
- The Bill to make 'talaq-e-biddat' void and illegal has provisions for imprisonment and fine for anyone invoking it.
- It also deals with subsistence allowance to a Muslim woman and her children by the estranged husband along with a provision for custodial rights of minor children.

### 2. <u>National Registry of Sexual Offenders</u> to be rolled out

- The database will be maintained by the National Crime Records Bureau (NCRB).
- The database will include names, photographs, Aadhaar numbers, residential address, DNA samples, fingerprints and Personal Account Numbers (PANs) of convicted sexual offenders.
- The information will only be available to law enforcement agencies for investigation and employee verification.
- The compilation will be done on the basis of information from prisons across the country.
- Offenders will be classified based on their criminal history to determine if "they pose a serious danger to the community"
- The database will include information on arrested and charge-sheeted offenders. However, limited access will be granted to officers after clearance.
- Juvenile offenders are likely to be included in the database at a later stage.



- According to the report, the registry will maintain data:
  - For 15 years of those cases classified as posing the low danger.
  - Moderate danger will be stored for 25 years.
  - For habitual offenders, violent criminals, convicted gang rapists and in case of custodial rapes, the data will be stored permanently.

- This will make India the ninth country in the world to set up and maintain a database of sexual offenders.
- Australia, Canada, Ireland, New Zealand, South Africa, Trinidad and Tobago, and the United Kingdom are the other countries where the database can only be accessed by law enforcement agencies.
- In the United States, the data can be accessed by the public.

### 8. States set to miss 20% debt-to-GDP ratio target by FY23: Report

 Though the Centre may manage to achieve the debt-to-GDP ratio target of 40 percent by FY23, the states achieving the 20 percent target looks difficult as most of them have not budgeted so far.

### According to the report by India Ratings' chief economist, DK Pant:

- The states' aggregate debt-to-GDP ratio for FY19 has been budgeted at 24.3 percent.
- According to their FY19 budgets, only 10 of the 20 states will have the debtto-GSDP ratio of under 25 percent in FY19.
- Eight states namely Himachal, Jammu & Kashmir, Kerala, Manipur, Meghalaya, Nagaland, Punjab, and Rajasthan had debt-to-GSDP ratios in excess of 30 percent in FY18.
- These periods were characterized by an average minimum nominal GDP growth of about 14 percent per annum and average aggregate revenue receipt-to-GDP ratio of around 20 percent.
- Though the aggregate revenue receipt-to-GDP ratio has been budgeted at 22 percent for FY19, achieving a nominal GDP growth of about 14 percent looks difficult.



#### NOTE

 The NK Singh committee, which is reviewing the Fiscal Responsibility and Budget Management Act of 2003, has suggested that the fiscal policy try to reduce the debt-to-GDP ratio to 60 percent by FY23, with the Centre's at 40 percent and the states' combined at 20 percent, instead of improving the revenue to fiscal deficit ratio.

- This will not only aid the victims/complainants but also help the civil society organizations and responsible citizens to anonymously report complaints pertaining to child pornography, child sexual abuse material or sexually explicit material such as rape and gang rape.
- Complainants can also upload the objectionable content and URL to assist in the investigation by the State Police.

### 7. <u>ILO: Strong wage policies are key to promote inclusive growth in India.</u>

 India's economy in the past two decades has seen an annual average GDP rate of 7% – low pay and inequality persist according to the India Wage Report: Wage policies for decent work and inclusive growth, published by the International Labour Organization.

#### **Key Highlights:**

 Real average daily wages for legislators, senior officials and managers nearly doubled between

- 1993–94 and 2011–12, the fastest rate of growth across occupational categories.
- The report highlights that salaries in urban India rose steadily during the period of high economic growth (1993–94 to 2004–05) and this was especially so for those working in the professional and administrative categories.
- Also, women workers have a lower probability of getting social security benefits than their male counterparts as most of them are concentrated in low-skilled occupations.
- In low-skilled jobs, women receive only 69% of men's average daily wages
- Daily wages in urban areas (₹384) also remain more than twice as high as those in rural areas (₹175)
- The average wage of casual workers, who make up 62% of the earning population, was only ₹143 a day.

### 1. <u>UNDP report lauds India's strides in</u> reducing poverty in the past decade

According to MPI 2018 released by the United Nations Development Programme (UNDP) and the Oxford Poverty and Human Development Initiative, there are 271 million fewer poor people in India in this period.

### The Multidimensional Poverty Index (MPI) 2018 says:

- Despite the massive gains made in reducing multidimensional poverty, 364 million Indians continue to experience acute deprivations in health, nutrition, schooling, and sanitation.
- Just over one in four multidimensionally poor people in India are under ten years of age.
- Traditionally disadvantaged groups, in terms of castes, religions etc, continue to be the poorest though they have experienced the biggest decadal reduction in MPI.
- About 196 million MPI poor people in India, accounting for more than half of all multidimensionally poor in India, live in the four states of Bihar, Jharkhand, Uttar Pradesh, and Madhya Pradesh.
- While Delhi, Kerala, and Goa have the lowest incidence of multidimensional poverty.

### Global Multidimensional Poverty Index (MPI)

- The Global Multidimensional Poverty Index (MPI) was developed in 2010 by the Oxford Poverty & Human Development Initiative (OPHI) and the United Nations Development Programme.
- It uses different factors to determine poverty beyond income-based lists.

- It replaced the previous Human Poverty Index.
- The global Multidimensional Poverty Index (MPI) is an international measure of acute poverty covering over 100 developing countries.

### The following ten indicators are used to calculate the MPI:

#### Education (each indicator is weighted equally at 1/6)

- Years of schooling: deprived if no household member has completed six years of schooling.
- Child school attendance: deprived if any school-aged child is not attending school up to class 8.

#### Health (each indicator is weighted equally at 1/6)

- Child mortality: deprived if any child has died in the family in the past 5 years.
- Nutrition: deprived if any adult or child, for whom there is nutritional information, is stunted.

#### Standard of Living (each indicator is weighted equally at 1/18)

- Electricity: deprived if the household has no electricity.
- Sanitation: deprived if the household's sanitation facility is not improved, or it is improved but shared with other households.
- Drinking water: deprived if the household does not have access to safe drinking water (according to MDG guidelines) or safe drinking water is more than a 30-minute walk from home roundtrip.
- Floor: deprived if the household has a dirt, sand or dung floor.
- Cooking fuel: deprived if the household cooks with dung, wood or charcoal.
- Assets ownership: deprived if the household does not own more than one of-



 Radio, TV, telephone, bike, motorbike or refrigerator and does not own a car or truck.

- Predator and Reaper armed drones were used against Taliban targets in the Afghanistan-Pakistan region.
- They are controlled through satellites and flown by ground-based "pilots and weapon operators" at the Creech Air Force Base in Nevada (US) over 7,500 miles away.

## 3. India third worst hit in world by terror, after Iraq and Afghanistan: US data

- According to the data released by US
  Department of state, for the second
  year in a row, India is the third largest
  victim of terror attacks across the
  world after Iraq and Afghanistan.
- While CPI-Maoists, which carried out 53% of the total attacks in India, is the fourth deadliest terror group after Islamic State, Taliban, and Al-Shabaab.

#### According to the national consortium for the study of terrorism and responses to terrorism, contracted by the US Department of state:

 Jammu and Kashmir witnessed a 24% increase in terror attacks in 2017 and an 89% increase in the number of people killed in those attacks.

- Out of a total 860 terror attacks across India in 2017, 25% were reported from J&K alone.
- Terming Maoists as the fourth deadliest terror group in the world, the US study has stated that it was responsible for 53% of attacks in India in 2017.
- The frequency of terrorist violence by Maoist extremists in India declined between 2016 and 2017 with respect to the number of attacks (from 338 in 2016 to 295 in 2017); however, the number of people killed increased 16%, and the number of people injured increased 50%,
- While Maoists were involved in 295 total attacks in India, only global outfits ahead of them are Al-Shabaab with 353 attacks, Taliban with 703 attacks and Islamic State with 857 attacks.

- India and Bangladesh share a 4,095km border, of which 1,116 km is along rivers.
- The proposed 900-km waterway would be used to transport freight from the northern and eastern states to the northeast.
- It would start near Haldia in West Bengal, go to the Sundarbans, merge into the Padma river in Bangladesh and then join up with the Brahmaputra in Assam.

- 4. Government mulls ordinance to fast-track settlement of commercial disputes
- Seeking to improve India's ranking on the ease of doing business index, the government is mulling an ordinance which provides for time-bound settlement of commercial disputes and makes arbitrators accountable.

#### **Key Features:**

- The draft law provides for a timebound settlement of disputes as well as accountability of the arbitrator.
- The amendments to the Arbitration Act will facilitate achieving the goal of improving institutional arbitration by establishing an independent body to lay down standards, make arbitration process more friendly, cost-effective and ensure timely disposal of arbitration cases.
- It provides for setting up of an independent body - Arbitration Council of India (ACI), which will frame arbitral institution and accredit arbitrators by laying down norms.
- The ACI will frame proper rules as to how institutions would be graded, norms to be followed, monitoring of quality and performance, and encourage training of arbitrators.
- The bill, which amends the 1996 Act, is part of the government's efforts to encourage institutional arbitration for the settlement of disputes and make India a center of robust Alternative Dispute Resolution Mechanism.

- In a first, scientists have successfully grown oesophageal organoids -miniature, functional versions of the human food pipe -- using stem cells, paving the way for new ways to study and test drugs against gut disorders.
- The tissue was grown entirely from pluripotent stem cells (PSCs), which can form any tissue type in the body.

### 10. NASA balloon mission may help improve weather forecasting

- The images of a thin group of seasonal electric blue clouds on the cusp of our atmosphere captured by a new NASA balloon mission may lead to improved weather forecasting.
- Data from these clouds, known as noctilucent clouds or polar mesospheric clouds (PMCs), may help scientists better understand turbulence in the atmosphere, as well as in oceans, lakes and other planetary atmospheres.
- The NASA long-duration balloon mission observed these clouds over the course of five days at their home in the mesosphere.

#### **Related Information**

- NASA's PMC Turbo mission launched a giant balloon on July 8 to study PMCs at a height of 50 miles above the surface.
- For five days, the balloon floated through the stratosphere from its launch at Esrange, Sweden, across the Arctic to Western Nunavut, Canada.
- During its flight, cameras on board the balloon captured high-resolution images.

#### **Noctilucent clouds**

Noctilucent clouds coalesce as ice crystals on tiny meteor remnants in the upper atmosphere. These clouds are affected by what is known as atmospheric gravity waves — caused by the convecting and uplifting of air masses, such as when the air is pushed up by mountain ranges.

 Andhra Pradesh, Odisha, and Madhya Pradesh have been awarded the three best performing states under AMRUT (Atal Mission for Rejuvenation and Urban Transformation) at the National Dissemination Workshop on Ease of Living Index, 2018, held in New Delhi.

#### **Related Information**

#### **Ease of Living index**

- Ease of Living Index is a transformative initiative to help the cities assess their liveability vis-à-vis national and global benchmarks.
- By the Ministry of Housing and Urban Affairs (MoHUA).
- The Ease of Living Index seeks to assist cities in undertaking a 360degree assessment of their strengths, weaknesses, opportunities and threats.
- Ease of Living framework comprised four pillars namely Institutional, Social, Economic and Physical which are further broken down into 78 indicators across 15 categories.
- All cities were evaluated out of 100. The 'physical' pillar (infrastructure) was given the highest weightage of 45, while institutional (governance) and social were weighted 25 each. the economy was weighted 5.

#### **Background**

- It was decided in June 2017 to rank 116 cities (all smart cities and million plus cities) based on the liveability parameters.
- The implementation of the assessment commenced formally on 19 January 2018.
- The MoHUA released the first ever 'Ease of Living Index' covering 111 Indian cities on 13 August, 2018.

## 2. Supreme Court asks Parliament to frame laws barring candidates accused of crimes from contesting elections Key ruling:

- Political parties have to display the criminal record of candidates who contest on their ticket on their official websites.
- Parties should also issue a declaration on the criminal antecedents of their candidates in a widely circulated publication.
- To facilitate this transparency by political parties, candidates should first give complete information about their criminal past or pending cases to political parties on whose ticket they intend to contest elections.



- This is to ensure that the ordinary voter can have an "informed choice" about who he has to vote for in a country "tired of money and muscle power,".
- The CJI had pointed out that Parliament was obliged under Article 102 (1) (e) to make a law.

#### Article 102(1)(e)

- A person shall be disqualified for being chosen as, and for being, a member of either House of Parliament
- If he is so disqualified by or under any law made by Parliament Explanation.

For the purposes of this clause, a person shall not be deemed to hold an office of profit under the Government of India or the Government of any State by reason only that he is a Minister either for the Union or for such State.

### 3. <u>Lawyers elected as lawmakers can</u> <u>practice in courts: SC</u>

- The Supreme Court held that there is no bar on MPs and MLAs doubling up as lawyers.
- MPs and MLAs do not come under the definition of full-time paid employees of the state.
- The apex court upheld the earlier decision of the Bar Council of India, which had also declined to issue such a ban on legislators practicing as lawyers.

- The Bar Council of India is a statutory body.
- To regulate the legal practice and legal education in India.
- Its members are elected from amongst the lawyers in India and as such represents the Indian bar.
- It prescribes standards of professional conduct, etiquettes and exercises disciplinary jurisdiction over the bar.
- It also sets standards for legal education and grants recognition to Universities whose degree in law will serve as a qualification for students to

- enroll themselves as advocates upon graduation.
- Formed in 1961.
- The Bar Council of India consists of members elected from each state bar council, and the Attorney General of India and the Solicitor General of India who are ex officio members.
- The members from the state bar councils are elected for a period of five years.

#### Perform Achieve Trade (PAT) scheme

- The Perform Achieve Trade (PAT) is an innovative, market-based trading scheme announced by the Indian Government in 2008.
- It is under the National Mission on Enhanced Energy Efficiency (NMEEE) in the National Action Plan on Climate Change (NAPCC).
- It aims to improve energy efficiency in industries by trading in energy efficiency certificates in energyintensive sectors.
- The scheme is being designed and implemented by the Bureau of Energy Efficiency (BEE), under the Ministry of Power of India.



- The PAT Scheme is being implemented in three phases- the first phase runs from 2012-2015 covering 478 facilities from eight energyintensive sectors, namely aluminum, cement, chor-alkali, fertilizer, iron and steel, pulp and paper, textiles and thermal power plants.
- The PAT scheme establishes plantspecific targets rather than a sectoral target.

### National Mission for Enhanced Energy Efficiency (NMEEE)

- National Mission for Enhanced Energy Efficiency (NMEEE) is one of the eight missions under the National Action Plan for Climate Change.
- It was taken by the Indian government to promote the market for energy efficiency by fostering innovative policies and effective market instruments.
- Its roots lie in the overall objective of The Energy Conservation Act of 2001.
- The mission document, which was approved in 2010.
- NMEEE includes four specific energy efficiency initiatives under its umbrella.
- Perform Achieve and Trade (PAT): Assigning energy reduction targets to large energy-intensive industries and distributing Energy Saving Certificates (ESCerts) on the achievement of the targets. These ESCerts can then be traded.
- Market Transformation for Energy Efficiency (MTEE): Promoting the adoption of energy efficient equipment and appliances through innovative business models.
- Energy Efficiency Financing Platform (EEFP): Increasing the confidence of financial institutions and investors to support energy efficiency initiatives.
- Framework for Energy Efficiency Economic Development (FEEED): Promoting energy efficiency initiatives by hedging against investment risks.

#### 9. <u>India falls below Myanmar, Nepal,</u> Pakistan in air safety audit

- India's air safety oversight score is lower than that of Myanmar, Bangladesh, Maldives, Pakistan, Sri Lanka, Nepal and even North Korea in the Asia-Pacific region.
- The only countries that rank below India are small and little known such as Papua New Guinea, Timor-Leste, Vanuatu and Samoa.
- In the aviation-safety audit conducted late last year by the United Nations' International Civil Aviation Organisation (ICAO), India has slipped below its previous ranking of 66% to 57%.
- India is one of the 15 countries that are below the minimum target rates.

#### Related information International Civil Aviation Organisation (ICAO)

- The International Civil Aviation is a specialized agency of the United Nations.
- It codifies the principles and techniques of international air navigation and fosters the planning and development of international air transport to ensure safe and orderly growth.
- Its headquarters is located in Montreal, Quebec, Canada.
- Formed on 4<sup>th</sup> April, 1947.
- ICAO defines the protocols for air accident investigation followed by transport safety authorities in countries signatory to the Chicago Convention on International Civil Aviation.

- India has become the first and only SAARC country to have a quit-line number on tobacco.
- The Union Health Ministry has already made 85% pictorial health warning mandatory on both sides of packets containing cigarettes, bidis, and chewing tobacco.



- The quit-line number will be printed on all tobacco products manufactured after September 1, 2018.
- For smoking and smokeless forms of tobacco products, the words 'Tobacco causes cancer' and 'Tobacco causes painful death' shall appear in white font on a red background and the words 'Quit today call — 1800-11-2356' shall appear in white font on a black background,

#### **NOTE**

- India is the fourth country in Asia after Thailand, Malaysia, and Singapore to have this government helpline for those looking at quitting tobacco.
- At least 46 countries have quit-line numbers as part of health warning labels on tobacco product packaging.
- The current pictorial warnings on both sides of packages of cigarettes, bidis and all forms of chewing tobacco products in India came into effect from April 2016, following the direction of the Rajasthan High Court and subsequently the Supreme Court.
- They have been in effect for almost two years.
- India's current international ranking for package warnings is number three in the world.

- Financial Inclusive Index would be released by the end of this year by the Department of Financial Services (DFS), Ministry of Finance.

## 10. The Supreme Court upheld the Aadhaar scheme as constitutionally valid

#### Highlights of the court verdict:

- The Supreme Court upheld the validity of Aadhaar saying sufficient security measures are taken to protect data and it is difficult to launch surveillance on citizens on the basis of Aadhaar
- A five-judge bench led by CJI Dipak Misra asked the government to provide more security measures as well as reduce the period of storage of data.
- The SC asked the Centre to bring a robust law for data protection as soon as possible.
- The SC said Aadhaar cannot be made mandatory for openings of a bank account and for getting mobile connections.
- The SC said that Aadhaar must not be made compulsory for school admission and CBSE, NEET, UGC cannot make Aadhaar mandatory.
- Private companies can't ask for Aadhaar.
- The apex court struck down the provision in Aadhaar law allowing sharing of data on the ground of national security.
- It added that Aadhaar is to empower the marginalized sections of the society, and it gives them an identity.

## 1. Adultery no longer a criminal offence as SC strikes down Section 497 of IPC

- The Apex court said that Adultery can be a civil wrong and a ground for divorce but it cannot be a criminal offence.
- SC said Section 497 offends sexual freedom of women.



#### NOTE

 Section 497 of the IPC, mandates that "Whoever has sexual intercourse with a person who is and whom he knows or has reason to believe to be the wife of another man, without the consent or connivance of that man, such sexual intercourse not amounting the offence of rape, is guilty of the offence of adultery and shall be punished."

## 2. Supreme Court refuses to refer to 7-judge bench its 2006 verdict on SC/ST job promotion.

 The Supreme Court paved the way for grant of quota for promotions in the government jobs to SCs and STs, holding that the states were not required to "collect quantifiable data" reflecting the backwardness among these communities.

#### Key ruling:

- The apex court clarified that there was no need to revisit its 12-year-old verdict in the M Nagaraj case.
- The bench said the conclusion arrived at in the Nagaraj case that the states have to collect quantifiable data showing backwardness of SCs and STs was "contrary" to the nine-judge bench judgment in the Indra Sawhney verdict of 1992, popularly known as Mandal Commission case.
- It said the whole object of the reservation was to see that backward classes of citizens move forward so that they may "march hand in hand with other citizens of India on an equal basis".
- This will not be possible if only the creamy layer within that class, bag all the coveted jobs in the public sector and perpetuate themselves, leaving the rest of the class as backward as they always were.
- It is clear that when a court applies the creamy layer principle to Scheduled Castes and Scheduled Tribes, it does not in any manner tinker with the Presidential List under Articles 341 or 342 (dealing with SC and ST) of the Constitution of India.

#### **NOTE**

 M Nagaraj case said that the states were bound to provide quantifiable data on the backwardness of SC/ST, the facts about their inadequate representation in government jobs and the overall administrative efficiency, before providing them quota in promotions.

The new telecom policy has been formulated, in place of the existing National Telecom Policy-2012 and aims to facilitate India's effective participation in the global digital economy.

- To allow the change in the existing composition of the Board of GSTN, the government inducted three directors from the Centre and the States and three other independent directors will be nominated by the Board of Directors.



 Besides, there are one Chairman and the CEO. Thus, the total number of Directors is 11.

practice and Kerala law denies rights to women on the ground of physiological reasons.

- In what is certainly the first such experiment in the country, and perhaps the world, the eminent linguist Ganesh Devy plans to set up a Global Language Park (bhasha van in Hindi) in Pune.
- It will be located on a one-acre plot on the premises of the Savitribai Phule Pune University (SPPU).
- Conceptualised as part of the 84th PEN (Poets, Essayists, Novelists) International Congress that is underway in the city, the park will have about 80 'language'.
- The idea is to physically represent 6,000 of the world's spoken tongues in one space.
- Each tree represents the languages and dialects derived from the family or parent tree.
- Set to open in January 2019, the park will have a tree-lined walkway.
- Each plant will be equipped with a 'bespoke audio tour' to aid visitors.
- Audio samples of songs, poems, folktales, sayings, and jokes will be drawn from different world languages.

### United Nations Sustainable Development Framework (UNSDF)

- The UNSDF was framed following a highly participative process, in consultation with government entities, civil society representatives, academia, and the private sector.
- The UNSDF outlines the development cooperation strategy between the Government of India and the United Nations Country Team in India.
- It supports the achievement of India's key national development priorities and the Sustainable Development Goals (SDGs).



 The focus areas include poverty and urbanization; health, water, and sanitation; education; nutrition and food security; climate change, clean energy, and disaster resilience; skilling, entrepreneurship, and job creation; and gender equality and youth development.

### 3. Apex Court declines SIT probe in Bhima Koregaon case

 The Supreme Court refused to interfere with the arrest of five rights activists by the Maharashtra Police in connection with the Koregaon-Bhima violence case and also declined to appoint a SIT for a probe into their arrest.

#### **Key ruling:**

- The CJI said arrests were not because of dissent of activists but there was prima facie material to show their link with the banned CPI (Maoists) organization.
- The apex court said that the accused persons cannot choose which investigating agency should probe the case.
- It also said this it was not a case of arrest merely because of a difference in political views.
- The majority verdict said the house arrest of the accused shall remain in force for four weeks to enable them to seek appropriate legal remedy at an appropriate legal forum.

#### 4. Centre to hike grant for SDRF

- The Centre has enhanced its contribution in the State Disaster Response Fund (SDRF) from 75% to 90% with effect from April 1.
- Kerala, which has recently faced the worst floods, will be a major beneficiary of the Centre's decision. Henceforth all States will be required to contribute 10% to the SDRF.

## Related information National Disaster Response Force (NDRF)

- The National Disaster Response Force (NDRF) is a specialized force constituted "for the purpose of specialist response to a threatening disaster situation or disaster" under the Disaster Management Act, 2005.
- Formed in 2006.
- It is the "Apex Body for Disaster Management" in India is the National Disaster Management Authority(NDMA).
- The Chairman of the NDMA is the Prime Minister.
- The responsibility for disaster management in India's federal system is that of the State Government.
- The 'nodal Ministry' in the central government for management of natural disasters is the Ministry of Home Affairs (MHA).

#### **State Disaster Response Force (SDRF)**

- The SDRF has been constituted in each State in which the Centre, so far, had been contributing:
  - 75% for the general category states.
  - 90% for special category States of hilly regions every year.
- The SDRF is a resource available to the States to meet the expenses of relief operations of immediate nature, for a range of specified disasters.
- Based on the recommendations of successive Finance Commission, the central government approves the annual allocation to SDRF.
- On the recommendations of 14th Finance Commission, the government has significantly enhanced the allocation to SDRF by 82.30% for 2015-16 to 2019-20.

 The Ministry of Housing and Urban Affairs, under the aegis of Swachh Bharat Mission – Urban (SBM – U), has partnered with Google to launch the Loo Review campaign.



 One of the objectives of the Swachh Bharat Mission – Urban (SBM - U) is to provide sanitation coverage through public toilet facilities across cities in India for achieving Open Defecation Free (ODF) status.

- It is to encourage all local guides in India to rate and review public toilets on Google Maps.
- This campaign is part of a feature which allows all citizens to locate public toilets in their cities on Google Maps, Search and the Assistant and also provide feedback on the same.
- 500+ cities in India with more than 30,000 toilets with the name of "SBM Toilet" are currently live on Google Maps.

## 7. NITI Aayog and Oracle sign a Statement of Intent to pilot drug supply-chain using the blockchain

 NITI Aayog signed an agreement with cloud services provider Oracle, hospital chain Apollo Hospitals, and pharmaceutical manufacturer Strides Pharma Sciences to curb the distribution of fake drugs using new technologies.  Oracle's blockchain software permanently registers a drug's record in the manufacturer's drug supply chain (serial number, labeling, scanning), leaving no scope for record tampering

#### **NOTE-**

- The Indian pharmaceutical industry is the third largest in the world in volume, accounting for 10% of the world's production.
- A recent report by World Health Organisation estimates 20% of all drugs sold in India are fake.
- Also, as the largest producer of generic drugs in the world, India is reported to be the source of 35% of all counterfeit drugs sold worldwide.

### About Blockchain technology in drug supply-chain

- Blockchain technology helps to permanently register a drug's record in the manufacturer's drug supply chain (serial number, labelling, scanning), leaving no scope for record tampering.
- At every point of hand change, it records the drug's movement – from manufacturer to logistics, to the stockist to the hospital, or pharmacy to the consumer.
- In case of a fake drug, the software will detect irregularity.
- Additionally, critical information such as chemical ingredients of the drug or maintenance of temperature control in case of life-saving drugs or vaccines can also be tracked.
