5. The result is provisional. The candidates whose Roll Numbers figure in the list must fulfill all the eligibility conditions/requirements as prescribed for the post in the Notice of Examination.
6. The department-wise allocation of the candidates for the states of Delhi, Rajasthan & Utrakhand has been done as per the following procedure :-
- (i) All intending departments, who had reported vacancies were arranged in Alphabetical order. Prefixed like Deptt. of, D/o, Department of, M/o, Ministry of etc. have been ignored.
  - (ii) Candidates in Merit order were segregated for each CATSEL i.e. selected category and allocated to the user departments figuring in alphabetical list in the 'following manner :-
    - (a) The Candidates in the merit order were allocated to the departments in order of ExS/OH/HH/VH(horizontally vacancies) and then SC/ST/OBC/UR.
    - (b) First ranking candidates has been allocated to the Department figuring third in the list.
    - (c) Second ranking candidate has been allocated to the Department figuring next in alphabetical order list and so on till vacancies are available in the different departments.
7. Allocation of withheld candidates has not been finalized.
