WHEREAS the employer has offered to engage Shri/Smt./Ku..... as (post) for on a probation/ training for a period of _____ years, which may be extended and the probationer/employee has agreed to accept the offer of the employer.

AND WHEREAS in terms of clause _____ of the Main Terms and Conditions of the said offer of appointment, the Probationer is required to undergo initial training as determined by the Employer for a period of twenty-four months, which may be extended to twelve more months in case of unsatisfactory performance by the Probationer, and to serve the Employer for a minimum period of 2 years from the date of joining on initial appointment in KVS.
