Barely would one come across staff in the State Bank of India walking up to a customer to sell a product that one had not asked for. But that is set to change. Cross-selling has been a mantra on which many of the global lenders – from Citibank to the locally groomed HDFC Bank - rest their success on. For Indian state-run banks built on orders from their political master, that's hardly strength. While SBI followed a model of others such as HDFC Bank and ICICI Bank when it came to the idea of a financial supermarket, its large lending operations and other activities such as earning fee income from advisory remained in silos that reduced its ability to exploit the customers. Growth has all along been about increasing the asset size by cutting cheques for thousands of crores in project finance, but not looking at customers' needs for other services such as digital only and complex financial products.

As the 25th chairman of SBI, Rajnish Kumar is determined to change course. In what is a total **revamp** of the organisational structure for the first time in 18 years, the lender will see its corporate lending groups amalgamated with the idea of extracting higher share of the customers' wallet _ from derivatives, encircling their suppliers for more business and make a business out of bad loans that it has accumulated. "The aim is to improve fee income as the corporate accounts group will also focus on project finance and credit accounts have huge supply chains around them," savs Kumar.

The mighty corporate accounts group will focus on large corporates with the best credentials, but would not restrict its activity to lending, but would exploit the potential to bring in other banking business. These companies such as Tata Motors have thousands of suppliers around them that is a great catchment area. Although SBI is the biggest with 23% market share of assets, it has also one-fourth of the total deposits and loan market. For the nine month period in the last fiscal, its income from fees grew 9% and cross-selling income grew by 85%. At the end of the December quarter, the bank's fee income comprised only 8% of its total income, this compares to 30% for Axis Bank.

Increasing fee income may be a good strategy, but hard to execute as it comes with many challenges. "There is a huge potential to grow fee income just looking at the sheer size," says Darpin Shah, banking analyst, HDFC Securities. "I did a road-trip in UP. It was surprising that SBI is the only PSU bank putting up a tough challenge to NBFCs and other banks in that region, in some places it was even No 1 and this is getting them good fee growth."

The very strengths that an institution counts upon to build its future could by itself become a drag. The staff strength of 2.6 lakh, including the over 73,000 that it got after the merger of associate banks last year, was becoming as much a problem as it opened up opportunities. After year when staff а amalgamated banks' lost out on promotions, the bank has come up with its own 'succession planning' up to the deputy managing director level within its ambit. For each DMD role, the bank will shortlist four chief general managers and, for every CGM position, there will be nearly 4 GMs who will prepare to take over senior management mantle.

1. Ans. B.

As stated in the 1st para, "Barely would one come across staff in the State Bank of India walking up to a customer to sell a product that one had not asked for." Hence, option B is correct.

2. Ans. A.

As stated in the first para, "While SBI followed a model of others such as HDFC Bank and ICICI Bank when it came to the idea of a financial supermarket, its large lending operations and other activities such as earning fee income from advisory remained in silos that reduced its ability to exploit the customers." Hence, option A is correct. In the given context, silos refers a system, process, department, etc. that operates in isolation from others.

3. Ans. C.

As mentioned in the 2nd para, "As the 25th chairman of SBI, Rajnish Kumar is determined to change course. In what is a total revamp of the organisational structure for the first time in 18 years, the lender will see its corporate

lending groups amalgamated with the idea of extracting higher share of the customers' wallet – from selling derivatives, encircling their suppliers for more business and make a business out of bad loans that it has accumulated." Option C expresses this idea, thus it is the correct answer.

4. Ans. D.

As stated in the 3rd para, "The mighty corporate accounts group will focus on large corporates with the best credentials, but would not restrict its activity to lending, but would exploit the potential to bring in other banking business." Hence, option D is correct. A and E are not mentioned in the passage. Option B is incorrect as the third paragraph states, "Although SBI is the biggest with 23% market share of assets, it has also one-fourth of the total deposits and loan market." Optio C is incorrect as fourth paragraph states, "Increasing fee income may be a good strategy, but hard to execute as it comes with many challenges."

5. Ans. B.

Hence, option B is the correct answer.

6. Ans. E.

7. Ans. A.

The word "mantle" means role or responsibility and out of the given words, "duty" has a similar meaning. "Plinth" and "pedestal" mean base of something. "Rebuke" and "reprimand" mean scold. Hence, option A is the correct answer.

8. Ans. B.

The word "revamp" means to give new and improved form, structure, or appearance to. "Refurbish" has a similar meaning.

"Exasperate" and "ruffle" means to annoy and "jeopardize" and "imperil" are antonyms of the given word. Hence, option B is correct.

The word "amalgamate" means to combine and out of the given words, "apportion" has a meaning opposite to the given word. "Integrate" and "fortify" are the synonyms of "amalgamate" and "snarl" and "intertwine" means entangle. Hence, option A is the correct answer.

10. Ans. D.

The word "accumulate" means gather or collect and out of the given words, and "segregate" has an opposite meaning.

"Garner" and "amass" are its antonyms. "Requite" means revenge and "subtle" means fine. Hence, option D is correct.

11. Ans. D.

All statements except D are correct as a sentence carrying a same idea has been rephrased in different ways. Option D has two

errors. The usage of the conjunction 'so' is incorrect here as it is used to state a reason. But in the given sentence, it is being told Twitter is different from other social media platforms. Thus, 'while' can be used instead 'so'. Secondly, 'adhere' should be followed by the preposition 'to' to make the correct prepositional phrase which is required here. Hence, D is the answer.

12. Ans. C.

All the sentences except option C are correct. In C, the adjective 'financial' does not modify any noun, which makes the sentence incorrect. Additionally, since 'pressure' has been used as a verb here, an adverb should modify it. But since "considerate" is an adjective, an error occurs in the sentence. Thus, 'considerate' should be replaced by 'considerable.

Thus, option C is the answer.

13. Ans. A.

All sentences except A are correct. In options B, C and D, "human" has been used as an adverb to modify the verb "caused", while in option A, human is used as a noun followed by a helping verb 'have', which is then later followed by 'played': "Human have caused climate change played". This sentence construction is grammatically incorrect. "Human- caused", on the other hand means "caused by humans". Hence, option A is the answer.

14. Ans. C.

All the sentences except option C are correct. In C, 'there' which indicates place has been used instead of the possessive noun "their" which would refer to the drivers. Thus, option C is the answer.

15. Ans. B.

All the sentences except option B are correct. The sentence construction in B is incorrect where "with the friction in Tuticorin early, and after having failed in it and hence a stage", does not make any coherent sense. Thus, option B is the correct answer.

16. Ans. D.

All the sentences except option D are correct. In option D the phrase "whether or no" is incorrect and the correct one is "whether or

not". Additionally, "the tax authority" may refer to a person, hence, 'who' can be used, but the usage of the plural verb "are" is incorrect as a single person is being talked about. Thus, D is the correct answer.

All the sentences except option A are correct. In A, 'to' has been wrongly used before the gerund 'focusing', which makes the sentence grammatically incorrect. Since, "to improve" has been mentioned earlier, "to focus" should be used to maintain parallelism. Thus, option A is the answer.

18. Ans. C.

Only alternative (iii) is correct. In the given sentence, 'him had his' is wrong because the subjective pronoun should be used instead of an objective one. So we should have 'he'. Thus, option C is the correct answer.

19. Ans. B.

Here the alternatives (ii) is correct. 'Turn on' is a completely different phrase which means 'to activate or cause to flow, operate, or function.' On the other hand the correct phrase i.e. 'turn down' means 'refuse request or offer.'

Thus, option D is the correct answer.

20. Ans. D.

When we use 'for' it shows the reason of occurrence. Therefore we can't use for in this sentence because it isn't giving any reason. 'But' is what we should use. 'But' changes the entire course of the sentence. It conveys the sense that rather than discarding habits at once, they need to be removed gradually. So here both (ii) and (iii) are correct. Therefore, option D is the correct answer.

21. Ans. A.

The expression "insisted on shown" is incorrect. The prepositional verb "insisted on" should always be followed by -ing form of the verb. Hence, here, "being" should be used after on. Alternatively, the sentence can be rephrased with the usage of that: "Helen was greatly interested in the boat, and insisted that she be shown every inch of it from the engine to the flag on the flagstaff." Among the given alternatives, only alternative (i) is correct and option A is the correct answer.

22. Ans. D.

The bold part in the given sentence and Option (ii) are incorrect because whenever the phrase "not only" is used, it is obligatory to use "but also" in the sentence. Option (i) is correct because it replaces "not only... but also" with "as well as" which is correct. Option 3 is correct as it uses "but also" with "not only". Thus, option D is the correct answer. 23. Ans. D.

The bold part of the sentence contains one error i.e. 'migration' is used before children and it is noun. Instead of a noun, an adjective is required here to qualify the noun 'children'. Similarly, immigration is also a noun, so sentence 2 is also incorrect. 'Migrant' meaning tending to migrate or having migrated can work as an adjective to qualify the noun children. Hence option D is the correct choice. 24. Ans. E.

This sentence does not need any correction and hence option E is the correct answer. Moreover, the three options grammatically incorrect and they cannot replace any part of the sentence. In alternative i, the word 'freezing' is not appropriate because there should be a superlative degree after 'and' if a superlative degree is used before it. Also, the preposition "at" is missing in the segment. In alternative ii the word 'tallest' in inappropriate because for peaks, we use "highest" not tallest. In alternative iii, the preposition 'in' is incorrect because we use 'at' for places.

25. Ans. B.

In the given sentence the preposition 'from' is used with shivering which is incorrect in this context because here the sentence is talking about the time period i.e. start to winter. Hence the option B is correct as sentence 2 uses the preposition 'through'. Rest two sentences does not make not make any sense semantically.

26. Ans. C.

The sentence talks about the speaker finding it difficult to cope with the crowd around him, rushing to get to their respective destinations.

"until the crowds dispersed" is correct because it implies that the speaker found peace only when there was less crowd around him. "until there was more calm around me" is correct because it implies the same thing as the previous snippet.

"until there were hoardes of people around me" is incorrect because it implies that the speaker found peace only when there was crowd around him, which doesn't make sense.

Thus, C is the correct option.

27. Ans. C.

The sentence talks about a story revolving around a small community whose identity has been erased by the government. "erasures instigated" perfectly fits into the blank as it completes the sentence and makes perfect sense.

"unjust obliteration of pieces of evidence" is correct too as obliteration means deletion or destruction. The finished sentence means that the evidence supporting the community has been erased by the government. "misconduct of information" cannot be used here as the word "misconduct" means bad conduct which is not the case here, and thus

the sentence does not make sense. Thus, C is the correct answer.

28. Ans. B.

Here only option B is correct. It is the only option that makes the sentence logical. While 'dethrone of the" doesn't make any sense, option iii makes the sentence grammatically incorrect.

Option i: dethrone means take the throne away from the king

Option ii: it is talking about something which is greater the king himslef

Option iii: something which is ahead of time 29. Ans. B.

"Crinkle" means wrinkle. Someone's eyes would perform actions behind his/ her glasses. Thus, only alternative (iii) is correct. 30. Ans. B.

Only option B is logical. It means that the subject got the car back without much damage.

Option i: car is reversed into one piece Option ii: car repaired one piece. Also doesn't make sense. Repairing itself means bringing the car into one piece.

Option iii: car is received without much damage.
