#### AGE LIMIT:

Upper Age limit is 27 years as on last date of online application in APCPL (i.e. 01.06.2020). SELECTION PROCESS:

Eligible candidates who have qualified in Graduate Aptitude Test in Engineering (GATE)-2019 and Based on the GATE-2019 marks and requirement, candidates will be short listed for further selection process (GD and Interview). The final merit list will be prepared based on 85% weightage of GATE-2019 marks, 5% weightage of GD marks and 10% weightage of Interview marks.

The vacancies for PwBD & EWS are reserved as per Govt. guidelines. COMPENSATION PACKAGE:

APCPL offers one of the best pay packages in the industry. Selected candidates will be placed in the pay scale of E1 (Grade) in the pay scale of Rs. 40,000-1,40,000 at the basic pay of 40,000/during one year training period. The other allowance such as Dearness Allowance, other perquisites and allowances, terminal benefits, etc. will be admissible as per company rules in force from time to time during training.

#### PLACEMENT:

The selected candidates shall undergo one-year training at APCPL. After completion of training candidates shall be placed in regular pay scale of E1 grade at APCPL.

# RESERVATIONS AND RELAXATIONS:

- Reservations and relaxations for SC / ST / OBC (non-creamy layer) /XMS/EWS/ PwBD candidates will be provided as per Government guidelines. Relaxations will be extended in vacancies identified for SC / ST / XSM/ OBC (non-creamy layer), PwBD.
- Category (SC / ST / OBC / XMS / EWS / PwBD) once filled in the online application form will not be changed and no benefit of other category will be admissible later on. The reserved category candidates are required to submit requisite certificate in the prescribed format of Government of India, issued by the competent authority, at the time of interview, if called for.
- No registration fee will be charged from SC/ST/XSM/PwBD candidates during online registration in APCPL Ltd.
- 4. SC, ST and PwBD candidates with at least 55% marks in qualifying examination are eligible to apply for the post.
- The upper age limit is relaxed by 5 years for SC/ST, 3 years for OBC (Non-Creamy Layer) candidates. It is relaxed by 10 years for PwBD – General, 13 years for PwBD-OBC and 15 years for PwBD-SC/ST Candidates.

- The OBC candidates who belong to "Creamy Layer" are not entitled for concession admissible to OBC category and such candidates have to indicate their category as General. The OBC (Non-Creamy Layer) candidates are required to submit requisite certificate in prescribed format of Government of India, from a competent authority issued in the current year only. Also, OBC (NCL) candidates will have to give a selfundertaking indicating that they belong to OBC (Non-creamy Layer) category also at the time of GD & Interview if called for.
- Upper age is relaxed by 5 years for the candidates who had ordinarily been domiciled in the state of Jammu & Kashmir from 01.01.80 to 31.12.89. In addition, the age relaxation for Ex-servicemen (XSM) will be as per Government of India norms.

#### SERVICE AGREEMENT BOND:

The selected candidates who belong to General and OBC categories will be required to execute a service agreement bond of Rs. 2,50,000/- (Rs. 1,25,000/- for candidates belonging to SC, ST categories) to serve the company for at least 3 years after successful completion of one-year training.

#### HOW TO APPLY:

- Candidates fulfilling the pre-requisite conditions are requested to fill up the application form in the portal in Block Letters.
- The candidates, who have appeared in GATE 2019, are only eligible to apply and should indicate GATE registration number, the candidates need to apply online for APCPL ET-2020 on the website www.apcpl.co.in from 04.06.2020 to 03.07.2020.
- Candidate belonging to General/OBC category is required to pay a non-refundable registration fee of Rs. 150/-. The SC/ST/PwBD category registration fees NIL.
- 4. Payment can be made either through offline mode or online mode as described below:
  - A. Payment in offline mode: Punjab National Bank has been authorized to collect the registration fee on behalf of APCPL. Candidate has to approach the nearby PNB branch with a printout of the "Challan" which is available on the application registration portal. The Challan printed from the portal should only be used for depositing the fee for proper crediting of amount in APCPL account. APCPL will not be responsible in case the candidate deposits the fee in a wrong account.
- Payment in online mode: Candidate also has the option to pay the fee online (through Net banking / Debit Card / Credit Card). The online payment option will be available on the application portal.
   Notes:
  - If the registration fee due to any reason, whatsoever, is not credited in the APCPL Account, the Application is liable to be rejected.
  - Fee once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility before paying the registration fee.

  Read the instructions carefully and fill-in the online application form giving accurate information including the GATE-2019 registration number. After successful registration, system will generate a Unique Registration Number. Candidates are required to login with their unique registration number for making the fee payment excluding SC/ST/PWBD and printing of registration slip. Candidates shall be allowed to take printout of registration slip only after confirmation of payment from PNB Bank. Candidates need to take printout of registration slip and keep it with themselves for future use.
- Please ensure that the GATE registration number, which is mentioned on your GATE Score Card, is filled up correctly. No request with respect to the change in any data entered by the candidate will be entertained once the application is submitted successfully.
