Antyodaya Anna Yojana	The objective is to target poorest of the poor population and provide them relief from hunger	It includes poorest of the poor from amongst the BPL families covered under the Targeted Public Distribution System within the States The scheme provides them food grains at the rate of Rs.1/ per kg for coarse grains, Rs.3/ per kg. for rice, and Rs. 3/ per kg for wheat.  Intended beneficiaries: Households headed by widows or terminally ill persons/disabled persons/ persons more than 60 years of age and persons with no assured means of subsistence or societal support.  It is a part of NFSA (National Food Security Act), and the households under AAY are entitled to 35 Kg of foodgrains per household per month States/UTs are required to bear the distribution cost, including a margin to dealers and retailers as well as the transportation cost
