- The full-form of NFS is National Financial Switch
- National Financial Switch is the largest network of shared automated teller machines in India.
- It was designed, developed and deployed by the Institute for Development and Research in Banking Technology in 2004, with the goal of inter-connecting the ATMs in the country and facilitating convenience banking.

2. Ans. C.

- The first-ever BRICS Games was concluded in Guangzhou, China in June 2017.
- India won six medals including two gold, two silver and two bronze, in the Wushu competition at the inaugural BRICS Games.
- The Indian Wushu team won a gold, silver and a bronze on two consecutive days. Notably, the BRICS Games were formulated at the 8th BRICS Summit held in Goa, India in 2016.

3. Ans. D.

- ECGC Ltd. is the seventh largest credit insurer of the world in terms of coverage of national exports. The present paid-up capital of the company is Rs. 2500 crores and authorized capital Rs. 5000 crores.

- Born in a peasant's family at Ajmer's Gopalpura village, the politician made his Lok Sabha debut in 2014 by defeating Rajasthan Congress president Sachin Pilot from Ajmer.

Nature of Cases to be Referred to as Lok Adalat

1. Any case pending before any court.
2. Any dispute which has not been brought before any court and is likely to be filed before the court.
