विज्ञप्ति

सम्मिलित राज्य अभियन्त्रण सेवा (सामान्य/विशेष चयन) परीक्षा-2021 की लिखित परीक्षा का परिणाम दि०.29.09.22 यथासंशोधित दि०.31.10.22 को घोषित किया गया था, जिसमें विभिन्न विभागों के सामान्य चयन के अन्तर्गत 271 पद एवं विशेष चयन के अन्तर्गत 12 पद (कुल-283 पद) शामिल थे। इस परीक्षा में कुल-892 अभ्यर्थी साक्षात्कार हेतु सफल घोषित किये गये थे। आयोग द्वारा साक्षात्कार हेतु सफल घोषित अभ्यर्थियों के साक्षात्कार दिनांक 17.10.2022 से 15.11.2022 तक सम्पन्न किये गये, जिसमें कुल 869 अभ्यर्थी सम्मिलित हुए। चयन हेतु उपलब्ध कुल 283 रिक्तियों के सापेक्ष विभिन्न पदों हेतु 266 अभ्यर्थी सफल घोषित हुये हैं एवं 17 रिक्तियाँ उपयुक्त अभ्यर्थी न मिलने के कारण अनभरी रह गयी हैं। उ०प्र० आवास एवं विकास परिषद में सहायक अभियन्ता (विद्युत) की ओ.बी.सी. श्रेणी की 01 रिक्ति, नमामि गंगे एवं ग्रामीण जल आपूर्ति में सहायक अभियन्ता (यान्त्रिक) की ओ.बी.सी. श्रेणी की 01 रिक्ति, नगर विकास विभाग में सहायक अभियन्ता (सिविल/मैकेनिकल/इलेक्ट्रीकल) की कुल 12 रिक्तियाँ (अना.-09, एस.सी.-02 ई.डब्ल्यू.एस.-01) एवं अग्नि शमन सेवा में मुख्य अग्निशमन अधिकारी की कुल 03 रिक्तियाँ (अ०पि०व०-02, एस०सी०-01) उपयुक्त अभ्यर्थी उपलब्ध न होने के कारण अनभरी रह गयी हैं जिन्हें अग्रणीत किया गया है।
