#### NOTIFICATION

## CONSTITUTION OF INDIA.

No.MBA-2015/C.R.08/D-VIIA.-In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all existing rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating the recruitment to the posts of Superintendent, Inspector, Certified School and Institution, Organization and Method Officer, Lecturer, District Women and Child Development Officer and Statistical Officer, Group-B (Gazetted) in the Commissionerate of Women and Child Development and Child Development Project Officer (Rural), Group-B (Gazetted) in the Commissionerate of Integrated Child Development Service Scheme under the administrative control of the Women and Child Development Department, Government of the Maharashtra, namely:-

- 1. (1.) These rules may be called the Commissionnerate of Women and Child development, Group-B (Gazetted) posts and Commissionerate of Integrated Child Development Scheme, Group B (Gazetted) post (Recruitment) Rules, 2022.
  - (2.) These Rules shall come into force on the date of publication of these Rules in the Government Gazette.
- 2. In these rules, unless the context requires otherwise,
  - a) "Government" means the Government of Maharashtra;
  - b) "Commission" means Maharashtra Public Service Commission;
  - c) "Degree" means a degree of a statutory University;
  - d) "Department" means the Women and Child Development Department in the Government of Maharashtra;
  - e) "Schedule" means the Schedule appended to these Rules.
- 3. Appointment to the posts of the Superintendent, Inspector Certified School and Institution, Organization and Method Officer, Lecturer, District Women and Child Development Officer and Statistical Officer, Group –B (Gazetted) in the Commissinerate of Women and Child Development and Child Development

Project Officer (Rural), Group-B (Gazetted) in the Commissionerate of Integrated Child Development Service Scheme shall be made either-

(a) by selection, as per common merit list prepared on the basis of the result of the common Limited Departmental Examination, to be held by the Commission in accordance with the orders issued by the Government, in consultation with the Commission in that behalf, from time to time, of the persons holding the posts mentioned in the Schedule "A" and Schedule "B" appended hereto, having not less than seven years regular service on those posts as on 1<sup>st</sup> January of the year in which examination is held:

Provided that, while computing the period of seven years regular service in case of cadre of District Probation Officer, combined regular service in the cadre of Probation Officer and the cadre of District Probation Officer shall be considered; or

- (b) by nomination on the basis of result of a Competitive Examination to be held by the Commission from amongst the following candidates who,-
  - (i) have completed eighteen years of age but not more than thirty- eight years of age:

Provided that, the age limit shall be relaxed upto five years in case of the candidates belonging to the reserved category; and

- (ii) possess a Degree in any discipline; or
- (c) by deputation:- In the event of non availability of candidates by selection and nomination a suitable person shall be appointed by deputation from officers/employees with equivalent pay scales:

Provided that, the appointment by deputation shall be made by adhering to the terms and conditions as prescribed in the deputation policy framed by the General Administration Department. However, the maximum appointments by deputations shall not exceed 15% of number of sanctioned posts.

- 4. Appointment to the post mentioned in Rule 3 by selection and nomination shall be made in the ratio of 50:50.
- 5. It is mandatory for a person who is appointed by nomination to the posts mentioned in rule 3, to complete the training under the Combined Probationary Training Programme (CPTP). The provisions specified in various Government Resolutions, Government Circulars, Rules and Notifications, from time to time by CPTP (Training) Desk of General Administration Department shall be applicable with respect to Probationary training, Probationary Period, Seniority, Departmental Examination and other related matters of officers undergoing training under CPTP. If the person appointed to the posts mentioned in rule 3 by nomination is found unfit for the posts during probationary period, then he shall be liable for termination of services.
- 6. (1) A person appointed to the posts mentioned in Rule 3, by selection either has been already passed the Marathi and Hindi language examinations as per the rules made in that behalf by the Government, from D:\RAJBHO\\सेवाप्रवेश गट-ब\R.R.final.docx

time to time, or has been exempted from passing those examinations. Otherwise, such person shall not be eligible for selection to the posts mentioned at Rule 3.

- (2) A person appointed to the posts mentioned in Rule 3, by nomination shall pass the Marathi and Hindi language examinations as per the rules made in that behalf by the Government, within the prescribed time limit after appointment, from time to time, unless he has already passed or has been exempted from passing those examinations. He shall not be eligible for annual increment or promotion to the next promotional post until he passes those examinations.
- 7. (1) A person appointed to the posts mentioned in rule 3, by selection either to possess a Knowledge of Computer Operations prescribed by the Government, from time to time, or he has been exempted there from before being selected to said posts.
- (2) A person appointed to the posts mentioned in rule 3, by nomination shall possess a Knowledge of Computer Operations prescribed by the Government, from time to time, within the prescribed time limit after appointment, unless he has been exempted from possessing such knowledge of Computer Operations, otherwise he shall not be eligible for annual increment and promotion to the next promotional post until he possess the same.
- 8. It is mandatory for the person appointed to the posts mentioned in Rule 3, by nomination to submit a declaration of small family as provided by the Maharashtra Civil services (Declaration of Small Family) Rules, 2005 and the Rules made thereunder from time to time, at the time of appointment to the concerned post. A person having more than two children on the date of submission of Declaration of Small Family, shall be disqualified for the appointment in Government Service. Moreover, the person shall be governed by Government Orders issued from time to time in this behalf.
- 9. A person appointed to the posts mentioned in rule 3, shall be liable to be transferred anywhere in the State of Maharashtra.
