**REJECTION NOTICE NO: 853 DATED 10.05.2022**

**PGT (ENGLISH) FEMALE, POST CODE-26/20  
IN DIRECTORATE OF EDUCATION.**

1. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of **PGT (English), Female, Post Code-26/20 in Directorate of Education** and the terms and conditions of the advertisement, the candidature of 02 candidate in respect of the above said post code is rejected for the reason/ remarks mentioned against her roll number:-

**2. EWS CATEGORY:-**

S. no.	Roll No	Reason/Remarks
1	11160800040	The candidate has uploaded B.Ed. degree after cutoff date i.e. December, 2020. This condition was however, releasable that in case, the candidate has not done B.Ed., than a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). But as per documents uploaded by the candidate in the e-dossier, it has been found that she has second division in Post Graduation i.e. M.A. (English). Hence, this condition is not applicable on her and therefore, she was given two opportunities 08/10/2021 to 17/10/2021 and 2 <sup>nd</sup> and final opportunity w.e.f. 29/11/2021 to 03/12/2021 to upload B.Ed. as on cutoff date but she failed to upload the deficient / requisite documents in the e-dossier. Hence, her candidature is rejected for fulfilling the eligibility criteria as per RRs.

**3. OBC CATEGORY:-**

1	11330800017	The candidate has not uploaded (i) B.Ed. degree & its marks sheet (ii). B.A. degree and its marks sheet, (iii). 1 <sup>st</sup> page of admit card duly signed by the invigilator & (iv). Undertaking for B.Ed. The candidate was given two opportunities w.e.f. 08/10/2021 to 17/10/2021 & 28/10/2021 to 01/11/2021 that in case, the candidate has not done B.Ed., than a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). But, she did not upload any requisite / relevant documents in the e-dossier. Hence, her candidature is rejected for not fulfilling the eligibility criteria as per RRs. The candidate has however, submitted a representation dated 13.10.2021 for activating of e-dossier link. The representation of the candidate has been examined in detailed and the facts are that that e-dossier link was opened for all the shortlisted candidates including Roll No. 11330800017 by giving 15 days time period w.e.f. 06.09.2021 to 20.09.2021 to upload all the requisite documents in the e-dossier. The requisite documents were specifically mentioned in the requisite column

		(serially) in the e-dossier. The candidate has however, uploaded all the requisite documents in that particular column in e-dossier <u>except B.Ed. degree &amp; its marks sheets, B.A. degree and its marks sheets, 1<sup>st</sup> page of admit card duly signed by the invigilator or undertaking in case not having B.Ed. but having 1<sup>st</sup> division in intermediate. Graduation and Post-Graduation.</u> The candidate was failed to upload all the requisite documents in the e-dossier even after giving 15 days time period w.e.f. 06.09.2021 to 20.09.2021. Further, she was given 1 <sup>st</sup> opportunity of 10 days w.e.f. 08.10.2021 to 17.10.2021 to upload the above mentioned deficient documents in the e-dossier but she again failed to upload the same in the e-dossier. Thereafter, she was given 2 <sup>nd</sup> and final opportunity of 05 days w.e.f. 28.10.2021 to 01.11.2021 but she again failed to upload the requisite / deficient documents in the e-dossier and again failed to upload the requisite / deficient documents. The claim of the candidate in her representation is totally baseless as she was given sufficient opportunities to upload the requisite documents in the e-dossier for the post of PGT (English) Female, Post Code-26/20.
