PGT (MATHS) MALE, POST CODE-28/20 IN DIRECTORATE OF EDUCATION.

1. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of PGT (Maths), Male, Post Code-28/20 in Directorate of Education and the terms and conditions of the advertisement, the candidature of 02 candidate in respect of the above said post code is rejected for the reason/ remarks mentioned against her roll number:-

2. OBC CATEGORY:-

S. no.	Roll No	Reason/Remarks
1	121102800077	OBC (Outsider) OBC certificate issued from Patna, Bihar. Hence, not eligible under OBC category. The candidate was given two opportunities w.e.f. 10.12.2021 to 19.12.2021 & 21.12.2021 to 26.12.2021 but failed to upload OBC (D) certificate. Hence not eligible under OBC category. However, his candidature is still alive under UR category but not in consideration zone as per his merit.

PH/OH CATEGORY:-

S. no.	Roll No	Reason/Remarks
1	121202800001	The candidate has uploaded B.Ed. degree after cutoff date i.e. 12.12.2020 whereas all the educational qualification should be as on cutoff date i.e. 13.02.2020. However, this condition was relexable that in case, the candidate has not done B.Ed., than a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). But as per documents uploaded by the candidate in the edossier, he has second division in Higher Secondary. Hence, this condition was not applicable for him and he was given two opportunities w.e.f 08.02.2022 to 17.02.2022 & 14.03.2022 to 18.03.2022 to upload B.Ed. as on cutoff date but he failed to upload the same. Hence, his candidature is rejected for not fulfilling the eligibility criteria as per RRs.
