**PGT (ENGLISH) MALE, POST CODE-25/20
IN DIRECTORATE OF EDUCATION.**

On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of PGT (English), Male, Post Code-25/20 in Directorate of Education and the terms and conditions of the advertisement, the candidature of 06 candidate in respect of the above said post code is rejected for the reason/ remarks mentioned against their roll number:-

2. **EWS CATEGORY:-**

| S. no. | Roll No | Reason/Remarks |

| 1 | 121102500792 | The candidate has not uploaded EWS certificate. He has neither mentioned in E-dossier form. He has uploaded a paper mentioned that "Not applicable - General Category" in e-dossier column wherein EWS certificate was required. Hence his candidature cannot be considered under EWS category. However, his candidature is still alive under UR category but not in consideration zone at present. |

3. **OBC CATEGORY:-**

| S. no. | Roll No | Reason/Remarks |

| 1 | 121202500698 | OBC (Outsider). The candidate has not uploaded OBC (D) certificate. However, he has uploaded an application mentioning that his candidature may be considered under UR category. Hence, not eligible under OBC category for being OBC (Outsider). However, his candidature is still alive under UR category as per his merit. |
| 2 | 111902500154 | B.Ed. after cutoff date. i.e. 02.12.2020. However, this condition was relaxable that in case, the candidate has not done B.Ed., then a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). But he has 2 nd division in M.A. & B.A. Hence, Not Eligible. |
| 3 | 121202500349 | OBC (Outsider). The candidate has uploaded OBC certificate issued from Gopalganj, Bihar. The candidate was given two opportunities w.e.f. 29.11.2021 to 08.12.2021 & 21.12.2021 to 25.12.2021 to upload OBC (D) certificate but he failed to upload the same. Hence, not eligible for being OBC (Outsider). |

4. ST Category:-

| S. no. | Roll No | Reason/Remarks |
|--------|--------------|--|
| 1 | 111902500229 | <p>The candidate is a FEMALE candidate and applied for MALE post code. She has uploaded an application and stated that she had applied both the post code i.e. post code-26/20 (PGT English-Female) & post code-25/20 (PGT-English Male) but she could not download admit card for post code-26/20 however, admit card for post code-25/20 was downloaded and she appeared in the written examination.</p> <p>From the above, it is clear that she had intentionally applied both the post code. When she had already applied for Female post code i.e. 26/20 then why she had applied for Male post code i.e. 25/20. The downloading of admit card is a later stage i.e. at the time of written examination whereas when she applied for Female post code i.e. 26/20, she got message "application submitted successfully" as she has already mentioned in her representation vide email. The candidate had intentionally applied for both post codes i.e. 25/20 & 26/20 but as she could not download the admit card for post code-26/20 (Female) for the reason whatsoever, she had downloaded admit card for post code-25/20 (male) and appeared in the written examination. A Female candidate cannot be considered on Male post code and accordingly she is not eligible for the post code-25/20.</p> |
| 2 | 121202500435 | M.A. English after cut off date i.e. 09.11.2020. |
