
- The DSSSB vide its advertisement no. 01/2021 dated 04/03/2021 with closing date 14.04.2021 and subsequent corrigendum dated 10/03/2021 had advertised 1126 vacancies (UR-487, EWS-54, OBC-328, SC-164, ST-93 including OH-23 and VH-22) for the Post of Special Educator (Primary) under the Post Code 32/21 in Municipal Corporation of Delhi.
- 2. The written examination (online mode in three shift) Tier-I (Technical) for recruitment in respect of this post was conducted on 17/10/2021.
- 3. Whereas all candidates were instructed vide clause 7 (viii) of the said advertisement that the educational qualification, age, experience, and other eligibility conditions against the post shall be determined as on the closing date of online submission of application.
- 4. Whereas all candidates were informed vide clause 5 (ii) of the said advertisement that Candidates who wished to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificates (SC/ST/OBC/Non Creamy layer/PH/Educational/Experience, etc.) issued by the competent/notified authority (in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise.
- 5. Whereas all the candidates were given opportunity through Notice No. 1337 dated 05/01/2022 to up-load their documents in the e-dossier link activated on OARS Module with effect from 13/01/2022 to 27/01/2022
- 6. Whereas on scrutiny of the document uploaded on OARS portal, candidates have been given proper opportunities vide 1<sup>st</sup> recall notice no.1376 dated 27/04/2022, 1384 dated 26/05/2022 & 2<sup>nd</sup> recall notices 1385 dated 26/05/2022, 1386 dated 03/06/2022 & 1389 dated 14/06/2022 to upload deficient documents through e-dossier module.
- 7. On final scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll Nos. in respect of the above mentioned post code have been found to be 'Not Eligible' in terms of the advertisement no. 01/2021 dated 04/03/2021 and Recruitment Rules for the post of Special Educator (Primary) under the Post Code 32/21 in Municipal Corporation of Delhi.


