This **Monthly GK Digest** is a **complete docket** of important news and events that occurred in the month of '**June-2022**'. This file is important for, **Bank, SSC, and Railway** exams.

### **Banking & Financial Awareness**

1. According to the annual report data of the Reserve Bank of India, the current the size of the central bank's balance sheet during 2021-22 is **Rs 61,90,302.27 crore**.  
**Note:** This shows activities carried out by it in pursuance of currency issue function as well as monetary policy and reserve management. Revenue has increased by 20.14% and expenditure rose by 280.13%.
2. **Rs 66,539 crore** is the net profit of Public sector banks (PSBs) during FY 2021-22.  
**Note:** The collective profit of banks during 2021-22 is Rs 66,539 crore with an increase of 110% over Rs 31,816 crore in FY21. SBI has the highest net profit at Rs 31,675 crore followed by Bank of Baroda (7,272 crores), and Canara Bank (Rs 5,678 crore).
3. The Fiscal deficit of India for 2021-22 is **6.71% of the GDP**.  
**Note:** The fiscal deficit in the absolute terms was Rs 15,86,537 crore (provisional). The finance ministry had estimated the deficit at Rs 15,91,089 crore or 6.9 percent of GDP in February 2022.
4. SEBI has imposed a penalty of Rs 1 crore on **India Infoline Ltd (IIFL)** for misusing client fund.  
**Note:** The amount has to be paid by IIFL within 45 days. The penalty came after the SEBI's inspections of the books of account of IIFL for the period April 2011 to January 2017. It was found that IIFL had misused client funds in the range of Rs 0.59 crores to Rs 397.02 crores for settlement obligation of debit balance clients.
5. The amount of GST has been collected by the Govt in May 2022 is **Rs 1.41 lakh crore**.  
**Note:** The government has collected Rs 1,40,885 lakh crore Goods and Services Tax (GST) revenue for the month of May 2022. The numbers have been surged 44% as against Rs 97,821 during the corresponding period of preceding fiscal year.
6. **7.5%** would be the FY23 economic growth forecast by the SBI.  
**Note:** SBI Research has estimated the growth of the Indian economy at 7.5% in 2022-23, an upward revision of 20 basis points from its earlier estimate. According to the official data, the economy will grow by 8.7% in FY22, net adding ₹11.8 lakh crore in the year to ₹147 lakh crore.
7. **Rs 86,912 crore** has been released by the finance ministry to the states as part of the GST compensation dues.  
**Note:** The Centre has released the entire amount of GST compensation to states which were due up to May 31, 2022. Maharashtra has received the highest amount of GST compensation dues at Rs 14,145 crore, followed by Tamil Nadu (Rs 9,602 crore) and Uttar Pradesh (Rs 8,874 crore).
8. **RBI** has launched the 2021-22 round of its annual survey on "Foreign Liabilities and Assets of Mutual Funds and Asset Management Companies".  
**Note:** The survey collects information from mutual fund companies and asset management companies on their external financial liabilities and assets at the end of March of the latest financial year. The survey results are released in the public domain besides being used for the compilation of balance of payments statistics and other uses
9. **Tata Projects** has won the bid to build Jewar Airport.  
**Note:** It outbid the Shapoorji Pallinji Group and Larsen & Toubro for the contract. The new airport is expected to be functional by 2024.
10. **NABARD** has launched My Pad My Right programme in Leh.  
**Note:** This programme was launched by Nabard's NabFoundation with machinery and materials of a cost of Seven and half Lakh rupees. NABARD also sanction One lakh (addition) to upgrade the

machinery to make sanitary pads suitable to the demands of women of different age groups.

- 11. SBI General Insurance** has launched new health insurance vertical to focus on new innovative health products to boost customer experience.

**Note:** The company will manage in-house servicing of all health insurance claims to deliver a superior and hassle-free customer experience. The company has recorded a 50% growth in gross written premium in 2021-22.

- 12.** The Reserve Bank of India (RBI) has released the provisioning guidelines for outstanding loans extended by 'NBFC-Upper Layer', these guidelines shall be effective from **October 1, 2022**.

**Note:** Individual housing loans and loans to Small and Micro Enterprises (SMEs) : 0.25%. Housing loans extended at teaser rates: 2% (decrease to 0.4% after 1 year from the date on which the rates are raised.) Advances to Commercial Real Estate-Residential Housing (CRE - RH) Sector: 0.75%

- 13. Smarter Digital Payments** is the theme of The Reserve Bank of India (RBI) first global hackathon – “HARBINGER 2021 – Innovation for Transformation”.

**Note:** Tone Tag (brand of Naffa Innovations) has been declared the winner in two categories, first is 'Innovative, easy-to-use, non-mobile digital payment solutions' and second is 'Context-based retail payments to remove the physical act of payment'.

- 14. Airtel Payments Bank** has partnered with Muthoot Finance to offer gold loans.

**Note:** There will be no-processing charge on the loan. Muthoot Finance will provide up to 75% of the pledged gold value as a loan. The loan facility will be available at the 5 lakh banking points for Airtel Payments Bank.

- 15.** Indian telecommunications company, **Jio** becomes the first to provide 4G voice and data services at Spangmik village near Pangong lake in the Ladakh region.

**Note:** Lok Sabha member from Ladakh, Jamyang Tsering Namgyal has inaugurated the Jio mobile tower at Spangmik village. This launch will help to boost the economy of the region besides providing seamless connectivity to the tourists and the troops in the area.

- 16.** According to the recent projection of the World Bank, **7.5%** would be India's gross domestic product (GDP) forecast for the current fiscal year (2022-23).

**Note:** The World Bank has revised its GDP forecast for the second time. In April 2022, The World Bank

had reduced the forecast from 8.7% to 8%. In May 2022, Moody's Investors Service has cut the GDP projection to 8.8% for the calendar year 2022 from 9.1% earlier.

- 17.** After the revision of the repo rate by the Reserve Bank of India (RBI) on June 8, 2022, **4.90%** is the current repo rate.

**Note:** Earlier, the committee had raised rates by 40 basis points at an unscheduled meeting in May. RBI has also raised the inflation forecast to 6.7% for 2022-23 from an earlier estimate of 5.7%.

- 18. Mastercard** will power the "Apple Pay Later" service that would be launched by Apple, to offer the users to split the cost of a purchase.

**Note:** Apple Pay Later will offer the users to split the cost of a purchase made over Apple Pay into four equal payments over six weeks without any interest or late fees. This service will be available everywhere, Apple Pay can be accepted online or in-app by using the Mastercard network.

- 19.** Along with Indian Oil Corporation Limited and the National Payments Corporation of India (NPCI) **Axis Bank** has launched co-branded contactless credit card.

**Note:** The card offers: fuel surcharge waiver, cashback on fuel purchases, reward points, quick cinema ticket discounts etc.

- 20. NABARD** has launched the My Pad My Right programme in Leh.

**Note:** This programme was launched by Nabard's NabFoundation with machinery and materials of a cost of Seven and half Lakh rupees. NABARD also sanction One lakh (addition) to upgrade the machinery to make sanitary pads suitable to the demands of women of different age groups.

- 21. Tata Project** has won the bid to build the national capital region's new airport at Jewar.

**Note:** It outbid the Shapoorji Pallinji Group and Larsen & Toubro for the contract. Tata Projects, the infrastructure and construction arm of the Tata group, will construct the terminal, runway, airside infrastructure, roads, utilities, landside facilities and other ancillary buildings at the Noida International Airport.

- 22.** According to the OECD, after the revision of the growth rates in June 2022, **6.9%** would be India's economic growth has been projected by the OECD for 2022-23.

**Note:** OECD has also projected the growth for India is 6.2% in 2023. The Reserve Bank of India has also estimated the growth of the nation to 7.2%. The RBI has also raised the repo rate by 50 basis points (bps) to 4.9% in a bid to curb the soaring inflation in the country.

- 23.** After raising the limit for individual housing loans for Cooperative Banks by the RBI, **Rs. 50 lakh** is the new limit for the Rural Cooperative Banks for

individual housing loans with an assessed net worth less than ₹100 crores.

**Note:** The limits for Tier I /Tier II UCBs have been revised from ₹30 lakh/ ₹70 lakh to ₹60 lakh/ ₹140 lakh, respectively. RCBs the limits have been increased:- From ₹20 lakh to ₹50 lakh for RCBs with an assessed net worth less than ₹100 crore; From ₹30 lakh to ₹75 lakh for other RCBs.

24. Nirmala Sitharaman has recently launched EASE 5.0 under EASENext program. EASE reforms are focused on **Public Sector Banks**.

**Note:** EASE Agenda was launched in January 2018 jointly by government and PSBs. It was commissioned through Indian Banks' Association and authored by Boston Consulting Group. EASE 1.0 report showed significant improvement in PSB performance in resolution of NPA transparently.

25. **ICICI Bank** has partnered with ZestMoney to expand its 'Cardless EMI' facility for purchases at retail and e-commerce platforms.

**Note:** The partnership enhances the affordability of millions of customers of the bank who can use pre-approved cardless credit to instantly buy products/ services using ZestMoney and take care of the cost into EMIs. Customers can convert transactions up to Rs 10 lakh into EMIs by simply putting their registered mobile number, PAN and OTP.

26. Electric two-wheeler maker Ather Energy has partnered with **State Bank of India** for vehicle financing for its customers.

**Note:** The collaboration will enable Ather Energy's customers, having pre-approved loan offers from SBI, to avail instant loans at low interest rates starting from 9.55 per cent per annum, depending on customer credit profile. The vehicle loans can be availed through SBI's mobile app YONO as well as offline.

27. **Indian Bank** has launched its KCC Digital Renewal scheme, enabling eligible customers to renew their Kisan Credit Card accounts via digital modes.

**Note:** The initiative is part of the bank's digital transformation under project 'WAVE' - World of Advanced Virtual Experience. The account renewals can be done using Indian Bank's IndoASIS mobile app and internet banking.

28. META4 group is a company based in **UAE** that signed an MoU with the Telangana govt to set up an Electric Vehicle manufacturing plant with an investment of ₹250 crores in Zaheerabad, Telangana.

**Note:** As per the MoU, the Telangana govt will provide 15 acres of subsidized land in the National Investment and Manufacturing Zone, Zaheerabad. META4 has made this investment through Voltly Energy, which provides advanced EV 2-wheeler manufacturing and delivers energy-efficient EV charging solutions.

29. Bharat FIH has received market regulator SEBI's approval for an Initial Public Offering (IPO) aggregating to **Rs. 5,000 crores**.

**Note:** Bharat FIH is a subsidiary of FIH Mobile a leading manufacturing services provider for the mobile handset industry, which is a part of Foxconn Technology Group. The company makes devices for Xiaomi and Nokia.

30. Fintech startup, **XPay.Life** has launched its UPI services targeted at rural India.

**Note:** aim: to make financial facilities accessible for people in rural areas. The launch of its UPI services is expected to benefit XPay.Life's 4 mn consumers across more than 15 states and 1 lakh villages. XPay.Life along with NABARD, NPCI and the state govt working towards strengthening DB and payments by enabling the last mile link.

31. **OmniCard** became 1st RBI licensed PPI to launch cash withdrawal using a RuPay-powered card from any ATMs across the country.

**Note:** The move came in after RBI permitted the non-bank licensed entities to enable cash withdrawals from the digital wallets. **OmniCard** users can withdraw cash from any ATM at their convenience with full security from frauds like card theft, card cloning, and PIN skimming. The company is working with **NPCI** to enable the facility.

32. According to the Reserve Bank of India (RBI), **More than 4.11 lakh** PoS, mobile PoS and other physical devices were deployed across the country under the Payments Infrastructure Development Fund (PIDF) scheme as on April 30, 2022.

**Note:** Besides, 1,14,05,116 digital devices, including inter-operable QR code-based payments such as UPI QR, Bharat QR, were deployed under the scheme. The PIDF scheme, operationalised by the Reserve Bank from January 2021, subsidises deployment of Points of Sale (PoS) infrastructure (physical and digital modes) in tier-3 to tier-6 centres and northeastern states of the country.

33. According to the report "Digital payments in India: A \$10 trillion opportunity" unveiled by PhonePe, India's digital payments market is expected to increase more than threefold from the current US\$3 trillion to US\$10 trillion by **2026**.

**Note:** India's leading digital payments company, PhonePe in collaboration with Boston Consulting Group (BCG), unveiled a report titled, "Digital payments in India: A \$10 trillion opportunity". This would translate to digital payments (non-cash) constituting 2 out of 3 payment transactions by 2026.

34. **Airtel Payments Bank** has partnered with Muthoot Finance to offer gold loans through the bank's app.

**Note:** With this partnership, Airtel Payments Bank customers can get hassle-free gold loans with Zero

processing fees from Muthoot Finance. There will be no-processing charge on the loan and Muthoot Finance will provide up to 75 percent of the pledged gold value as a loan. The partnership will give access to secured and affordable credit to customers looking for quick liquidity against their gold assets.

- 35. Adani Group** has agreed to invest \$50 billion over the next 10 years in India to produce green hydrogen with TotalEnergies SE.

**Note:** TotalEnergies will buy 25% in a new clean energy company, Adani New Industries Ltd, a unit of Adani Enterprises Ltd, to jointly build the world's biggest green hydrogen ecosystem. In the initial phase, Adani New Industries will develop a green hydrogen production capacity of 1 million tonnes per annum by 2030.

- 36. Financial wellness platform CASHe** has launched an industry-first credit line service using its AI-powered chat capability on WhatsApp.

**Note:** Aim: to provide customers with a fast, seamless and convenient way to access instant credit line by merely typing their name. CASHe's WhatsApp chat service is built on the WhatsApp Business Platform.

- 37. 7.04%** is the retail inflation based on the Consumer Price Index in May 2022.

**Note:** As the Food and Beverages have a weightage of more than 54% in CPI, the dip in food prices contributed the most to the ease in inflation. Rural inflation lowered to 7.01% in May as compared to 8.38% in April.

- 38. HDFC Bank** has signed an MoU with 100X.VC to enhance its engagement with the start-up ecosystem in the country.

**Note:** The bank will also assess start-ups for investment and loan extension opportunities which are recommended by 100X.VC.

- 39. New Development Bank (NDB)** has signed BRICS Partnership on New Industrial Revolution (PartNIR) Innovation Center to facilitate bilateral cooperation and promote the common development of BRICS countries.

**Note:** The MoU was signed at a meeting held via video link in the port city of Xiamen, East China's Fujian Province. BRICS is the acronym for Brazil, Russia, India, China and South Africa.

- 40. An exclusive savings account for kids ENJOI** was launched by the Equitas Small Finance Bank.

**Note:** The ENJOI allow kids of 0-18 years to open savings accounts under the supervision of their

parents. The bank offers 7% interest for savings balances between ₹5 lakh to ₹2 crore.

- 41. The Reserve Bank of India (RBI)** lifted the restrictions imposed on **Mastercard** on June 16 citing improvement compliance.

**Note:** The RBI had imposed restrictions on Mastercard Asia/Pacific Pte. Ltd. from on-boarding new domestic customers (debit, credit or prepaid) onto its card network from July 22, 2021. Reason of restriction: For non-compliance with the RBI circular dated April 6, 2018, on Storage of Payment System Data.

- 42. Tamil Nadu** has replaced West Bengal to become the largest state in terms of the outstanding portfolio of microfinance loans.

**Note:** It was followed by Bihar (₹35,941 crores) and West Bengal (₹34,016 crores). The gross loan portfolio of Tamil Nadu as of March 31, 2022 stood at ₹36,806 crore, as per the MFIN Micrometer Q4 FY21-22, a quarterly report published by Microfinance Institutions Network.

- 43. Canara, HSBC, and Oriental Bank of Commerce Life Insurance** have rebranded and renamed itself as Canara HSBC Life Insurance. The HQ of Canara Bank is located in **Bengaluru**.

**Note:** They launched its first brand campaign #PromisesKaPartner aligned to its new positioning - 'Powering India to re-imagine their dreams and aspirations.

- 44. By the year 2025, RBI** increase the number of digital payment transactions by more than 3X and to curb the volume of cheque-based payments to less than 0.25% of total retail payments.

**Note:** Core theme of vision documents: E-Payments for Everyone, Everywhere, Everytime (4Es). It covers 47 specific initiatives and 10 expected outcomes

- 45. After revising the Additional Factor of Authentication (AFA) limit for e-mandates on cards, Prepaid Payment Instruments (PPIs), and UPI for recurring transactions by RBI Rs 15,000 per transaction** is the new limit.

**Note:** An e-mandate means, that the cardholder gives a standing instruction to the merchant platform to deduct a certain amount of money for recurring transactions.

- 46. Fitch Ratings** has revised the rating outlook of nine Indian banks which include SBI, ICICI Bank and Axis Bank, from negative to stable.

**Note:** The other banks are: Bank of Baroda (BOB), Bank of Baroda (New Zealand) Ltd, Bank of India,

Canara Bank, Punjab National Bank (PNB) and Union Bank of India.

**47. Kotak Mahindra** has partnered with PhonePe Insurance Broking Services Pvt. Ltd (PhonePe) to offer motor insurance on the PhonePe platform.

**Note:** With the help of this platform, Kotak General Insurance will provide quick and seamless car and two-wheeler insurance policies to its customers.

**48.** Along with ICICI Bank and HDFC Bank, **NPCI** has been identified as a 'critical information infrastructure' by the Union Ministry of Electronics and IT (MeitY).

**Note:** The government has the power to declare any data, database, IT network or communications infrastructure as CII to protect that digital asset as per the IT Act of 2000. Any person who secures access to a protected system in violation of the law can be punished with a jail term of up to 10 years.

**49. Open Network for Digital Commerce** has joined hands with National Bank for Agriculture and Rural Development (NABARD) to activate e-commerce in the agriculture domain.

**Note:** ONDC and NABARD have come together to host the NABARD-ONDC Grand Challenge to establish market linkages for the enabled players with market-ready Farmers Producers Organisations. Aim: To promote the development of innovative solutions that are likely to aid the adoption of e-commerce in the agriculture domain.

**50. The Life Insurance Corporation of India (LIC)** has launched Dhan Sanchay, a non-linked, non-participating, individual savings life insurance plan.

**Note:** This plan offers financial assistance to the family in the event of the life assured's untimely death within the policy's term. It also offers a guaranteed income stream from the date of maturity until the end of the payout period.

**51.** PVR and INOX Leisure have received clearances for their merger from **NSE and BSE**.

**Note:** In March 2022, both multiplex operators announced the merger to create the largest multiplex chain in the country. The company received an observation letter with 'no adverse observations' from BSE Ltd on June 20, 2022, and an observation letter with 'no objection' from NSE on June 21, 2022.

**52. SBI** will collaborate with the Government's Department of Pension & Pensioners' Welfare (DoPPW) to create an integrated pension portal.

**Note:** It helps to enhance the ease of living of pensioners. It was decided during the special session, that immediate effort are needed for the

creation of a pension portal by linking the existing portals of the DoPPW and the SBI.

**53.** Under the chairmanship of **KV Kamath**, the Securities and Exchange Board of India (SEBI), has set up a 20-member advisory committee, which recommends a fillip to the growth of such instruments, including measures focusing on ease of issuance and attracting domestic and global capital.

**Note:** Sebi has reconstituted its research advisory committee of 16 members, chaired by V Ravi Anshuman.

**54. October 1, 2022** is the new timeline recommended by the RBI for implementation of a few provisions under its master directions on credit card and debit card issuance.

**Note:** Provisions: Card issuers shall seek OTP-based consent from the cardholder for activating a credit card, If consent is not received then card issuers shall close the credit card account without any cost.

**55. South Indian Bank** has launched a new portal for its corporate EXIM customers named 'SIB TF Online'.

**Note:** This portal provides a platform for trade-related payments to foreign entities remotely. Through this portal, customers can initiate the payment request on SIB TF Online, after uploading the relevant documents for the transaction.

**56. YES Bank** has joined hands with CARD91 and RuPay, to create a card management system that will allow companies to launch a variety of co-branded card instruments.

**Note:** This will enable CARD91 to expand its presence in the Indian payments market. CARD91 is a global payment infrastructure powering B2B payments. It was designed to help businesses launch co-branded cards and simplify payments.

**57.** Max Life Insurance Company Ltd has launched the 'Max Life Smart Fixed-return Digital Plan' with **Policybazaar**.

**Note:** It is a non-linked, non-participating, individual life insurance savings plan. This plan helps customers to meet their short-term financial goals. The plan also offers guaranteed tax-free returns up to 6.14%. Monthly premiums: ₹3000; Minimum tenure: five years

**58.** In association with **Equitas Small Finance Bank**, Freo has launched a digital savings account offering 'Freo Save'.

**Note:** With this launch, Freo has become the first consumer neobank in the country to provide full-stack neo-banking products. It includes smart

savings account, credit and payments products, cards and wealth-growth products.

**59. AU Bank LIT (Live-It-Today)** the customised Credit Card, launched by AU Small Finance Bank.

**Note:** This credit card offers a unique value proposition to cardholders. Cardholders can choose the features and time period according to their wish. Through the AU0101 app, cardholders can track their saving/earnings daily to maximize their benefits.

**60. Liberty General Insurance** has signed an agreement with **Peerless Financial Products Distribution Ltd (PFDDL)** distribution company to enable the distribution of Liberty's retail and commercial line of products.

**Note:** The product distribution across the country will be done through the 42 branches of Peerless. Liberty is working closely with PFDDL to provide training and operational expertise.

**61. Karnataka Bank** has launched the 'Video-based Customer Identification Process (V-CIP)'.

**Note:** It is an online savings bank (SB) account opening facility. This facility will enable the corporate website of the bank, to strengthen the prospective customers to open an SB account through the online process and complete KYC verification through a video call. This is an end-to-end paperless digital process.

**62. Uttarakhand's** rain-fed agriculture in the steep areas project has been approved by the World Bank, cost Rs. 1,000 crore.

**Note:** The watershed department will carry out the Uttarakhand Climate Responsive Rain-fed Farming Project. Aims: Lower the greenhouse gas emissions. It will also encourage environment-friendly agricultural practices.

**63. The World Bank** has approved a loan of **\$ 245 Million** to the Indian Railways to reduce the India's high carbon emissions and low modal freight share in the railways.

**Note:** The Indian Railway project will help India to shift more traffic from road to rail. This will make transport more efficient and reduce tonnes of greenhouse gas emissions each year. This loan is financed through the International Bank for Reconstruction and Development with a maturity of 22 years.

**64. ICICI Bank** has launched a digital platform called 'Campus Power'.

**Note:** Aim: To help students aspiring to pursue higher education in India and outside the country. This platform will cater the varied needs of the

entire student ecosystem comprising students, parents, and institutes.

**65. Zomato** online food delivery platform has announced to acquire Blinkit, which was earlier known as Grofers, in an all-stock deal of Rs 4,447 crore.

**Note:** Zomato would acquire up to 33,018 equity shares of Blink Commerce Pvt Ltd. The total purchase consideration of Rs 4,447.48 crore at a price of Rs 13.45 lakh per equity share. Last year, Zomato had bought a 10% stake in Blinkit for about \$100 million.

**66. Mufin Finance** has received in-principal RBI approval for issuance of semi-closed prepaid payment instruments.

**Note:** This PPI licence will allow digital banks, fintech firms and large consumer-facing applications to roll out features such as digital payment solutions for lending. It is the fourth NBFC to receive such a licence from the RBI Other three: **Bajaj Finserve, Manapurram and Paul Merchants.**

**67. Acemoney** fintech service has launched UPI 123Pay payment and wearable ATM cards.

**Note:** UPI 123Pay: Allow people to carry out cashless transactions without smartphones or internet connections by using feature phones only. Wearable ATM cards: It is designed as key chains and rings that allows people to carry out cashless transactions without ATM cards and phones. Acemoney is India's first company to launch UPI 123Pay services in Malayalam and Tamil.

**68. Kerala Financial Corporation** has raised the upper loan limit of loans under the Chief Minister's Entrepreneurship Development Programme (CMEDP) to ₹2 crore.

**Note:** Aim: More MSMEs can get funds at a concessional 5% interest rate. The Kerala government will provide a subsidy of 3% with the Corporation chipping in with 2% towards the effective interest rate. The age limit set by Govt for SC/ ST entrepreneurs, women entrepreneurs and non-resident Keralites is 55 years.

**69. As per the Goods and Services Tax (Period of Levy and Collection of Cess) Rules, 2022,** has been notified by the finance ministry that the government has extended the time for levy of GST compensation cess by nearly 4 years till **March 31, 2026.**

**Note:** The levy of cess was about to end on June 30. The revenue from the GST compensation cess is used to pay for the borrowings and arrears of

compensation paid to states in the last two financial years.

He belonged to north Kashmir's Sopore district and came from the 'Sufiana Gharana'.

**11. Pallonji Mistry, who passed away was a Chairman of Shapoorji Pallonji group.**

**Note:** In 2022, Pallonji Mistry stands at rank 125 while he was the ninth richest Indian person as of 2021, as per the Forbes Billionaires List. He has been conferred with the Padma Bhushan (2016).

He was the largest individual shareholder in the Tata Group with a 18.4% holding.

**12. Varinder Singh, who passed away was related to sports of Hockey.**

**Note:** He was an integral part of the gold-medal-winning Indian team at the 1975 men's Hockey World Cup in Kuala Lumpur. He was also a part of the bronze medal-winning team at the 1972 Munich Olympics and the silver medal at the 1973 World Cup in Amsterdam. He has been conferred with the prestigious Dhyana Chand Lifetime Achievement Award in 2007.

3. The World Food Safety Day is observed annually on **June 7** to raise awareness of the health hazards associated with unsafe food, and to highlight the significance of hygiene in daily life.  
**Note:** Theme 2022: 'Safer food, better health'. This day was marked by the United Nations General Assembly (UNGA) on December 20, 2018.
4. World Brain Tumour Day is observed every year on **8th June**.  
**Note:** It is a mass or growth of abnormal cells in your brain. There are two types of brain tumors, noncancerous (benign), and cancerous (malignant). The day also pays tribute to brain tumour patients, their families and healthcare professionals.
5. **Revitalization: collective action for the ocean** is the theme of World Oceans Day 2022 which is observed annually on June 8.  
**Note:** World Oceans Day is observed on June 8 every year to raise the awareness among people of the importance of the oceans and the major role they play in everyday life. The World Oceans Day concept was first proposed by the UN in 1992 at the Earth Summit in Rio de Janeiro.

8. **United in making our voice heard** is the theme of International Albinism Awareness Day 2022.  
**Note:** International Albinism Awareness Day (IAAD) is annually observed on 13th June, representing the importance and celebration of human rights of people with albinism.
9. **Universal Social Protection to End Child Labour** is the theme of World Day Against Child Labour' 2022.  
**Note:** The United Nations observes the 12th of June every year as the 'World Day Against Child Labour' to bring attention to the evil practices of child labour across the world. International Labour Organization (ILO) launched this day in 2002 to tackle this global issue against child labour.
10. International Albinism Awareness Day is observed by the United Nations every year on **13th June**.  
**Note:** The day represents the importance and celebration of human rights of people with albinism. The United Nations Human Rights Council adopted this resolution and put its firm foot down for the prevention of attacks and discrimination against

people with albinism. This day is mandated to remind people of the perils of the past and the path to the future in the case of albinism and the people living with it.

- 11. Donating blood is an act of solidarity** is the theme of the World Blood Donor Day 2022.

**Note:** World Blood Donor Day is observed on 14 June every year to spread awareness regarding the need for “safe blood and blood products for transfusion”. The host nation for World Blood Donor Day 2022 is Mexico. The WHO initiated and declared June 14, the birth anniversary of Karl Landsteiner, as WBD in 2004.

- 12. World Wind Day, also known as Global Wind Day, is observed on 15th June.**

**Note:** Wind Europe (Brussels) initiated the Global Wind Day in 2007. Global Wind Day 2022 is based on the theme is celebrate to enjoy the benefits of Wind energy and providing education to individuals about the power and potential of wind energy to change the world.

- 13. World Elder Abuse Awareness Day is observed on June 15.**

**Note:** To raise awareness about abuse and neglect of older persons. This year’s theme of World Elder Abuse Awareness Day 2022 is “Combatting Elder Abuse”.

- 14. National Reading Day is observed annually on 19 June.**

**Note:** Observed in honour of P N Panicker who is considered as the Father of Kerala’s Library and Literacy Movement. This day was first celebrated on June 19, 1996, by the Government of Kerala in association with the P N Panicker Foundation, National Reading Day, became a mass movement to promote literacy and the culture of reading in the state.

- 15. World Refugee Day is observed annually on June 20** date to highlight the difficulties faced by refugees.

**Note:** 2022 theme: Whoever, Whatever, Whenever. Everyone has a right to seek safety.

- 16. The International Day for the Elimination of Sexual Violence in Conflict is an international event conducted by the United Nations (UN) on June 19.**

**Note:** The theme 2022: ‘Prevention as Protection: Enhancing structural and operational prevention of conflict-related sexual violence.’

- 17. The world observes Sustainable Gastronomy Day is observed on 18 June.**

**Note:** The objective of this day is to recognize the practices associated with sustainable food consumption, especially with the art of collecting and preparing the food we eat.

- 18. International Day for Countering Hate Speech falls on June 18.**

**Note:** In July 2021, the UN General Assembly highlighted global concerns over “the exponential spread and proliferation of hate speech” around the world and adopted a resolution on “promoting inter-religious and intercultural dialogue and tolerance in countering hate speech”.

- 19. The World Day to Combat Desertification and Drought is observed on 17 June** each year to promote public awareness of international efforts to combat desertification.

**Note:** The theme of 2022 Desertification and Drought Day “Rising up from drought together”.

- 20. The International Day of Family Remittances (IDFR) was adopted by the United Nations General Assembly and is observed on 16 June.**

**Note:** Theme 2022: recovery and resilience through digital and financial inclusion.

- 21. The 8th edition of International Day of Yoga is being observed on 21st June.**

**Note:** Aim: To raise awareness worldwide of the many benefits of practicing yoga. 2022 theme: ‘Yoga for Humanity’. PM Modi will lead the mass Yoga demonstration at Mysuru in Karnataka.

- 22. International Olympic Day is observed annually on June 23** across the world to commemorate the birth of modern Olympic games.

**Note:** The International Olympic Committee (IOC) was founded on 23 June 1894. The theme for the International Olympic Day 2022 is “Together For A Peaceful World”.

- 23. UN Public Service Day is observed on June 23** with the aim to appreciate the value of public institutions and public servants.

**Note:** The 2022 theme: “Building back better from COVID-19: Enhancing innovative partnerships to meet the Sustainable Development Goals.”

- 24. The International Maritime Organization (IMO) is observed the International Day of Seafarer annually June 25** to pay respect to Seafarers and sailors who help the entire world function by conducting sea transport.

**Note:** This day was proposed by International Maritime Organization in 2010. This day recognizes the invaluable contribution of seafarers to the worldwide commerce and economic system. 2022 theme: Your voyage – then and now, share your adventure.

25. The International Day against Drug Abuse and Illicit Trafficking is observed on **June 26**.

**Note:** Aim: To spread awareness about the physical and psychological impact of substance abuse, drug overdose deaths. The theme 2022: Addressing drug challenges in health and humanitarian crisis. In 2022, the UNODC has started the campaign - “#CareInCrises” - for World Drug Day.

26. The International Day in Support of Victims of Torture is observed annually on **June 26**.

**Note:** Aim: to promote the abolition of torture, support victims, and promote human rights. The United Nations General Assembly passed a resolution on December 12, 1997. Presently, the Convention has been ratified by 162 countries.

27. The World Micro, Small, and Medium Enterprises (MSME) Day is observed annually on **June 27** to recognize the contribution of these industries in the implementation of the Sustainable Development Goals (SDGs).

**Note:** Theme 2022: Resilience and Rebuilding: MSMEs for Sustainable Development. The United Nations General Assembly (UNGA) has marked the

first World MSME Day by 74th Plenary on April 6, 2017. MSME minister: Narayan Rane

28. Union Government has observed National Statistics Day on **29th June** every year to mark the birth anniversary of late Professor Prasanta Chandra Mahalanobis.

**Note:** Since 2007, this day is observed in recognition of his valuable contribution in the field of Economic Planning and Statistics. Theme 2022: Data for Sustainable Development.

29. International Day of the Tropics is observed annually on **29 June**.

**Note:** This day highlights the challenges faced by the tropic’s nations. The tropics nations are those that lies between the Tropic of Capricorn and the Tropic of Cancer.

30. World Asteroid Day is observed annually on **June 30** to raise the awareness about the asteroid hazardous impact.

**Note:** In December 2016, UNGA has adopted resolution A/RES/71/90 to declare 30 June International Asteroid Day. This day marked the anniversary of the Tunguska impact over Siberia, Russian Federation, on 30 June 1908.

- 22. Justice Vipin Sanghi** will be appointed as the Chief Justice of **Uttarakhand HC**.  
**Note:** Justice Rashmin M Chhaya of the as the Chief Justice of the Gauhati High Court. Telangana Chief Justice, Satish Chandra Sharma will be appointed to the Delhi HC. Justice Amjad A Sayed and Justice SS Shinde will be elevated as the Chief Justice of the Himachal Pradesh HC and Rajasthan HC respectively. - 24. Ruchira Kamboj** has been appointed as the Permanent Representative of India to UN.  
**Note:** She will replace T S Tirumurti. She has joined the Indian Foreign Service (IFS) in 1987, was the All India women's topper of the 1987 Civil Services batch and the topper of the 1987 Foreign Service batch.
- 25. Minerva Punjab FC, Ranjit Bajaj** has been appointed as the chairperson of the 12-member committee formed by the Committee of Administrators (CoA).  
**Note:** The CoA took charge of the AIFF, after the Supreme Court removed the Praful Patel led office bearers for not holding elections on time. Aim: To look the day-to-day matters of various departments of the All India Football Federation (AIFF).

**Note:** Aim: To measure the performance of states across five parameters. Tamil Nadu topped the list among large states followed by Gujarat and Maharashtra. Smaller states: Goa(1st) followed by Manipur and Sikkim. UTs: Jammu & Kashmir, Delhi and Chandigarh
11. In **Goa**, Finance Minister Nirmala Sitharaman inaugurates "Dharohar - the National Museum of Customs and GST".  
**Note:** Union Finance Minister Nirmala Sitharaman has inaugurated "Dharohar - the National Museum of Customs and GST" in Panaji Goa. It is a two-storey 'Blue building', which was earlier known as Alfandega, during Portuguese rule in Goa and has been standing on the banks of Mandovi River in Panaji for more than 400 years.
12. Prime Minister Narendra Modi has inaugurated Jagatguru Sreesanth Tukaram Maharaj Shila Mandir in **Maharashtra**.  
**Note:** He will inaugurate Jagatguru Sreesanth Tukaram Maharaj Shila Mandir at Dehu near Pune. The city of Dehu is sanctified by the Jagadguru Sant Tukaram Maharaj, a renowned poet and worshipper of Lord Vithala, from 17th century.
13. **Himachal Pradesh** becomes the first Indian state to approve a policy for drones.  
**Note:** The 'Himachal Pradesh Drone Policy 2022' was approved by the chief minister Jai Ram Thakur.  
  
The policy envisions creating a holistic drone ecosystem built upon the foundation of Governance and Reforms Using Drones (GARUD). With this new drone policy, Himachal Pradesh has become the first state in the country to formally acknowledge the public use of drones.
14. **Tamil Nadu** state has launched the Ennum Ezhuthum scheme to bridge the learning gap that was created due to the COVID-19 pandemic among students aged below eight.  
**Note:** Aim: To ensure foundational literacy and numeracy by 2025. Under this programme, the education department of state will provide workbooks to students from Classes 1 to 3.
15. **Gujarat** state has become the first state in the nation to launch 'Balika Panchayat' with an aim to strengthened girl power in the state.  
**Note:** This unique initiative was started in several villages of Gujarat's Kutch district. This initiative was started by the Women and Child Development Welfare department of the Gujarat Government under the 'Beti Bachao Beti Padhao' campaign.
16. The three days international literary festival "Unmesh" was held in **Shimla, Himachal Pradesh**.  
**Note:** This festival was organised by the Union Ministry of Culture and the Sahitya Akademi in association with the state Department of Art and Culture. The festival was inaugurated by Minister of State for Culture, Arjun Ram Meghawal.
17. PM Narendra Modi has launched Mukhyamantri Matrushakti Yojana in **Gujarat government** under its Integrated Child Development Services, Poshan Abhiyan.  
**Note:** The scheme will cover 7 lakh women to deal with the dietary deficiency within the first 1,000 days of the conception of a child. The scheme will also distribute 2 kg chickpeas, 1 kg toor daal and 1 litre fortified ground nut oil.
18. **Andhra Pradesh** state government has signed an MoU with BYJU's to provide quality education to government school students.  
**Note:** The government will provide tablets to 4.7 lakh (approximately) students of class VIII at an estimated cost of Rs 500 crore. Aim: More efficient, quality-oriented and presentable
19. **Assam** state government has operationalised the Centre's 'One Nation, One Ration Card' programme, with this, it is implemented across the country.  
**Note:** Beneficiaries can get their quota of subsidised foodgrains from any electronic point of sale device

(ePoS)-enabled fair price shops. Beneficiaries can use their existing ration cards with biometric authentication.

- 20. Gujarat** state government has launched the 17th 'Shala Praveshotsav'.

**Note:** To increase the enrollment of students in primary schools in the state. This is a three-day enrollment drive, starts from Memadpur primary school in Vadgam taluka (Banaskantha district).

- 21. Indira Gandhi International Airport** has become India's first airport to run entirely on hydro and solar power since June 1.

**Note:** Presently, the airport met its electricity requirement of 6% (approx) from onsite solar power plants and rest 94% by hydropower plants. Delhi Airport has signed a power purchase agreement with Himachal Pradesh to supply hydroelectricity for the airport until 2036.

- 22. Maharashtra** state energy department has signed an MoU with Adani Green Energy Group Ltd (AGEL) to generate green power.

**Note:** It would require an investment of Rs 60,000 crore and generate employment. AGEL will set up Pumped Storage Projects (PSP) in the next five years and will produce 11,000 MW power.

- 23. Karnataka** state government has launched the 'Kashi Yatra' project.

**Note:** It offers cash assistance of ₹5,000 to each pilgrims, take up a pilgrimage to the Kashi Vishwanath Temple in Varanasi, Uttar Pradesh. The government will be using funds of up to ₹7 crores from the accounts head of 'Assistance to Manasa Sarovara Pilgrims'.

- 24. Kerala** state government will launch the MEDISEP scheme - Medical insurance scheme for State Government employees, pensioners and their eligible family members from 1st July, 2022.

**Note:** It will provide cashless medical assistance with a comprehensive coverage up to 3 lakhs per year. The annual premium would be Rs 4,800 plus 18% GST for the policy period of 2022-24. Monthly premium: Rs.500

- 25. Telangana CM, K Chandrashekhara Rao** has inaugurated the T-Hub 2.0, nation's leading innovation and startup catalyst.

**Note:** This facility will support over 2000 startups under one roof, with a total built-up area of 5,82,689 sq. ft, making it the world's largest innovation campus. With the help of this hub, young Indians launch their startups with a collaborative innovation ecosystem.

### Important News – World

- 1. Israel** has signed a free trade deal with the United Arab Emirates on May 31, its first with an Arab country.

**Note:** The agreement helps to increase bilateral trade in goods and services, increase Israeli exports to UAE. The UAE was the first Gulf country to normalise ties with Israel and only the third Arab nation to do so after Egypt and Jordan.

- 2. Bangladesh** has become the top recipient of Covid-19 vaccine doses with the delivery over 190 million doses of vaccines under UNICEF's COVAX programme.

**Note:** COVAX is a global initiative which is led by the Coalition for Epidemic Preparedness Innovation, Gavi, the Vaccine Alliance, and the World Health Organization with UNICEF. Under the COVAX programme, more than 62% of the doses has been delivered to Bangladesh.

- 3.** To mark the diplomatic ties of 30 years, **Israel** has adopted a "vision statement" with India to strengthen the defence cooperation in future.

**Note:** During the bilateral meeting between the Union Defence Minister Rajnath Singh and his Israeli counterpart Benny Gantz, leaders discussed defence cooperation and the prevailing global and regional scenario. Benny Gantz has been honoured with a Tri-Service Guard of Honour in the presence of Rajnath Singh.

- 4.** After the United Nations has approval **Türkiye** is the new name of Turkey.

**Note:** The country has begun the move to change its internationally recognised official name in English to Türkiye in December. The move comes after Turkish President Recep Tayyip Erdogan has released a memorandum and asked the public to use Türkiye to describe the country in every language.

- 5. 42nd** is the rank of the Indian Institute of Science (IISc), Bangalore in The Times Higher Education (THE) 2022 edition of the Asia University Rankings.

**Note:** China's Tsinghua and Peking universities placed first and second place respectively. India

being the third most-represented country with 71 universities making it to the list, behind China (97) and Japan (118).

- 6. Organisation for Economic Co-operation and Development (OECD)** has released a report which states that the global usage of plastic is set to increase by three times by the year 2060.

**Note:** The world that is destroy by severe plastic pollution, has need to take up several measures to combat the the use of plastic. Currently, nearly 100 million tonnes of plastic waste is either mismanaged or allowed to leak into the environment.

- 7. RIL Chairman and MD, Mukesh Ambani** has regained the position of India as well as Asia's richest man after replacing Adani Group Chairman, Gautam Adani, according to Bloomberg Billionaire Index.

**Note:** The net worth of Mukesh Ambani has risen to \$99.7 billion, while Gautam Adani's net worth stood at \$98.7 billion. Mukesh Ambani is ranked the eighth richest person in the world as per the Bloomberg Billionaire index.

- 8. AMBER alerts** feature will be launched by Instagram in 25 countries to help in finding the missing child.

**Note:** With the help of this alerts, users will get notifications of missing children in the area. This feature was already available on Facebook and helped to find hundreds of children since it was introduced in 2015. This was developed in partnership with the National Center for Missing & Exploited Children in US and International Centre for Missing & Exploited Children.

- 9.** By the year **2035**, European Parliament Members have voted to ban the sale of new petrol and diesel cars.

**Note:** Aim: To fight against climate change. The EU assembly voted in Strasbourg, France to require automakers to cut carbon-dioxide emissions by 100% by the middle of the next decade. The mandate would amount to ban on the sale in the EU nations of new cars powered by gasoline.

- 10. Sri Lanka** will receive the humanitarian assistance of \$48 million from the United Nations in June 2022.

**Note:** India has already provided financial assistance worth over \$3 billion since January to provide essential items, including food, fuel, cooking gas, and medicines. Sri Lanka needs \$6 billion to keep the country afloat for the next six months, adding that \$5 billion is required to ensure day-to-

day living and another \$1 billion to strengthen the Sri Lankan rupee.

- 11. India** will host special ASEAN Foreign Ministers' meet 2022.

**Note:** It will be the first meeting hosted by India in New Delhi. ASEAN members: Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Philippines, Singapore, Thailand, and Vietnam

- 12. USA** is the top recipient of FDI as per the UNCTAD's World Investment Report 2022.

**Note:** In its latest World Investment Report released on Thursday, UNCTAD said FDI inflows into India declined to \$45 billion in 2021 from \$64 billion in the preceding year. While the USA (\$367 billion) remained the top recipient of FDI, China (\$181 billion) and Hong Kong (\$141 billion) also retained second and third position respectively.

- 13. UNGA** has adopted an India-sponsored resolution on multilingualism that mentions the Hindi language for the first time.

**Note:** The resolution urges United Nations to continue spreading vital communications and messages in both official and non-official languages, including Hindi.

- 14.** The twelfth WTO Ministerial Conference is being held in **Geneva, Switzerland**.

**Note:** The twelfth WTO Ministerial Conference is being held in Geneva, Switzerland from 12th to 15th June 2022. Key areas: WTO's response to the pandemic, Fisheries subsidies negotiations and Agriculture issues including Public Stockholding for Food security.

- 15. China** has released a new geological map of the moon, which it says is the most detailed to date.

**Note:** The new map, which has details of craters and structures not charted before, will assist in further research of the moon. USGS Astrogeology Science Centre had, for the first time, mapped and classified the entire lunar surface in collaboration with NASA and the Lunar Planetary Institute in 2020.

- 16. Central African Republic** has become the 2nd country in the world to adopt bitcoin as its official currency, after El Salvador.

**Note:** The CAR is the first country in Africa to adopt Bitcoin as legal tender. This move places the Central African Republic on the map of the world's boldest and most visionary countries. Currently, The country uses the French-backed CFA franc as its currency, along with most other former French colonies in Africa.

- 17. Google** company has announced a program for women founders, 'startup accelerator program', which will help them address challenges such as fundraising and hiring.

- Note:** The first batch of the Google for Startups Accelerator India – Women Founders will enroll up to 20 women-founded co-founded startups in the country, and support them through a three-month program. The selected Startups will receive support and mentorship around AI/ML, Android, Web, Product Strategy and Growth.
- 18. Japanese Prime Minister Fumio Kishida** will attend North Atlantic Treaty Organization (NATO) summit, which will be held in Madrid and becomes the Japan's first leader to join NATO summit.  
**Note:** Sweden and Finland will also send delegations to the summit and South Korea's new President Yoon Suk-yeol will also become the first leader from his country to join the meeting.
- 19. Kerala** state of India has been ranked as the best in Asia and fourth in terms of Affordable Talent, as per the Global Startup Ecosystem Report (GSER).  
**Note:** Bengaluru city, has been moved up to number 22 in the ranking. The report also showed that the Bengaluru's tech ecosystem value is at \$105 billion which is higher than that of Singapore at \$89 billion and Tokyo at \$62 billion. Top five: Silicon Valley, followed by New York City, London, Boston, and Beijing.
- 20. Globally India's** ranked **68th** in the Coursera latest Global Skills Report (GSR) 2022.  
**Note:** In Asian countries, India stands at the 19th position. West Bengal leads the Indian states in terms of skills proficiency. For the second consecutive year, Switzerland had the highest-skilled learners followed by Denmark, Indonesia, and Belgium.
- 21. India's** rank in the REN21 Renewables 2022 Global Status Report (GSR 2022) is **third**.  
**Note:** India's total renewable power capacity additions in 2021 was 15.4 GW. Top performer of the report: China (136 GW) and US (43 GW). India installed 843 MW of hydropower capacity in 2021, brings the overall capacity to 45.3 GW.
- 22. Khuvsgul Lake National Park of Mongolia** has been added to the World Network of Biosphere Reserves of UNESCO.  
**Note:** This decision was made during the 34th session of the International Co-ordinating Council of the Man and the Biosphere Programme taking place in Paris, France.
- 23. The 12th Ministerial Conference (MC12) of the World Trade Organisation** concluded on 16th June 2022 in **WTO headquarters in Geneva**.
- Note:** The Conference was co-hosted by Kazakhstan and chaired by Mr Timur Suleimenov (Deputy Chief of Staff of Kazakhstan's President).
- 24. Australia** has announced to provide 50 million US dollars support to Sri Lanka for meet urgent food and health care needs.  
**Note:** Presently, Sri Lanka is facing its worst economic crisis in 70 years, which leads to food shortage, medicine and fuel. Australia will provide 22 million dollars to the World Food Programme (WFP) for emergency food assistance to meet their daily nutritional needs and 23 million dollars in development assistance to Sri Lanka in 2022-23.
- 25. TCS, HDFC Bank, Infosys and LIC** four Indian companies have been featured in the top 100 global biggest brands, along with companies like Apple, Google, Amazon and Microsoft.  
**Note:** TCS has been placed on the 46th spot of the list with an estimated of \$50 billion by Kantar Brands 2022. HDFC Bank placed on 61st with \$35 billion brand value. Infosys was ranked at 64th position and LIC placed on 92nd. Top 10: Apple, Google, Amazon, Microsoft, Tencent, McDonalds, Visa, Facebook, Alibaba, Louis Vuitton.
- 26. Sri Lanka** has raised the Minimum Age for women Migrant Domestic Workers to 21 years.  
**Note:** The Cabinet of Ministers has also granted permission to revise the age limit, after considering the recommendations of the Cabinet-appointed Sub-Committee. For Saudi Arabia the minimum age is 25 years, and for other Middle Eastern Countries is 23 years, and for all other countries is 21 years.
- 27. Europe's** biggest start-up conference, **Vivatech 2020** has recognized India as the "country of the year".  
**Note:** The country has been recognised with this honour, due to the global contribution of Indian start-ups. The start-up ecosystem of India is growing rapidly and has over 100 unicorns.
- 28. The US** has signed the gun violence bill and toughen background checks for the youngest (21 years) gun buyers.  
**Note:** Other reforms: \$ 13 billion in federal funding for mental health programs and school security upgrades. The funding will encourage the states to implement "red flag" laws to remove firearms from people considered a threat.
- 29. The UK, the United States, Japan and Canada** will soon ban the new imports of gold from Russian, to tighten the sanctions squeeze on Moscow for its invasion of Ukraine.

**Note:** Countries will apply for newly mined or refined gold. This move will not affect previously exported Russian gold. Last year, the exports of Russian gold were worth 12.6 billion pounds.

30. During the Group of Seven (G7) Summit in Germany's Bavarian Alps, **600 billion dollar** will be raised by the G7 leader to help developing countries tackle climate change.

**Note:** This will boost help to give a boost to the economies of countries. G7 is offering sustainable, quality infrastructure and will be listening closely to the recipient countries.

31. **Iran** has applied to become a member of the BRICS.

**Note:** BRICS is a group of Brazil, Russia, India, China and South Africa. Iran is the world's second-largest gas reserves and membership in the BRICS group would added values for both sides.

32. According to a World Gold Council (WGC) report, India's rank as the recycler in the world is **4th**.

**Note:** The country has recycled 75 tonnes in 2021. WGC report titled: Gold refining and recycling. Top three: China (recycled 168 tonnes), followed by Italy (80 tonnes) and the US (78 tonnes in 2021).

**Note:** Lionel Messi has received the Man of the Match trophy for the second time in his career, he won his first trophy in Barcelona (2011). Messi has made 46 goal contributions in the 45 finals that he has played in his career.
- Para-athlete, Vinod Kumar** the Discus throw player, has been banned by the Board of Appeal of Classification (BAC) for two years (Until 2023) for 'intentional misrepresentation'.  
**Note:** He won the bronze medal in the discus throw event (F52 category) at the 2020 Tokyo Paralympics.
- 4<sup>th</sup>** edition of the Khelo India Youth Games 2021 begins in Panchkula, Haryana.  
**Note:** The event was inaugurated by the union home minister Amit Shah. KIYG is the flagship event of the Indian government's Khelo India initiative. As many as 25 sports events will be organized at five venues namely Panchkula, Ambala, Shahabad, Chandigarh, and Delhi.
- In **62kg** category of wrestling, India's Sakshi Malik has won gold medal at the 2022 Bolat Turlykhanov Cup wrestling tournament in Kazakhstan.  
**Note:** Divya Kakran (68Kg) and Mansi Ahlawat (57kg) have won gold medal. Last time, Sakshi Malik won a gold was at the 2017 Commonwealth Championship. While, Pooja Sihag and Neeraj have settled for bronze in the 76kg and 63 Kg category respectively.
- Rafael Nadal (Spain)** wins his 14th title of the Men's 2022 French Open championship at Roland Garros and 22nd Grand Slam title overall.  
**Note:** He defeated Casper Ruud by 6-3, 6-3, 6-0. Iga Swiatek (Poland) has defeated Coco Gauff to win the Women's French Open 2022. Men's Doubles: Marcelo Arévalo (El Salvador) & Jean-Julien Rojer (Netherlands). Women's Doubles: Caroline Garcia and Kristina Mladenovic (France). Mixed Doubles: Ena Shibahara (Japan); Wesley Koolhof (Netherlands).
- In the **10m air rifle standing SH1** category, Indian shooter, Avani Lekhara has won the gold medal at the 2022 Para Shooting World Cup in France.  
**Note:** She also created a world record score of 250.6 in women's 10m air rifle standing SH1. Emilia Babska from Poland has bagged the silver medal with a total of 247.6, while Anna Normann of Sweden has settled for bronze medal.
- The 4th edition of the Khelo India Youth Games 2021 is being organized at **five** locations.  
**Note:** The event was inaugurated by the union home minister Amit Shah. KIYG is the flagship event of the Indian government's Khelo India initiative. KIYG 2021 will see participation from 37 States and Union Territories of India. As many as 25 sports events will be organized at five venues namely Panchkula, Ambala, Shahabad, Chandigarh, and Delhi.
- After defeating **Poland**, India has won the final of the inaugural FIH Hockey 5s championship in Lausanne in Switzerland.  
**Note:** India had topped the five-team league standings with three wins and one draw en route final, ending their campaign with an unbeaten record. Earlier, India has outplayed Malaysia by 7-3 before beating Poland 6-2 in the second match of the day.

- 12. Indian Women's cricketer Mithali Raj** has announced her retirement from all forms of international cricket on Jun 8, 2022.  
**Note:** She has represented India in matches (232) and scored 7,805 runs at an average of 50.68. She made her international debut in an ODI against Ireland, in June 1999. She became the first and is the only woman cricketer to have aggregated more than 10,000 international runs in over 350 matches across all three formats.
- 13. Thambi** is the name of the official mascot of the 44th Chess Olympiad, launched by Tamil Nadu Chief Minister MK Stalin.  
**Note:** It is a knight dressed in the traditional Tamil attire Veshti (Dhoti) with a shirt and is seen with folded hands, apparently extending the Tamil greeting 'Vanakkam'.
- 14. Saanapathi Gurunaidu** has clinched gold medal in men's 55-kilogram event at IWF Youth World Championships 2022.  
**Note:** Indian weightlifter Saanapathi Gurunaidu has clinched gold medal in men's 55-kilogram event at IWF Youth World Championships in Mexico with total lift of 230 kilogram.
- 15. Avani Lekhara** won the gold medal at the Chateauroux 2022 World Cup.  
**Note:** The Tokyo Paralympian has won in the R8 event- women's 50m rifle 3 positions SH1 with a score of 458.3. She beat Veronika Vadovicova of Slovakia to win this title and gold for India.
- 16. R Praggnanandhaa** the Indian Grandmaster won the Norway Chess Group A open chess tournament.  
**Note:** The 16-year old GM, the top-seed, was in fine form and remained unbeaten through the nine rounds. He finished the tournament with a win over fellow Indian V Praneeth, an International Master.
- 17. Manpreet Kaur** is associated with **Shot Put** and sets a new National Record in the Inter-State Athletics Meet in Chennai.  
**Note:** She held the previous record of 17.96m. Manpreet has previously threw the iron ball 18.86m at the Asian GP in 2017. Manpreet Kaur, who has recently returned after a 4-year doping ban.
- 18. Haryana** state emerged as the champion at the 4th edition of Khelo India Youth Games 2021.  
**Note:** Haryana tops the medal tally with 52 gold, 39 silver, and 46 bronze medals. While Maharashtra finished 2nd with 45 gold, 40 silver, and 40 bronze. Karnataka finished 3rd with 22 gold, 17 silver and 28 bronze.
- 19. Swimmer Aneesh Gowda** won the highest number (six gold medals) of medals in the 4th Khelo India Youth Games 2021.  
**Note:** Maharashtra swimmer Apeksha Fernandes and gymnast Sanyukta Kale won five gold medals each in the games. Host state Haryana becomes the champion at the 4th Khelo India Youth Games 2021.
- 20. Max Verstappen** won the Azerbaijan Formula One Grand Prix 2022.  
**Note:** He became the most successful driver in the Red Bull of all time. Red Bull's Sergio Perez came second and Mercedes' George Russell came at the third spot.
- 21. Star badminton player Viktor Axelsen** belongs to **Denmark** has won men's single title at the BWF Indonesia Masters 2022.  
**Note:** Axelsen (Denmark) defeated Taiwan's Chou Tien-chen in straight sets. While Chen Yufei (China) beats Thailand's Ratchanok Intanon. For Chen, triumph in Jakarta marks a first individual tournament victory since she won gold at the Tokyo 2020 Games.
- 22. Two Indian para-powerlifters (Men and Women individual) Manpreet Kaur and Parmjeet Kumar** have won bronze medals in World Para-powerlifting 2022 Asia Oceania Open Championships at Pyeongtaek in South Korea.  
**Note:** Manpreet Kaur (women's category) won bronze medal in the 41 kg category and had the best lift of 88 kg and the total lift of 173 kg. Parmjeet Kumar (men's category) also won the bronze medal in 49 kg category and lifted 160 and 163 kilograms in two rounds which were his lifetime best lifts.
- 23. PM Narendra Modi** has flagged off the first ever-torch relay for the 44th Chess Olympiad, which will be held in Mahabalipuram between 28 July and 10 August.  
**Note:** The International Chess Federation (FIDE) has instituted the torch relay for the very first time. President of FIDE, Arkady Dvorkovich handed over the torch to PM Modi, who gave it to Viswanathan Anand.
- 24. Javelin thrower, Neeraj Chopra** has clinched gold in javelin throw in the 2022 Kuortane Games in Finland.  
**Note:** He threw 86.69 metres. Keshorn Walcott of Trinidad has settled for silver with a throw of 86.64 metres. Anderson Peters has won the bronze with a throw of 84.75 metres. Sandeep Chaudhury from India got eighth position in the standings with a throw of 60.35 metres.
- 25. Mixed team of Manu Bhaker and Shiva Narwal** has won the 10m air pistol mixed team title at the

20th Kumar Surendra Singh Memorial Shooting competition.

**Note:** They beat the duo of Amanpreet Singh and Shweta Singh of ONGC by 16-8 to clinch the gold medal. Esha Singh (Telangana) had teamed up with Kaushik Gopu to win bronze in both the senior and junior mixed team competitions.

**26. Neeraj Chopra** will lead the 37-member Indian athletics contingent in Birmingham, 2022 Commonwealth Games in July-August.

**Note:** The Athletics Federation of India (AFI) has named a 37-member contingent for the 2022 Commonwealth Games, Birmingham.

**27. Indian** team of women's Wrestling has clinched five medals to claim the Under-17 Asian Championship, held at Bishkek, Kyrgyzstan.

**Note:** India has lifted the title with a total of 235 points (eight golds, one silver and one bronze). With 143 points, Japan finished at second and Mongolia at third with 138 points.

**28. Sunil Chhetri** has become the joint fifth highest goalscorer in the history of international football.

**Note:** He has achieved this feat during their AFC Asian Cup Qualifier clash against Hong Kong, where he scored his 84th goal. Presently, he is equal to the legendary Real Madrid and Hungarian player, Ferenc Puskas goals.

**29. Red Bull's driver, Max Verstappen** has clinched the 2022 Canadian Grand Prix title.

**Note:** Ferrari driver, Carlos Sainz and Seven-time world champion, Lewis Hamilton (Mercedes) have finished at second and third respectively.

**30. Rumeli Dhar** has announced her retirement. She is related to **cricket**.

**Note:** She has played her last international match in the tri-nation women's T20I series between India, Australia and England at Brabourne (2018). She has been featured in four Tests, 78 ODIs, and 18 T20Is.

**31. The Indian women team** of Deepika Kumari, Ankita Bhakat and Simranjeet Kaur has clinched for a silver medal at the World Cup Stage 3 in Paris, related to **Archery**.

**Note:** India has lost to Chinese Taipei by 1-5 in the women's recurve team final. India has concluded their campaign with one gold and two silver medals.

**32. Madhya Pradesh** has created history after defeating the 41-time champions, Mumbai by six wickets to win their first-ever Ranji Trophy title at M.Chinnaswamy Stadium in Bengaluru.

**Note:** Madhya Pradesh has chased down 108 in the fourth innings for the fall of four wickets. Madhya Pradesh has now become the fourth first-time winner of the Ranji Trophy in the last five seasons - joining Gujarat, Vidarbha (two-time winners now) and Saurashtra.

**33. Indian cyclist, Ronaldo Singh** has scripted history by winning Silver in the sprint event at the Asian Cycling Championships 2022.

**Note:** He also became the first Indian cyclist to win a silver medal (including the Elite category) at the Asian Track Championship. Ronaldo Singh Laitonjam hails from Manipur and started cycling at the age of 14.

**34. Deepak Punia** has won a bronze medal in the U23 Asian wrestling championships 2022 in Bishkek, Kyrgyzstan.

**Note:** He defeated Maksat Satybaldy in the 86kg freestyle weight category. He has lost to eventual gold medallist, Azizbek Fayzullaev of Uzbekistan and Nurtilek Karypbaev of Kyrgyzstan.

**35. Navjeet Dhillon** the Indian women's discus thrower, who has won the gold medal at the Qosanov Memorial 2022 athletics meet in Almaty, Kazakhstan.

**Note:** She won the women's discus throw with a 56.24m effort. Karina Vasilyeva (Kazakhstan) placed second with 44.61m and Uzbekistan's Yulianna Shchukina at third with 40.48m on the podium.

**36. Los Angeles, Toronto and Mexico City** have been named among the host cities for the 2026 FIFA World Cup in the United States, Canada and Mexico.

**Note:** USA: Seattle, San Francisco, Los Angeles, Kansas City, Dallas, Atlanta, Houston, Boston, Philadelphia, Miami and New York/New Jersey. Canada: Vancouver and Toronto. Mexico: Gadalajara, Mexico City and Monterrey

### Books and Authors

- 6.** Who has released a book titled Ashtang Yoga authored by Dr Sonu Phogat on 8th International Yoga Day \_\_\_\_ **Haryana CM, Manohar Lal.**

**Note:** During the launch he announced that various programmes are being organised in Haryana on IYD. CM also appreciated the efforts of writer Dr Sonu Phogat, as it is a matter of pride that the book on Yoga was released on International Yoga Day.

### Science and Defence

- 1.** The Defence Ministry has signed a contract of **2,971 crores** with Bharat Dynamics Ltd under the 'buy Indian' category.

**Note:** The contract was signed for the supply of the indigenously developed Astra Mk-I Beyond Visual Range air to air missiles and associated equipment for the Navy and the Indian Air Force. The Defence Acquisition Council headed by Defence Minister, Rajnath Singh had approved the purchase of 248 Astra-MK1 missiles (200 for the IAF and 48 for the Navy) in July 2020.

- 2. INS Akshay and INS Nishank** two ships have been decommissioned by the Indian Navy after 32 years of service.

**Note:** While INS Nishank, a high-speed missile craft, was commissioned on September 12, 1989, INS Akshay was commissioned a year later on December 10, 1990, at Poti, Georgia. Both were part of the 22 Missile Vessel Squadron and 23 Patrol Vessel Squadron, respectively.

- 3. Chandigarh** has signed an MoU with the Indian Air Force to set up a heritage center to showcase the role of the Indian Air Force in various wars and its overall functioning.

**Note:** The 'IAF Heritage Centre' will be set up jointly by the force and the Chandigarh administration. An MoU between the Union Territory of Chandigarh and the IAF for setting up of the center was signed.

- 4. 10th** edition of Ex SAMPRITI has been begun on June 5 at Jessore military station in Bangladesh.

**Note:** A joint military training exercise between India and Bangladesh. Aim: At strengthening the aspects of interoperability and cooperation between both armies. Indian contingent represented: Dogra regiment.

- 5.** India has successfully test-fired a nuclear-capable Agni-IV ballistic missile from APJ Abdul Kalam Island in Odisha, **4,000 km** is the strike target of Agni-IV.

**Note:** This missile is the fourth in the Agni series of missiles which is earlier known as Agni II prime. This missile was designed by the Defence Research and Development Organisation (DRDO) and manufactured by the Bharat Dynamics Limited.

- 6. Ex Khaan Quest 2022** a multinational peacekeeping exercise has started in Mongolia.

**Note:** 16 countries are taking part in this exercise including India. This exercise has been inaugurated by the President of Mongolia, Ukhnaagiin

Khurelsukh. Indian Army is represented by a contingent from the Ladakh Scouts.

7. Defence Acquisition Council (DAC) has accorded the Acceptance of Necessity (AoN) for Capital Acquisition Proposals of the Armed Forces amounting to **Rs 76,390 crore**.

**Note:** This will give boost to the Indian Defence Industry and reduce foreign spending significantly. The DAC meeting was headed by Defence Minister, Rajnath Singh.

8. In the year **1989** INS Nishank was commissioned, and which has been decommissioned by the Indian Navy on June 4, 2022.

**Note:** These two ships also participated in Operation Talwar and Operation Parakram. While INS Nishank, a high-speed missile craft, was commissioned on September 12, 1989, INS Akshay was commissioned a year later on December 10, 1990 at Poti, Georgia.

9. By the year **2029**, NASA set to launch “DAVINCI Mission” to explore the harsh atmosphere of Venus.

**Note:** The mission will fly by Venus and explore its harsh atmosphere in 2029. It will be the first mission to study Venus by means of both flybys and descent. Spacecraft is likely to explore layered Venusian atmosphere. It will reach Venusian surface by June 2031. The mission would capture data about Venus, that scientists are trying to measure since early 1980s.

10. India will launch first manned Human Ocean Mission in **2023**.

**Note:** Union Minister of State (Independent Charge) Science & Technology; Minister of State (Independent Charge) Earth Sciences India Jitendra Singh said that India will achieve the unique distinction of simultaneously launching the first Human Space Mission “Gaganyaan” as well as the first manned Human Ocean Mission in 2023.

11. **China** has launched its third aircraft carrier named 'Fujian'.

**Note:** It is the most advanced as well as the first fully domestically-built naval vessel in China. Its launching ceremony was held at Shanghai's Jiangnan Shipyard.

12. Indian Short-Range Ballistic Missile **Prithvi-II** has been test fired successfully from an integrated test range in Chandipur, Odisha.

**Note:** This missile system is capable of striking targets with a very high degree of precision. It is an indigenously developed, surface-to-surface missile. Range: 250 km and can carry one-ton payload.

13. **The Eastern Region** of Indian Coast Guard has inducted the indigenously designed and developed Advanced Light Helicopter (ALH) Mark III, the first aircraft of the newly created “840 Squadron”.

**Note:** The new squadron will be stationed at the headquarters of the Eastern Region of the Coast Guard, Chennai. ICG will add three more ALHs to the inventory of ‘840 Squadron’ soon.

14. Communication satellite **GSAT-24** has been successfully launched by the Indian Space Research Organisation (ISRO) from Kourou in French Guiana.

**Note:** It is built by ISRO for NewSpace India Limited (NSIL). It was launched by French company Arianespace. It is a 24-Ku band communication satellite, weight 4180 kg, pan-India coverage for meeting DTH application needs.

15. **South Korea** country has successfully launched satellites into orbit with its homegrown Nuri rocket.

**Note:** This is a crucial step for the country's space program expansion after a failed attempt last year. With this launch, South Korea becomes the 10th country to place a satellite with its own technology. Nuri is a three-stage rocket, more than 47 meters (154 feet) long and weighing 200 tons,.

16. **Iran** country has launched a solid-fueled rocket, a 25.5 meter-long rocket into space.

**Note:** Rocket name: Zuljanah, This rocket is capable of carrying a satellite of 220 kilograms. It will gather data in low-earth orbit and promote Iran's space industry.

17. **38th** edition of the Coordinated Patrol with Indonesian Navy (IND-INDO CORPAT) has been conducted by India.

**Note:** INS Karmuk (indigenously built missile corvette) is based at the Andaman and Nicobar Command, along with a Dornier Maritime Patrol Aircraft. While the Indonesian Navy is being represented by KRI Cut Nyak Dien, a Kapitan Pattimura (PARCHIM I) class corvette. The closing ceremony is scheduled at Sabang, Indonesia on 23 June 22.

18. **Bharat Electronics Limited** aerospace company has signed an MoU with Defense Initiatives (DI), Belarus, and Defense Initiatives Aero Pvt Ltd, India (a subsidiary of DI Belarus).

**Note:** To supply of Airborne Defense Suite (ADS) for helicopters of the Indian Air Force (IAF). It would be supported by DI with transfer of technology (manufacturing and maintenance) for supply of advanced electronic warfare suite for helicopters under 'Make in India' category.

**19.** Shipborne weapon system, **Vertical Launch Short Range Surface to Air Missile (VL-SRSAM)** is developed by the DRDO, was successfully test fired from Chandipur in Odisha.

**Note:** This missile system has been designed to strike at the high-speed airborne targets. Range: 40km to 50km. This missile's design is based on Astra missile.

**20.** Indian Air Force has participated in Tactical Leadership Programme with **Egyptian Air Force** air force in Cairo west Airbase.

**Note:** Indian Air Force: Three Su-30MKI aircraft, two C-17 aircraft and 57 IAF personnel including C-17 contingent. Aim: Enhancing defence cooperation between the two countries and exchange of best practices.

**21.** Defence Research and Development Organisation (DRDO) has successfully test-fired indigenously-developed Laser-Guided Anti-Tank Guided Missile (ATGM) from **Main Battle Tank (MBT) Arjun Tank**.

**Note:** The ATGM has been developed with multi-platform launch capability. It is currently

undergoing technical evaluation trials from 120 mm rifled gun of MBT Arjun. The successful development of the laser guided ATGM will enhance the fire power of the MBT Arjun.

**22.** The indigenously developed, high-speed expendable aerial target (HEAT) **ABHYAS** has been tested successfully from the Integrated Test Range in Chandipur, Odisha.

**Note:** It can be used as an aerial target for evaluating various missile systems. It is developed and designed by Aeronautical Development Establishment, Defence Research and Development Organisation (DRDO).

**23.** Indian Space Research Organization (ISRO) has launched **PSLV-C53** with three Singapore satellites on 30th June, from the Satish Dhawan Space Centre at Sriharikota.

**Note:** PSLV-C53, is the second dedicated commercial mission of the NewSpace India Limited, Department of Space. Primary payloads: 365 kg earth observation satellite called DS-EO, a 155 kg NeuSAR satellite and the 2.8 kg Scoob-1 nano-satellite of the Nanyang Technological University, Singapore.
