VACANCIES & RESERVATION

Details of number of vacancies and reservation shall be indicated in the notification to be published on our website before commencement of Online Registration. However, reservation shall be provided to OBC(NCL)/EWS/SC/ST/PwD candidates depending on the number of vacancies and as per Govt. of India Directives.

Final Year / Semester students who expect their final results **by 14.08.2023** are also eligible to apply, provided they have obtained minimum 60% marks or equivalent CGPA in aggregate of all semesters/years up to pre-final examination. In case of selection, their candidature shall be subject to their securing minimum 60% marks in essential qualification.

Such candidates need to mention their marks up to pre-final examination while filling up the online application form for POWERGRID.



- 2. Reservation/ relaxation/ concession to OBC (NCL)/ SC/ ST/EWS/ PwD/ Ex SM/ J&K Domiciled/ Victims of riots shall be as per Government of India directives.
- 3. Persons suffering from not less than 40% of the relevant disability shall only be eligible for the benefit for PwD.
- Relaxation in Marks in essential qualification for <u>SC/ST/PwD</u> candidates:
 Qualifying Marks in essential qualification is relaxed to pass marks for posts reserved for

- 8. **Reservation and Relaxation for OBC (NCL)** will be subject to submission of a copy of the latest OBC (NCL) certificate in the format prescribed by the Govt. of India for "Appointment to posts under Govt. of India" from a competent authority at the time of application and interview, if called for.
- Reservation for EWS will be subject to submission of a copy of the latest Income and Asset Certificate issued by a Competent Authority at time of application and interview, if called for.
- 10. **Reservation / Relaxation / Concession for Persons with Disability** is subject to submission of medical certificate in prescribed format in support of disability issued by the Government Medical Board at the time of application and interview, if called for.
- 11. Candidates working in POWERGRID are advised to refer to internal circular before filling up the application.
- 12. Relaxation/ Concession for POWERGRID Departmental Candidates
 - No Upper Age Limit
 - Qualifying Marks in essential qualification is relaxed to 50% for General and OBC (NCL) Category.

 - No application fee for applying in POWERGRID

Trainees working in POWERGRID shall not be considered as Departmental Candidate. Please refer to Internal Circular before filling up the application for further details.

SELECTION PROCESS

The Selection Process consists of marks obtained (out of 100) in the corresponding paper of GATE 2023, Group Discussion & Personal Interview.

Eligible candidates will have to appear for the **corresponding paper of GATE 2023**, i.e. **Electrical Engineering (EE)** / **Electronics and Communication (EC)** / **Civil Engineering (CE)** / **Computer Science Engineering (CS)**.

Candidates qualified in corresponding paper of GATE 2023 shall only be eligible to be considered for the next stage of selection. Qualifying marks in GATE 2023 shall be as decided by GATE 2023 conducting authority.

Qualified candidates shall be short-listed category-wise for Group Discussion & Personal Interview based on their **normalized marks out of 100** in GATE 2023, in the corresponding paper.

Candidates shall have the option of appearing in the GD/Interview in Hindi or English.

Candidates shall obtain information about their status through their login at the POWERGRID Online Application System. Shortlisted candidates shall be able to download their interview call letter and other relevant documents through the candidate login.

Candidates shortlisted for the Group Discussion and Interview shall be required to bring the documents as mentioned in their interview call letter.

Candidates must qualify in the Personal Interview in order to be considered for empanelment. The qualifying % in interview for different categories is as mentioned below:

Empanelment of Candidates

Candidates shortlisted for GD and interview may have to undergo psychometric assessment results of which shall be used as an input during the interview. Candidates who qualify in the Personal Interview will only be adjudged suitable for empanelment. Therefore, it is again reiterated that candidates will have to qualify in GATE 2023 and in Personal Interview separately in order to be considered eligible for empanelment.

Please note that only GATE 2023 score (Normalized Marks out of 100) is valid for this recruitment process. GATE score of 2022 or prior is not valid.

The offer of appointment shall be issued to the suitable candidates in the order of category wise merit and based on the requirement. Selected candidates shall be notified through their login in Online application system.

Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination to be conducted as per **POWERGRID Norms and Standards of Medical Fitness.**

COMPENSATION PACKAGE

The Corporation offers a very attractive pay package and is one of the best in the Industry. Selected candidates will be placed in the pay scale of Rs.40,000/- -3%- 1,40,000(IDA) during the

one-year training period. They shall be paid stipend in the form of Basic Pay of Rs. 40,000/- along with IDA, HRA and Perks @12% of basic pay during training period.

On successful completion of training, the candidates will be absorbed as Engineers in E2 scale - Rs. 50,000/- 3%- 1,60,000/- (IDA).

- 5. SC/ST/PwD/ Ex-SM/ Departmental candidates are exempted from payment of application fees. You are required to login to your candidate login section and then deposit non-refundable application fees of Rs. 500/- through online mode only. On submission of application fees, your application process will be treated as complete.
- 6. Candidates will be required to retain their GATE 2023 Admit card and GATE 2023 Score card for verification at the time of GD/ Interview /pre-employment medical examination/ Joining in POWERGRID.

- 3. Essential qualification should be recognized in India and from a recognized Institution or University.
- 4. Vacancies are for requirement all over the country, mostly on-site locations. Selected candidates shall be assigned for OJT and final postings accordingly.

- 6. Date of issuance of final mark sheet shall be taken as the date of acquiring qualification.
