India and Austria to sign migration and mobility agreement, shore up ties.

Why in the news: Close to similar mobility agreements with France, United Kingdom, Finland, India Germany, and will sign а "Comprehensive Migration and Mobility Partnership Agreement" (MMPA) with Austria.

The migration and mobility partnership is set to encourage an increased exchange of students, academics, and researchers migrating for professional and economic reasons.



- It is abiding by equal treatment of nationals of both Parties in a similar situation. India has also signed agreements with other European countries, namely, France, Kingdom, the United Germany, and Finland.
- India is keen to finalize these agreements with European countries as a stepping stone to resolving issues over the longpending India-European Union (EU) Free Trade Agreement and facilitating Indian professionals working in these countries; the European countries also see them as a way to curb illegal immigration from India.
- The Agreement will regulate multiple entry visas for professionals and student exchange programs and will be reviewed regularly by a Joint Working Group (JWG).
- India-Germany Agreement on Migration and Mobility partnership to foster the exchange of skills and talents was signed in December 2022.

#### India, Pakistan exchange list of nuclear installations

Why in the news: In continuing a 32-year practice, India and Pakistan exchanged a list of their nuclear installations under a bilateral pact that prohibits the two sides from attacking each other's atomic facilities.

 India and Pakistan today exchanged the list of nuclear installations and facilities covered under the Agreement on the Prohibition of Attack against Nuclear Installations and Facilities.



- 2. The Agreement was signed on December 31, 1988, and ratified on
- 3. January 27, 1991. It includes Nuclear power and research reactors, fuel fabrication, uranium enrichment, isotopes separation, and reprocessing facilities, as well as any other installations with fresh or irradiated nuclear fuel and materials in any form and establishments storing significant quantities of radioactive materials under the umbrella term "nuclear installations and facilities."
- 4. The need for the Agreement had been felt against the backdrop of Israel's 1981 bombing of Iraq's Osirak reactor near Baghdad.
- The two countries also exchanged lists of prisoners held in each other's prisons under the provisions of the Agreement on Consular access signed in May 2008.

#### India to assume chairmanship of Wassenaar Arrangement on 1 Jan

Why in the news: India joined the Wassenaar Arrangement, a multilateral export control regime, in 2017 and became its 42nd member.

 India will assume the chairmanship of the Wassenaar Arrangement (WA), a multilateral technology control agreement, on January 1, 2023, for one year.

2. WA is a multilateral export control regime.



- Through regular information exchange among members on transfers of conventional arms and dual-use goods and technologies, it seeks to promote transparency and greater responsibility in such transfers and prevent destabilizing accumulations.
- 3. The organization's primary goal is to restrict access to sensitive technologies for terrorist outfits.
- 4. The Wassenaar Arrangement came into being in 1996 and has 42 members. The WA operates voluntarily, and decisions are made by consensus.
- 5. Every six months, members exchange information on deliveries of conventional arms to non-Wassenaar members that fall under eight broad weapon categories: battle tanks, armored combat vehicles (ACVs), largecaliber artillery, military aircraft/unmanned aerial vehicles, military and attack helicopters, warships, missiles or missile systems, and small arms and light weapons.
- The WA maintains lists of technologies that are of interest. Tier 1 denotes a list of essential items, while Tier 2 denotes Sensitive or Very Sensitive Technologies.

What are the new Dexa scan tests that will determine Indian cricketers' fitness levels?

Why in the news: Through Dexa tests, BCCI and trainers can measure body fat percentage, lean muscle mass, water content, and bone density.

1. In a review meeting of the team's 2022 T20 World Cup debacle held in Mumbai that was attended by BCCI president Roger Binny, secretary Jay Shah, captain Rohit Sharma, head coach Rahul Dravid and NCA head of cricket VVS Laxman, the board has also re-introduced



Yo-Yo test and Dexa scan results as criteria for selection.

- 2. The trainers can measure body fat percentage, lean muscle mass, water content, and bone density through Dexa tests.
- 3. Dexa, also known as the bone density test, is an X-ray technology that measures bone strength.
- 4. It can help identify if a person has a risk of breaking or losing bones and can be used to determine if a player is at risk of fracturing any body parts. Two X-ray beams at different energy levels are directed at the bone, and the resulting chart shows the bone's current bone density and mineral content.
- The Yo-Yo test is a fitness test used to measure a person's endurance. It involves running back and forth between two cones placed 20 meters apart.
- 6. The speed at which the person runs increases over time and the test is stopped when the person cannot keep up with the required rate. The Yo-Yo test is often used in sports to evaluate athletes' endurance, and it is prevalent in soccer.

Sebi asks exchanges to set up Investor Risk Reduction Access platform.

Why in the news: IRRA service will be enabled upon the request of stockbrokers facing glitches that disrupt trading.

- Stock exchanges have been directed by the Securities and Exchanges Board of India (SEBI) to set up an Investor Risk Reduction Access (IRRA) platform.
- With the growing reliance on technology in the securities market, there is an increase in glitches in trading members' systems, some of which resulted in the disruption of trading services.
- In these cases, investors with open positions are at risk of the nonavailability of avenues to lose their jobs, especially at times when the markets are volatile.
- 4. The stock exchanges will jointly develop the Investor Risk Reduction Access (IRRA) platform to enable investors to square off their position or cancel the pending orders if the trading members disrupt services. Trading members are those who trade on their accounts as well as on the performance of their clients.
- 5. The SEBI has asked the stock exchanges and clearing corporations to operationalize the IRRA platform by October 1, 2023.

India's second longest cable-stayed eight-lane Zuari Bridge opens in Goa

Why in the news: Minister of Roads Transport and Highways Nitin Gadkari inaugurated the country's second longest cable-stayed eightlane Zuari Bridge.











- 1. The 640-meter-long bridge and the 13.20 km roads on both sides have been built in 3 phases.
- 2. The Zuari Bridge is between North Goa and South Goa, India. It carries the NH 66 over the tidal part of the Zuari River, between Agaçaim and Cortalim. It is a few meters downstream of the Konkan Railway Bridge.
- 3. The Zuari River is the largest in Goa, India.
- 4. It is a tidal river that originates at Hemad-Barshem in the Western Ghats.
- 5. The bridge project will be an expressway between Panaji and Margao over the Zuari river. The Rs.2530 Crore project consists of the new bridge from Bambolim to Verna.
- 6. India's longest cable bridge is over the Narmada River on the Ahmedabad-Mumbai section of NH-8 (New NH-48) in Bharuch, Gujrat.

Why in the news: The United Nations has declared 2023 as the International Year of Millets after proposed by the Prime Minister of India, which also accounts for a fifth of the 2023: INTERNATIONAL millets world's



- 1. In April 2018, Millets were rebranded as "Nutri Cereals," followed by the year 2018 being declared as the National Year of Millets, aiming at the more prominent promotion and demand generation.
- 2. In India, millets are primarily a Kharif crop, requiring less water and agricultural inputs than other similar staples.
- 3. PM Narendra Modi has also shared his vision to make IYM 2023 a 'People's Movement' alongside positioning India as the 'Global Hub for Millets.'
- 4. Next in the series, before the year-long celebration of 'International Year of Millets (IYM) 2023', the Department of Agriculture & Farmers Welfare hosted a special 'Millet Luncheon' for the Members of the Parliament at the Parliament house.
- 5. The states will conduct millet-centric activities, including mahotsavs/ melas and food festivals, training of farmers, awareness campaigns, workshops/ seminars, placement of hoardings, and distribution of promotional material at critical locations in the state, etc.
- 6. Millet is a common term for categorizing small-seeded grasses that are often called Nutri-cereals. Some of them are sorghum (jowar), pearl millet



Croatia Switches To Euro, Enters Europe's Passport-Free Zone

Why in the news: At midnight, the Balkan nation bid farewell to its kuna currency and became the 20th member of the Eurozone.

 The country officially became the 20th member of the Eurozone on January 1, and the removal of land border controls with neighboring Slovenia and Hungary marks its inclusion in the Schengen zone.



- 2. The euro adoption is expected to improve borrowing conditions in Croatia and shield its economy when inflation is soaring worldwide.
- 3. The Schengen Area is an area that comprises 27 European countries that have abolished all passports and border control at their respective mutual borders. The name of this area comes from the 1985 Schengen Agreement that was signed in Schengen, Luxembourg.
- 4. It will also be the 27th nation in the passport-free Schengen zone.
- 5. The Eurozone, officially called the euro area is a monetary union of 20 of the 27 European Union (EU) member states which have









adopted the euro as their common currency and sole legal tender.

 It consists of Austria, Belgium, Cyprus, Croatia, Estonia, Finland, France, Germany, Greece, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Portugal, Slovakia, Slovenia, and Spain.

SBI, ICICI, HDFC Bank remain systemically important banks: RBI

Why in the news: SIBs are perceived as 'Too Big To Fail' and their continued functioning is critical for the uninterrupted availability of essential banking services to the real economy.

- The Reserve Bank of India (RBI) has a state of the top three lenders in India -State Bank of India (SBI), ICICI Bank, and HDFC Bank - as Domestic Systemically Important Banks (D-SIBs), or banks that are too big to fail.
- A D-SIB is a bank considered crucial to the financial system, and its failure could cause significant disruption. As a result, these banks must maintain higher capital buffers to protect against potential losses and ensure their stability.
- Banks classified as D-SIBs are subjected to additional standard equity tier 1 (CET1) capital requirements in addition to the capital conservation buffer. The other CET 1 requirement as a percentage of Risk Weighted Assets for SBI stands at 0.6 percent and 0.20 percent each for ICICI and HDFC Bank.

### RBI launches Utkarsh 2.0 for the period 2023-2025.

Why in the news: Utkarsh is a three-year roadmap of the Reserve Bank of India (RBI) to improve regulation and supervision, among other functions of the central bank

 The Reserve Bank of India (RBI) has launched Utkarsh 2.0, the second phase of its mediumterm strategy for strengthening regulatory and supervisory mechanisms. Utkarsh 2.0 builds upon the foundation laid by Utkarsh 2022, launched in July 2019, and covers the period from 2019 to 2022.



- 2. Utkarsh 2.0 will guide the RBI over the period from 2023 to 2025 and includes six vision statements that are designed to improve the performance of the RBI's statutory and other functions, enhance its relevance and significance at the national and global levels, and improve its internal governance, infrastructure, and human resources.
- 3. Utkarsh 2.0 will guide the RBI over the period from 2023 to 2025 and includes six vision statements that are designed to improve the performance and have Transparent, accountable, and ethics-driven internal governance, Innovative, dynamic, and skilled human resources, Strengthened trust of citizens and institutions in the RBI among others.
- 4. The Reserve Bank of India is the central bank of India and was established under the Reserve Bank of India Act of 1934. It began operations on April 1, 1935, and was nationalized in 1949, with the government of India becoming its owner.

 The National Commission for Indian System of Medicine (NCISM) and the Central Council for Research in Ayurvedic Sciences (CCRAS), the two prominent institutions under the Ministry of Ayush, Government of India for regulating medical



education and conducting scientific research respectively, have launched 'SMART' (Scope for Mainstreaming Ayurveda Research in Teaching Professionals) program aimed to boost scientific research in priority healthcare research areas through Ayurveda colleges and hospitals.

- The proposed initiative is conceptualized to identify, support, and promote innovative research ideas in healthcare research areas, including Osteoarthritis, Iron Deficiency Anaemia, Chronic Bronchitis, Dyslipidemia, Rheumatoid Arthritis, Obesity, Diabetes Mellitus, Psoriasis, Generalised Anxiety Disorder, Non-alcoholic fatty liver disease (NAFLD).
- The eligible Ayurveda academic institutions may apply by January 10, 2023.
- 4. The 'SMART' program will motivate teachers to take up projects in designated areas of healthcare research and create an extensive database.

- 2. The program, 'Didir Suraksha Kawach,' will see 3.5 lakh party leaders reach every block and cover two crore families in 60 days, with workers staying in villages to understand the problems faced by locals and promoting the TMC government's flagship programs.
- 3. The 'Didir Doot' app has also been developed for people to register their problems. This initiative follows Banerjee's 'Didi ke Balo' program in 2019, which aimed to reach out to ordinary people and was successful.

 The Central Government of India recently announced the launch of a new integrated food security scheme, which will provide free food grains to 81.35 crore beneficiaries under the National Food Security Act (NFSA) for the year 2023.



- The Cabinet has decided to implement this central sector scheme to fulfill the vision of "One Nation-One Price-One Ration" under Prime Minister Narendra Modi.
- 3. This commitment of the government is intended to benefit the most vulnerable 67% of the population, which is 81.35 crore persons covered under the NFSA.
- 4. The new integrated scheme will subsume two current food subsidy schemes of the Department of Food and Public Distribution- a) Food Subsidy to FCI for NFSA and b) Food Subsidy for decentralized procurement states, dealing with procurement, allocation, and delivery of free foodgrains to the states under NFSA.
- 5. Under the scheme, th<mark>e Government of India will provide free foodgr</mark>ains to all NFSA beneficiaries, i.e., Antyodaya Ann Yojana (AAY) households

& Priority Household (PHH) persons, for the following year.

CJI announces launch of electronic Supreme Court Reports (e-SCR) project to provide access to judgements

Why in the news: electronic Supreme Court Reports (e-SCR) project to provide free access to about 34,000 judgments to lawyers, law students, and the common public.

 The Chief Justice of India (CJI), D Y Chandrachudh, has announced the launch of the electronic Supreme Court Reports (e-SCR) project, which aims to provide free access to around 34,000







judgments of the apex court to lawyers, law students, and the general public.

- These judgments will be available on the Supreme Court's website, mobile app, and on the National Judicial Data Grid's judgment portal.
- The e-SCR project is part of the Indian judiciary's efforts towards digitization and aims to bring positive change for all



stakeholders in the justice system, including litigants, members of the Bar, and judicial academies.

- 4. The judgments delivered by January 1, 2023, will be made available, and all decisions will be placed online within 24 hours. The Supreme Court has developed a search engine with the help of the National Informatics Centre (NIC), which uses elastic search techniques in the database of e-SCR.
- 5. In addition to the e-SCR project, the CJI also announced that neutral citations would be introduced in the Supreme Court. Neutral citations are standardized legal citations that do not identify the publisher of a legal document, allowing for impartial and objective referencing.

U.N. Security Council welcomes new members including two first timers

Why in the news: The five latest UNSC members – Ecuador, Japan, Malta, Mozambique, and Switzerland – are replacing India, Ireland, Kenya, Mexico, and Norway, whose terms ended on December 31, 2022.









- The incoming members (Ecuador, Japan, Malta, Mozambique, and Switzerland) are replacing India, Ireland, Kenya, Mexico, and Norway, whose two-year terms have ended.
- Albania, Brazil, Gabon, Ghana, and the United Arab Emirates are currently in the middle of their two-year term as non-permanent members of the Security Council.
- The United Nations Security Council comprises 15 members, five permanent members (the United States, the United Kingdom, France, Russia, and China), and ten non-permanent members.
- The non-permanent members are elected for two-year terms by the U.N. General Assembly, with five new members replacing outgoing ones yearly.
- Becoming a member of the UNSC is a significant diplomatic accomplishment for a country, as it can increase its global profile and give smaller nations a more prominent voice on international peace and security issues.

- The BIND scheme, through financial aid, will enable Prasar Bharati to undertake significant upgrades of its facilities with improved infrastructure, which will expand its reach to include areas with left-wing extremism, strategic locations, and border regions.


- It aims to provide free plots to the poor living in rural areas to build their houses.

and write, increasing their independence and access to education and employment opportunities.

- The first World Braille Day was celebrated in 2019.
- Braille is a system of representing alphabetic and numerical symbols using six raised dots. The dots are arranged in a grid, with different combinations of dots representing other letters, numbers, and symbols. It allows blind individuals to read and write by feeling the raised dots with their fingers.







- India also established the Central Braille Plant in Dehradun and the Central Braille Press in 1954, which produced simple Braille equipment such as slates and styluses.
- The Government of India has taken several steps to support people with disabilities, including enacting the Persons with Disabilities Act in 1995. This Act provides a category called "low vision" in addition to the type of "blind" and meets the stipulations of the United Nations Convention on the Rights of Persons with Disabilities.

- It is a centrally sponsored scheme for the upgradation and development of more than 14500 Schools across the country. It aims at strengthening the selected existing schools from amongst schools managed by Central Government/ State/ UT Government/ local bodies.

India identifies copper and lithium mines in Argentina; to acquire soon.

Why in the news: The Government of India sent a geologist team to Argentina to assess and find potential lithium deposits in November 2022. They have identified a possible source of lithium and copper deposits in the south American country.

- Lithium is widely used in manufacturing batteries and other electronic products.
- Argentina is the fourth largest producer of lithium. It also has the third-largest reserve of minerals in the world.



- Khanij Bidesh India Ltd. (Kabil) will have ownership or leasing rights to the mines. It was established in 2019 and is a joint venture between the National Aluminium Company (Nalco), Hindustan Copper (HCL), and Mineral Exploration Corporation Ltd.
- "Lithium Triangle"- holds more than 75 percent of the world supply. It consists of Chile, Bolivia, and Argentina.
- During 2021-22 Geological Survey of India (GSI) has carried out seven projects on Lithium in Arunachal Pradesh, Andhra Pradesh, Chhattisgarh, Jharkhand, Jammu & Kashmir, and Rajasthan. However, the resource of lithium has yet to be augmented by GSI.

- iFANS-2023 will be jointly organized by the National Agri-Food Biotechnology Institute (NABI), Centre for Innovative and Applied Bioprocessing (CIAB), National Institute of Plant Biotechnology (NIPB), and International Centre for Genetic Engineering and Biotechnology (ICGEB) at NABI, Mohali.
- NABI, under the Department of Biotechnology, is a national institute with a mandate focusing on research activities at the interface of Agriculture, Food, and nutritional biotechnology.

#### RBI unveils plans to raise ₹16,000 crore via Sovereign Green Bonds

Why in the news: For the first time, the Reserve Bank of India (RBI) will issue Sovereign Green Bonds (SgrBs) worth Rs 16,000 crore in two tranches of Rs 8,000 crore each in the current financial year. The first batch of 5 and 10-year tenor bonds will be issued on January 25 for ₹4,000 crores each.









- The RBI will auction 5-year and 10-year green bonds worth ₹4,000 crores each on January 25 and on February 9, which would be a uniform price auction.
- Green bonds are bonds issued by any sovereign entity or corporates whose proceeds are utilized for funding environmentally sustainable projects such as renewable energy, clean transportation, energy efficiency, sustainable water, waste management, etc.
- The only difference between Green Bonds and other ordinary government-issued bonds is that the funds from investors are only used to support initiatives that positively influence the environment.
- 4. The government issued the framework for the sovereign green bond in November 2022. The framework established a committee headed by the Chief Economic Adviser to select eligible projects for financing.
- 5. Green Bonds will help the government tap the requisite finance from potential investors for deployment in public sector projects to reduce the economy's carbon intensity.

National Health Authority (NHA) introduces new system to measure and grade performance of hospitals empaneled under Ayushman Bharat PM-JAY scheme

Why in the news: The aim is to shift the focus of measuring hospitals' performance from the volume of services provided to the value of healthcare services.

1. The new initiative will introduce the concept of 'value-based care,' where payment will be outcome-based, and providers will be













rewarded according to the quality of the treatment delivered and not the quantity.

- Under value-based care, the performance of AB PM-JAY impaneled hospitals will be measured based on five performance indicators such as:
- 1. Beneficiary Satisfaction;
- 2. Hospital Readmission Rate;
- 3. The extent of Out-of-Pocket Expenditure;
- 4. Confirmed Grievances and
- 5. Improvement in-patient's Health-Related Quality of Life.
  - 1. The hospital's performance based on the above indicators shall also be made available on a public dashboard to help the beneficiaries make an informed decision.
  - In this way, the hospital's performance shall not only determine the financial incentive of the hospital but also create a demand for quality treatment of beneficiaries under PMJAY.

#### Ayushman Bharat-PMJAY

- 1. Launched in February 2018, it offers a sum insured of Rs.5 lakh per family for secondary care (which doesn't involve a super-specialist) and tertiary care (which involves a super-specialist).
- The National Health Authority (NHA) has been constituted as an autonomous entity under the Society Registration Act of 1860 to effectively implement PM-JAY in alliance with state governments.

Odisha: Bhitarkanika National Park witness rise in number of birds this year Why in the news: Bhitarkanika National Park is a prime location for birds of different species and 130 km from Odisha's capital Bhubaneswar.

1. The recent census report of birds released by the





forest department in Odisha said that the number of migratory birds in Bhitarkanika National Park has risen to 1,39,959 this winter compared to last year's count of 1,38,107 birds.

 However, the diversity of species has decreased compared to last year. This year the Bhitarkanika National Park saw 140 species of birds compared to 144 last year.

#### FACTS -

- 1. Bhitarkanika National Park is located in the Kendrapara district of Odisha.
- It is India's second-largest mangrove ecosystem after the Sunderbans. It is home to the country's largest congregation of endangered Salt Water Crocodiles.
- 3. This National Park is a network of creeks and canals inundated with waters from Brahmani, Baitarani, Dhamra, and Patasalaforming a unique ecosystem.

Joshimath crisis: What is land subsidence and why does it happen?

Why in the news: The exact reason behind Joshimath land subsidence is still unknown, but experts cite unplanned construction, over-population, obstruction of the natural flow of water, and hydel power activities as possible causes.

 According to the National Oceanic and Atmospheric Administration (NOAA), subsidence is the "sinking of the ground because of underground material movement."



 It can happen for various reasons, man-made or natural, such as removing water, oil, or natural resources and mining activities. Earthquakes, soil erosion, and soil compaction are well-known subsidence causes.





- The primary cause of the land subsidence in Joshimath is believed to be the National Thermal Power Corporation's Tapovan Vishnugad Hydro Power Project. However, climate change is also a contributing factor.
- 4. Over 60 families living in uninhabitable houses have already been moved to temporary relief centers, with at least 90 more families set to be evacuated.

- 1. According to the latest estimates released by the United Nations Interagency Group for Child Mortality Estimation (UN-IGME), Sub Saharan region accounted for 6 percent of all global under-five deaths in 2021.
- 2. With 2.8 million children dying in 2021, sub-Saharan Africa is at the highest risk of childhood deaths in the World, according to Levels and trends in child mortality report 2022.
- 3. The rate is 15 times higher than in Europe and North America and 19 times higher than in Australia and New Zealand.
- Globally, the under-five mortality rate (U5MR) fell to 38 deaths per 1,000 live births in 2021, while it was 74 deaths per 1,000 live births under-five mortality rate (U5MR) for Sub-Saharan Africa.

- 5. It uses an advanced inertial navigation system to engage its target with enhanced precision and can carry payloads weighing 500 kg to 1000 kg.

Integrated Guided Missile Development Programme (IGMDP)

- IGMDP was an Indian Ministry of Defence program to research and develop a comprehensive range of missiles. The project started in 1982-1983 under the leadership of Dr. APJ Abdul Kalam.
- 2. Five Missiles Developed under the IGMDP:
- PRITHVI (Short range surface-to-surface ballistic missile)
- AGNI (Medium to intercontinental surface-to-surface missile)
- TRISHUL (Short range low-level surface-to-air missile)
- AKASH (Surface-to-air missile having a range of up to 25 Km and a multi-target handling system)
- NAG (Third generation "fire & forget," "top attack" anti-tank missile)

- 1. The Defence Acquisition Council (DAC) was formed after recommendations made by the Group of Ministers on 'Reforming the National Security System' in 2001, post-Kargil war.
- DAC is the highest decision-making body in the Defence Ministry (headed by the Minister of Defence) for deciding on new policies and capital acquisitions for the three services - Army, Navy and Air Force, and the Indian Coast Guard.
- 3. The objective of the DAC is to ensure the faster procurement of the approved requirements of the armed forces in terms of capabilities sought and time frame prescribed by optimally utilizing budgetary resources.

MSME minister Narayan Rane launches web portal for World Bank-assisted RAMP scheme

- 3. The scheme was originally announced in 2020 by the government and the World Bank to support Covid-hit MSMEs in the country. It aims to improve the performance of 5.55 lakh MSMEs by supporting institutional and policy reforms, research studies, and technology upgradation.
- It is in line with the recommendations of the U K Sinha Committee, KV Kamath Committee, and the Economic Advisory Council to the Prime Minister (PMEAC).
- 5. During the first year of implementation, FY23, the RAMP scheme will invite states and union territories to prepare a financing roadmap called Strategic Investment Plans (SIPs).
- 6. The SIPs would include an outreach plan for the identification and mobilization of MSMEs under RAMP, identify key constraints and gaps, set milestones, and project the required budgets for interventions in priority sectors, including renewable energy, rural & non-farm business, wholesale and retail trade, village and cottage industries, women enterprises, etc.

### Tamil Nadu Assembly passes resolution asking Centre to implement Sethusamudram project

Why in the news: The project, which aims to create a shipping route between India and Sri Lanka, had been the focal point of political and religious tensions for decades.

1. The project was originally conceived in 1860 by Commander Taylor at the cost of Rs. 50 lakh.







- 2. Local fishermen and environmentalists have opposed the scheme, saying that digging would mean that the seabed scooped from the straits will be dumped in deeper water out to sea. They say this will endanger a rich biosphere reserve with 400 endangered species, including sea turtles, dolphins, dugongs, and whales.
- 3. The bridge is 48 km long and separates the Gulf of Mannar (southwest) from the Palk Strait (northeast).

FACTS -

- 1. Sethusamudram Ship Channel Project envisages the dredging of a ship channel across the Palk Straits between India and Sri Lanka.
- 2. Two channels will be created one across Adam's Bridge (the chain of islets and shallows linking India with Sri Lanka), southeast of Pamban Island, and another through the shallows of Palk Bay, deepening the Palk Straits.
- 3. To reduce the steaming distances between the east and west coasts of India and to improve navigation within the territorial waters of India, this project was envisaged.
- 4. The channel will cut short sailing of an additional distance of 254-424 nautical miles and 21-36 hours of sailing time.

- 2. Per the rules, 90% of the CAF money is to be given to the states, while the Centre retains 10%.
- 3. Compensatory afforestation means that whenever forest land is diverted for non-forest purposes such as mining or industry, the user agency pays for planting forests over an equal area of non-forest land, or when such land is unavailable, twice the area of degraded forest land.



#### Sweden's LKAB finds Europe's biggest deposit of rare earth metals


Why in the news: Swedish state-owned mining company LKAB had identified more than 1 million tonnes of rare earth oxides in the Kiruna area in the far north of the country, the largest known deposit in Europe.



- 1. Rare earth minerals are essential to many hightech manufacturing processes and are used in electric vehicles, wind turbines, portable electronics, microphones, and speakers.
- Rare earth elements need to be mined in Europe, leaving the region depending on imports from elsewhere. At the same time, demand is expected to rise in the coming years due to a ramp-up in electric vehicles and renewable energy.
- India has 6% of the world's rare earth reserves, it only produces 1% of global output, and it meets most of its requirements of such minerals from China.
- 4. The vast majority of rare earth is currently mined in China.

 They are a set of seventeen metallic elements. These include the fifteen lanthanides on the periodic table and scandium and yttrium, which show similar physical and chemical properties to the lanthanides.

Four dinosaur species found in Chilean valley for first time: Study

Why in the news: The fossils were found in Cerro Guido, in southern Chile's Las Chinas valley near the border with Argentina.

- Scientists have found the remains of four species of dinosaurs, including a mega raptor, in a barren valley in Chilean Patagonia that has emerged over the past decade as an essential fossil deposit.
- They belong to dinosaurs that have yet to be identified in the area.
- 3. Each collaborated with the University of Chile and the University of Texas on the expedition.
- 4. They identified the remains including teeth and postcranial bone pieces
   of four species of dinosaur, including the mega raptor, which belongs to the theropod family.
- 5. These carnivorous dinosaurs inhabited 66 and 75 million years ago, at the end of the Cretaceous period.

- 3. The move also disallows the cultivation of Neelakurinji, which is endemic to Western ghats.
- The most popular Neelakurinji is Strobilanthes kunthiana which blooms once in 12 years. However, some other rare varieties of Neelakurnji are also found in the Western Ghats region.



James Webb telescope discovers its first Earth-sized exoplanet: What are exoplanets?

Why in the news: Exoplanets are planets that orbit other stars and are beyond our solar system. According to NASA, more than 5,000 exoplanets have been discovered.







 NASA's Transiting Exoplanet Survey Satellite (TESS) mission has discovered a second Earth-sized, rocky planet within the habitable zone of its star - the range of distances where liquid water could occur on a planet's surface.



- The planet, named TOI 700 e, is one of only a few systems with multiple minor, habitable-zone planets that we know of.
- 3. Astronomers have previously discovered three planets in the TOI 700 system: TOI 700 b, c, and d. Planet d also orbits within the habitable zone, but the scientists needed an additional year of TESS observations to discover TOI 700 e. The non-permanent members are elected for two-year terms by the UN General Assembly, with five new members replacing outgoing ones yearly.
- 4. The discovery of TOI 700 e expands the known sample of potentially habitable rocky planets. It opens the door to future studies to understand the habitability of these worlds and search for signs of life in them.

- 6. Under the mission, these cities' sewage treatment, air quality, flood management, and water bodies will be monitored through technological interventions.

1. The Department of Medical and Health, on the direction of Chief Minister Ashok Gehlot, released the policy document for the prevention of blindness.





- 2. The policy has been introduced to bring light to the lives of more than three lakh people with visual impairment in the state. The prevalence rate of blindness in the country was 1.1 percent in 2020, and work would be done to bring it down to 0.3 percent through the blindness control policy.
- 3. Under the policy, the Rajasthan government will mandatorily run Keratoplasty Centres and Eye Banks at all government medical colleges. Also, cornea collected by private organizations and NGOs getting financial help from the government will have to be provided to the government institutions on priority.
- 4. In collaboration with voluntary organizations, trusts, hospitals, and other charitable institutions working in this field, efforts to eliminate visual impairment would be made in the districts.
- 5. Special training will be imparted to eye experts, eye surgeons, postgraduate students, counselors working for eye donation and eye assistants, etc.

#### 1200-yr-old miniature stupas found in Nalanda district

Why in the news: Archeological Survey of India (ASI) has discovered two 1200year-old miniature votive stupas during landscaping activities near Sarai Tila mound on the premises of 'Nalanda Mahavihara,' a world heritage site in Nalanda district.

- A Stupa is a hemispherical structure that symbolizes the burial mound of Buddha. It rose to prominence after the advent of Buddhism and peaked during Ashoka's reign. Stupas evolved as Chorten in Tibet and pagodas in East Asia.
- 2. A votive stupa has a distinctive domelike drum, which originates in eight cylindrical structures where the Buddha's relics are placed after his death.
- Votive stupas were offered in fulfillment of a vow. Beginning in the 7th century CE in India, small miniature terracotta stupas became popular as votive offerings.

- 3. Shukrayaan will be India's first orbiter mission to Venus after sending similar missions to the Moon and Mars. The mission aims to study the surface of the hottest planet in our solar system and unravel the mysteries under the Sulfuric Acid clouds enveloping it.



#### RBI proposes expected loss-based approach for provisioning by banks

Why in the news: Presently, banks are required to make loan loss provisions based on an 'incurred loss' approach, which used to be the standard globally till recently.



1. THE RBI has proposed adopting an









expected loss-based approach for provisioning against loan loss by banks in India.

- 2. Banks make loan loss provisions based on the 'incurred loss' approach, which has been the standard globally till now.
- The Expected loss-based approach is a more forward-looking method, where banks must make provisions based on self-designed models that the regulator approves.
- 4. Under the proposed framework, banks will be required to classify financial assets (primarily loans, including irrevocable loan commitments, and investments classified as held-to-maturity or available-for-sale) into one of three categories Stage 1, Stage 2, and Stage 3 depending upon the assessed credit losses on them, at the time of initial recognition as well as on each subsequent reporting date and make necessary provisions.
- Adopting the forward-looking expected credit loss approach to estimating loss provisions is likely to result in excess provisions compared to a shortfall in provisions.
- 6. The proposed norms are for all scheduled commercial banks, excluding regional rural banks and smaller cooperative banks (based on a threshold to be decided based on comments)

KVIC through RE-HAB project of the Honey Mission Programme aims to reduce elephant attacks on humans and farmers' crops

Why in news: KVIC initiated a pilot project with the Technical assistance of the College of Forestry, Ponnampet, Kodagu District and the results were encouraging.

- KVIC has distributed live Bee Colonies, Beekeeping equipment, and 200 Bee-Boxes to the trained beneficiaries at Sulia at Dakshina Kannada, Karnataka, under the RE-HAB Project (Reducing Elephant-Human Attacks using Bees), an initiative under the Honey Mission Programme.
- 2. Under Project RE-HAB, "Beefences" is created by setting up bee boxes in the passageways of elephants to block their entrance to human habitats. The boxes are connected with a string so that when elephants attempt to pass through, a tug or pull causes the bees to swarm the elephant herds and dissuade them from moving further.
- Six such projects were sanctioned in the most wanted states, namely Assam, Maharastra, West Bengal, Orissa, and Uttarakhand, apart from Karnataka.
- 4. Under the RE-HAB, farmers are trained in beekeeping. Each of them is supplied with 10 Bee boxes and installed in the elephant corridors, so bee boxes and bee hives are placed in the Elephant corridor to restrict elephants from approaching the agricultural field.
- 5. The KVIC launched the Honey Mission in 2017 to provide awareness, training, Bee Boxes, and Bee Colonies to the farmers.

#### US launches Welcome Corps Scheme

Why is in news: The program is intended to deepen the connections between the local communities and incoming refugees, as well as take some cost of resettlement off the shoulders of the government.

The United States is launching a new programme that will allow groups of people and organizations in the US to "sponsor" refugees seeking sanctuary in the country.

. Under the programme, sponsors will form groups of at least five members. These groups will raise funds (a minimum of \$2,275 per assigned refugee), prepare initial housing, greet refugee newcomers at the airport, enroll children in schools, and help adults find employment.

. Once the groups are formed, sponsors will participate in a training program before they receive certification, ensuring that they have raised enough funds to properly go about their work.

. Once certified, sponsor groups will be matched with a refugee individual or family of any nationality who has completed all application and vetting steps required by the U.S. Refugee Admissions Program (USRAP).

. The goal has been set to place all 5,000 refugees with sponsors by the end of the 2023 fiscal year.

Europe's mission to Jupiter's icy moons ready for launch

Why in the news: The mission will characterize these moons as both planetary objects and possible habitats, explore Jupiter's complex environment, and would enable the in-depth and broader study of the Jupiter system as an archetype of gas giants across the Universe.



- The European Space Agency (ESA) is ready to launch the Jupiter Icy Moons Explorer (JUICE), an extraterrestrial spacecraft, with Airbus Defence and Space as the lead contractor.
- 2. The mission will focus on three of Jupiter's Galilean moons: Ganymede, Callisto, and Europa.
- 3. The JUICE will explore -
  - The habitable zone characterizes the oceans, icy shells, compositions, surfaces, environments, and activity of Ganymede, Europa, and Callisto.
  - The broader Jupiter system characterizes Jupiter's atmosphere, magnetic environment, ring system, and other satellites (including lo).
- JUICE builds on the previously proposed Europa Jupiter System Mission (EJSM-Laplace), a planned joint mission between ESA and NASA that would have carried out an in-depth study of the Jovian system and its icy moons.
- 2. It will pave the way for extensive future exploration of the diverse extreme environments in the distant outer Solar System.
- Jupiter has 80 moons; the four largest moons Io, Europa, Ganymede, and Callisto - were first observed by the astronomer Galileo Galilei in 1610.

0. Switzerland Becomes 1st in WTO to Formally Adopt Fisheries Deal

Why in the news: Switzerland became the first World Trade Organization member to submit its acceptance of the fisheries subsidies agreement struck at the 12th Ministerial Conference at WTO.

 Adopted by consensus at the WTO's 12th Ministerial Conference (MC12) held in Geneva on 12-17 June 2022, the Agreement on Fisheries Subsidies sets new binding, multilateral rules to curb harmful subsidies, which are a crucial



factor in the widespread depletion of the world's fish stocks.

- The Agreement bars subsidies to illegal, unreported, and unregulated fishing; and bans the same for fishing overfished stocks and fishing on the unregulated high seas.
- The prohibition of harmful marine capture subsidies is a significant contribution of the multilateral trading system toward achieving the UN's sustainable development goals.
- 4. Two-thirds of WTO members' acceptance is required for the Agreement to come into effect.



NASA to test nuclear fission-powered spacecraft engine by 2027

Why in the news: Defence Advanced Research Projects Agency (DARPA) is working on nuclear power fission power spacecraft along with NASA called the Demonstration Rocket for Agile Cislunar Operations (DRACO).

- 1. NASA will partner with the US military's Defense Advanced Research Projects Agency (DARPA) to develop the nuclear thermal propulsion engine and launch it into space.
- A nuclear thermal rocket engine uses a fission reactor to generate extremely high temperatures. The heat is then transferred to a liquid propellant, which "is expanded and exhausted through a nozzle to propel the spacecraft."
- 3. A nuclear thermal rocket can be three or more times more efficient than conventional chemical propulsion. That means that a spacecraft powered by nuclear fission could result in faster travel times and less risk to









astronauts. The technology could also allow for more power for instruments and communications on board.

4. No country on earth has succeeded in this technology. China, Russia, and USA are space racing on the technology.

Five billion people unprotected from trans fat leading to heart diseases: WHO Why in the news: The World Health Organization (WHO) has released a new report that revealed that five billion people globally remain unprotected from harmful trans fat, increasing their risk of heart disease and death.

- The report, called "Countdown to 2023 WHO report on global trans fat elimination 2022", is an annual status report published by WHO in collaboration with Resolve to Save Lives to track progress towards the goal of trans fat elimination in 2023.
- 2. It monitors global progress towards the 2023 target for eliminating industrially produced Trans-Fatty Acids (TFA) worldwide.
- 3. The report finds that 5 billion people globally are exposed to harmful trans-fat, increasing their heart disease and death risk. Almost 9 of the 16 countries do not have a best-practice policy.
- 4. TFAs are unsaturated fatty acids that are of two types.
  - Naturally occurring trans-fat occurs naturally in some dairy and meat products.
  - Industrially produced trans-fat adds hydrogen to liquid vegetable oils to make them more solid. It is found in packaged foods, baked goods, cooking oils, and spreads.
- World Health Organization (WHO) has launched a comprehensive plan called "REPLACE" to eliminate industrially-produced artificial trans-fats from the global food supply by 2023.
- FSSAI limits the content of not more than 2% by mass of total oils and fats from January 2022. It has made it mandatory for food manufacturing units to specify TFA content on the nutrient label.

While all countries have sent entries, Pakistan is the only country that did not send any film for screening in the group's third such film festival.

- The 20-year-old organization has Russia, India, China, Pakistan, and four central Asian countries - Kazakhstan, Kyrgyzstan, Tajikistan, and Uzbekistan as its members.
- 4. Iran is the latest country to become a member and, under Indian Presidency, will, for the first time, attend the grouping's meeting as a full-fledged member.
- 5. The last meeting of the Shanghai Cooperation Organization was held in Samarkand, Uzbekistan.

#### NARCL acquires first stressed account from IDBI Bank-led lenders

Why in the news: The bad loan transferred to NARCL, or bad bank, is Jaypee Infratech, among the 12 large accounts referred by the Reserve Bank of India (RBI) to the National Company Law Tribunal (NCLT) in 2017.

- 1. NARCL, an Asset Reconstruction Company (ARC)/bad bank, has acquired its first stressed asset- Jaypee Infratech- from lenders.
- NARCL, which was set up by banks last year, is aggregating and consolidating select stressed assets (above ₹500 crores each) in the financial system for their subsequent resolution. It is incorporated under the Companies Act 2013, and Public sector banks hold a majority stake in the ARC.
- 3. Stressed assets will be acquired through a 15 percent upfront cash payment and 85 percent security receipts.
- It is registered with RBI as an ARC under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002.
- Establishing NARCL is part of the government's efforts to clean up the financial system, which sits on one of the world's most enormous piles of bad assets.

- 2. The Olive Ridley Sea Turtle, also known as the Pacific ridley sea turtle, is a medium-sized sea turtle found in warm and tropical waters, primarily in the Pacific and Indian Oceans.
- 3. The species is listed as Vulnerable in the IUCN Red List, Appendix 1 in CITES, and Schedule 1 in Wildlife Protection Act, 1972.
- 4. They are best known for their behavior of synchronized nesting in mass numbers, termed Arribadas.
