OFFICE MEMORANDUM

Subject: Engineering Services Examination, 2021- Allocation of candidates to the various services/posts on the basis of the results of.

The undersigned is directed to refer to the Union Public Service Commission's letter No.F.1/4(14)/2021/E.VII dated 26.04.2022 forwarding a list along with dossiers and other connected papers of finally recommended candidates on the basis of Engineering Services Examination, 2021.

2. Against a total of 225 vacancies indented for various services under four disciplines viz. Civil Engineering, Mechanical Engineering, Electrical Engineering and Electronics and Telecommunications Engineering, the Commission had recommended only 194 candidates inclusive of 26 Scheduled Caste (SC), 16 Scheduled Tribes (ST), 56 Other Backward Classes (OBC), 20 Economically Weaker Sections (EWS) and 14 candidates from Persons with Benchmark Disabilities (PwBD) category for appointment to various services/posts. This is due to operation of Rule 13 (iv) & (v) of ESE 2021 Rules pertaining to maintenance of Reserve List. The remaining candidates shall be requisitioned from the Reserve List.

3. Lists detailing allocation of candidates to different services/posts are enclosed as **Annexure- I**.

4. A statement showing the number of vacancies which could not be filled in various services/posts is at **Annexure II**. Some of these vacancies will be filled later by requisitioning candidates from the Reserve List of ESE-2021 maintained by Union Public Service Commission, as stated in Para 2 above.

5. Allocation of candidates has been done keeping in view provisions of the Engineering Services Examination Rules-2021, strictly on the basis of ranks secured by the candidates, order of preferences for various services/posts exercised, medical requirements of various services and medical fitness of the candidates for services allotted, availability of vacancies in their category at their turn and physical requirements/functional classification, as prescribed for the various services/posts and physical requirements/functional classification possessed by the candidates. As regards allocation of PwBD candidates, if a PwBD candidate is not available the vacancy has been allotted to the candidate of the category concerned. In such cases only the reservation is carried forward by the CCA (as the reservation for PwBDs is horizontal).

5.1 In Mechanical Engineering Discipline, UPSC has recommended one PwBD-1/OA candidate (Shri Gunjal Sagar Balasaheb, Roll No. 0507741, M-34) belonging to OBC category against the only PwBD-1/OL vacancy in Mechanical Engineering Discipline (i.e. GSI). However, there are no OBC vacancies in GSI in Mechanical Engineering Discipline. In this regard, it is pertinent to mention that reservation for PwBD candidates is horizontal and they occupy the posts of the community (UR/EWS/OBC/SC/ST) to which they belong to. In view of this, Shri Gunjal Sagar Balasaheb has been allotted to GSI. CCA for GSI is advised to adjust Shri Gunjal Sagar Balasaheb against future available OBC vacancy.

6. Medical Reports of candidates, clearances in respect of candidature of candidates (Provisional-I/Provisional-II/Conditional) received from UPSC have been placed in their respective dossiers.
7. Claim of candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST), Other Backward Classes (OBC) or Economically Weaker Sections (EWS) have been accepted by the Commission on the basis of the Original Certificates/ Income & Asset certificates (in case of EWS) submitted by them. Copies of these Certificates submitted by the candidates have been placed in their respective dossiers by the UPSC itself. In case of doubt regarding genuineness / claim of the candidate regarding his/her community (i.e. Scheduled Caste/ Scheduled Tribe/ OBC) or Income & Asset certificates (in case of EWS), the Cadre Controlling Authorities/Participating Ministries may, if they consider it necessary, verify further the genuineness of these documents at their end. There may be some cases where though the OBC certificates have been issued to the candidates, the "Creamy Layer" status may be doubtful keeping in view the income/ status of the parents of the candidates as per declaration of the candidates vide column 11 in the Detailed Application Form. It is advised that participating Ministries may, in such cases, ensure that candidates do not attract "Creamy Layer" provision and offers of appointment to these candidates may be made after the Ministry/CCA concerned satisfies itself in this respect also.
8. Verification of character and antecedents in respect of the candidates indicated in Annexure -I is to be done by the Cadre Controlling Authorities concerned to their satisfaction as stipulated in DOP&T's OM No. 13012/1/2007-AIS-I dated 27.6.2007 and 4.1.2008 and DoP&Ts OM No.18011/29s)/2016-Estt.(B)(i) dated 29.06.2016. The cadre controlling Ministries / Departments are requested to obtain Attestation Forms from candidates allotted to services/posts under their control for the purpose of verification of their character and antecedents from the District Authorities concerned. Pending such verification participating Ministries are advised to inform candidates that offers of appointment issued are provisional subject to clearance from the Cadre Controlling Authority regarding completion of verification of their character and antecedents.
9. Details of 02 candidates whose candidature is still marked as "**Provisional-II**" due to discrepancy in Caste Certificate/Income and Asset Certificate as indicated against their names are given in **Annexure-III**. UPSC has obtained clarification from the candidates and placed the same in their dossiers. As regards clearance of their Provisional candidature before offers of appointment to these candidates are issued, UPSC has advised that CCAs concerned may take further necessary action/decision themselves as per instruction/guidelines of the Government on the subject and the Commission's clearance would not be required.
10. Details of 09 candidates whose candidature is still **conditional** on account of non-submission of certain documents as indicated against their names are given in **Annexure -IV**. The said documents may be obtained from the candidates and sent to Union Public Service Commission. Offers of appointment to these candidates need not, however, be withheld on this account.
11. While issuing offers of appointment, detailed instructions contained in Union Public Service Commission's letter referred to above and DoP&T's instructions, issued from time to time may be followed. In addition, clause relating to verification / acceptance of caste certificates etc. may also please be incorporated in the appointment letters clearly bringing out that if at any stage it is found that any Certificate/Document/testimonial etc. as furnished by the candidate and having a bearing on his/her eligibility is not in order, his/her appointment shall be cancelled forthwith without prejudice to any punitive action under the relevant rules.



12. It is advised that arrangements for additional training and coaching to the candidates belonging to the Scheduled Caste/Scheduled Tribe candidates except those whose names are given in **Annexure -V** may please be made in terms of the Ministry of Home Affairs OM No.2/11/55 – RPS dated 7th May 1995 and in respect of OBC candidates vide Commission's Order No. 3/06/2003-C.II dated 16.04.2004 so that they may come up to the standard of other direct recruits appointed along with them.

13. No departmental candidate (under age concession) has been recommended by the Commission.


14. UPSC may please be kept informed from time-to time about the position of appointment of these candidates. Copies of offers of appointment as and when issued to them may please be endorsed to the UPSC and the dates of joining of candidates may also be advised subsequently. Assessment reports on the work & performance of the candidates may be made available to the Commission every year for a period of 5 years subsequent to their appointment. Copies of the Gazette Notifications appointing the candidates to the service to which they have been allotted may also be sent to the UPSC in due course.

15. **In case the candidates do not accept offer of appointments, their dossiers may please be returned to UPSC directly under intimation to this Office.** Replacements against such candidates will not be provided. A vacancy against which a candidate has been allotted is deemed to be filled up for all purposes. It may please be noted that UPSC has time to time reiterated that Reserve List is not a waiting list to cater to vacancies arising out of other reasons such as candidates not turning up to join, being found medically unfit, left out on account of medical fitness for limited services, resignation or any other reasons.

16. Name (exact spelling of name) of the allotted candidate may be verified from the dossiers of the candidate being forwarded and their Marks obtained may please be verified from the UPSC Mark list uploaded on Indian Railways website at link: https://indianrailways.gov.in/railwayboard/view_section.jsp?lang=0&id=0,1,304,366,530


