Subject: Declaration of Final Result of Junior Engineer (Civil, Mechanical, Electrical and Quantity Surveying & Contracts) Examination, 2022.

Result of Paper-I of Junior Engineer (Civil, Mechanical, Electrical and Quantity Surveying & Contracts) Examination, 2022 was declared on 18.01.2023. Thereafter, Paper-II (Descriptive) of the Examination was conducted on 26.02.2023.

- 2. As per para 17 of the Notice of the Examination, Document Verification (DV) would be done by the Indenting/User Departments. Accordingly, as per Notice No. HQ-PPII010/1/2022-PP_II-Part (3) [Comp-3723] dated 28.04.2023 of the Commission, Option-cum-preference has been taken online from the candidates [between 04.05.2023 to 06.05.2023], who had appeared in Paper II of the Examination.
- 3. As per provisions of the Notice of Examination, allocation of Posts and Departments to the provisionally shortlisted candidates has been made on the basis of the performance of candidates in Paper-I & Paper-II and the preference of Posts/Departments submitted by them online. Subject to their qualifying in the Document Verification to be conducted by the respective User Departments, a total of 2798 candidates have been provisionally shortlisted.
